**Order of the Minister of State for Labour and Employment and Minister of Labour dated 26 October 2000**

Building Act  
(R.S.Q., c. B-1.1; 1998, c. 46)

Temporary delegation agreement between the Régie du bâtiment du Québec and Ville de Montréal

THE MINISTER OF STATE FOR LABOUR AND EMPLOYMENT AND MINISTER OF LABOUR,

CONSIDERING the first paragraph of section 132 of the Building Act (R.S.Q., c. B-1.1; 1998, c. 46), which provides that the Régie du bâtiment du Québec may enter into a written agreement with a local municipality to delegate to it, within its territory and to the extent specified, its powers and duties pursuant to sections 14 to 19, 21, 22, 24 to 27, 32 to 37.2 and 37.4 to 39 of that Act, with a view to ensuring the quality of construction work and public safety;

CONSIDERING a temporary delegation agreement expiring on 5 June 2001 that was entered into on 25 October 2000 between the Régie du bâtiment du Québec and Ville de Montréal, in accordance with section 132 of that Act;

CONSIDERING section 136 of that Act, which provides that such an agreement requires approval by the Minister of State for Labour and Employment and Minister of Labour and comes into force on the tenth day following publication in *the Gazette officielle du Québec* of a notice to that effect or on any later date fixed therein;

CONSIDERING that it is expedient to approve the agreement and it is expedient that it come into force 10 days following the publication of this Minister's Order in the *Gazette officielle du Québec*;

ORDERS that:

(1) the temporary delegation agreement, entered into on 25 October 2000 between the Régie du bâtiment du Québec and Ville de Montréal and expiring on 5 June 2001, be approved;

(2) this Minister's Order be published in the *Gazette officielle du Québec*;

(3) the Agreement come into force on 7 November 2000.
