Mount Royal historic and natural district

Recommendation of the Minister of State for Culture and Communications and Minister of Culture and Communications respecting the Mount Royal historic and natural district

Please take notice of the recommendation of the Minister of State for Culture and Communications and Minister of Culture and Communications concerning the declaration of Mount Royal as a historic and natural district.

Interested persons may, during the 30-day period following this publication, make representations to the Commission des biens culturels du Québec, at its head office at 225, Grande Allée Est, bloc A, rez-de-chaussée, Québec (Québec) G1R 5G5.

At the expiry of at least thirty days from this publication, the recommendation will be submitted to the Government and if an order to that effect is made, the order will take effect on the date of publication of this notice in the *Gazette officielle du Québec*.

Recommendation for the declaration of Mount Royal as a historic and natural district

THE MINISTER OF STATE FOR CULTURE AND COMMUNICATIONS AND MINISTER OF CULTURE AND COMMUNICATIONS SUBMITS :

THAT Mount Royal is a major visual landmark that is a focal point of identity for travellers and for island and off-island residents who have taken an interest in its preservation since 1863; the Act that created Mount Royal Park one hundred and twenty-five years ago constitutes Québec's first initiative to protect a natural landscape;

THAT Mount Royal, with its wide variety of plant and animal species, is also a refuge for city dwellers, affording them contact with nature;

THAT Mount Royal encompasses the most beautiful cemeteries in Québec where a number of noted public figures who were part of Québec's history are buried;

THAT monuments and historic sites forming an important part of Québec's heritage are situated on Mount Royal and in the surrounding area;

THAT the Commission des biens culturels (the "Commission") held public consultations from 21 to 24 May 2002 concerning Mount Royal, on the values that should be preserved, and on its boundaries and management structure;

THAT those consultations highlighted the cultural heritage value of Mount Royal, mainly historical, architectural and landscape, as well as its natural heritage value, in particular because of its ecology and the scenic views it offers looking from and towards the mountain;

THAT the Commission recommended that Mount Royal be given legal protection by the Government of Québec on the grounds of its heritage value as a territory comprising green spaces and built spaces with recognized natural and cultural qualities, deserving protection because it is a unique non-renewable resource and constitutes a site of symbolic significance for Québec;

THAT, under section 45 of the Cultural Property Act (R.S.Q., c. B-4), the Government may, on the recommendation of the Minister of Culture and Communications, who shall obtain the advice of the Commission, declare a territory to be a historic district because of the concentration of monuments or historic sites found there;

THAT, under that section, the Government may also, in the same manner, declare a territory to be a natural district because of the aesthetic, legendary or scenic interest of its natural setting;

THAT the Minister of State for Culture and Communications and Minister of Culture and Communications, in accordance with the Cultural Property Act, will obtain the advice of the Commission des biens culturels;

THEREFORE, the Minister of State for Culture and Communications and Minister of Culture and Communications recommends :

THAT the territory of Mount Royal, as delimited in the attached Schedule, be declared a historic and natural district;

THAT the historic and natural district be designated under the name of Mount Royal Historic and Natural District.

SCHEDULE

RECOMMENDATION OF THE MINISTER OF STATE FOR CULTURE AND COMMUNICATIONS FOR THE DECLARATION OF MOUNT ROYAL AS A HISTORIC AND NATURAL DISTRICT LOCATED IN MONTRÉAL

Boundaries of Mount Royal Historic and Natural District

A territory located in the city of Montréal the perimeter of which is described as follows:

1. starting from the meeting point located in the middle of the public right-of-way of Avenue Vincent-D'Indy with that of Boulevard Mont-Royal;

2. thence, easterly, southeasterly and again easterly, following the middle of the public right-of-way of Boulevard Mont-Royal to the meeting point located in the middle of the public right-of-way of Boulevard Mont-Royal with that of Avenue Roskilde;

3. thence, northeasterly, following the middle of the public right-of-way of Avenue Roskilde to the meeting point located in the middle of the public right-of-way of Avenue Roskilde with that of Avenue McCulloch;

4. thence, southeasterly, following the middle of the public right-of-way of Avenue McCulloch to the meeting point located in the middle of the public right-of-way of Avenue McCulloch with that of Boulevard Mont-Royal;

5. thence, northeasterly and easterly, following the middle of the public right-of-way of Boulevard Mont-Royal to the meeting point located in the middle of the public right-of-way of Boulevard Mont-Royal with that of Avenue du Mont-Royal;

6. thence, northwesterly, following the middle of the public right-of-way of Chemin de la Côte-Sainte-Catherine to the meeting point located in the middle of the public right-of-way of Chemin de la Côte-Sainte-Catherine with that of the lane located northwest of Avenue du Mont-Royal (Lot 2 135 867);

7. thence, northeasterly, following the middle of the right-of-way of the lane located northwest of Avenue du Mont-Royal to the meeting point located in the middle of the public right-of-way of the lane with that of Rue Hutchison;

8. thence, northwesterly, following the middle of the right-of-way of Rue Hutchison to the meeting point located in the middle of the public right-of-way of Rue Hutchison with the extension of the southeastern limit of Lot 1 868 911;

9. thence, northeasterly, following the southeastern limit of Lot 1 868 911 to the meeting point of the southeastern limit of Lot 1 868 911 with the southwestern limit of Lot 1 868 916;

10. thence, southeasterly, following the southwestern limit of Lot 1 868 916 to the meeting point of the southwestern limit of Lot 1 868 916 with the southeastern limit of Lot 1 868 916;

11. thence, northeasterly, following the southeastern limit of Lot 1 868 916 to the meeting point located in the middle of the public right-of-way of Avenue du Parc and the extension of the southeastern limit of Lot 1 868 916;

12. thence, northwesterly, following the middle of the right-of-way of Avenue du Parc to the meeting point located in the middle of the public right-of-way of Avenue du Parc with that of the lane located north of Avenue du Mont-Royal (Lot 2 135 853);

13. thence, northeasterly, following the middle of the public right-of-way of the lanes located northwest of Avenue du Mont-Royal (lots 2 135 853, 2 135 847 and 2 135 843) to the meeting point located in the middle of the public right-of-way of the lane designated by Lot 2 135 843 with the extension of the southwestern limit of Lot 1 867 633;

14. thence, southeasterly, following the southwestern limit of Lot 1 867 633 to the meeting point located in the middle of the public right-of-way of Avenue du Mont-Royal with the extension of the southwestern limit of Lot 1 867 633;

15. thence, northeasterly, following the middle of the public right-of-way of Avenue du Mont-Royal to the meeting point located in the middle of the public right-of-way of Avenue du Mont-Royal with the extension of the southwestern limit of Lot 1 353 086;

16. thence, southeasterly, following the southwestern limit of Lot 1 353 086 to the meeting point of the southwestern limit of Lot 1 353 086 with the southeastern limit of Lot 1 353 086;

17. thence, northeasterly, following the southeastern limit of Lot 1 353 086 to the meeting point located in the middle of the public right-of-way of Rue Saint-Urbain with the extension of the southeastern limit of Lot 1 353 086;

18. thence, southeasterly, following the middle of the right-of-way of Rue Saint-Urbain to the meeting point located in the middle of the public right-of-way of Rue Saint-Urbain with the extension of the northwestern limit of Lot 1 353 089;

19. thence, southwesterly, following the northwestern limit of Lot 1 353 089 to the meeting point of the northwestern limit of Lot 1 353 089 with the southwestern limit of Lot 1 353 089;

20. thence, southeasterly, following a broken line being the southwestern limit of lots 1 353 089, 1 353 090, 1 353 093, 1 353 095, and 1 353 097 to the meeting point of the southwestern limit of Lot 1 353 097 with the southeastern limit of Lot 1 353 097;

21. thence, northeasterly, following the southeastern limit of Lot 1 353 097 to the meeting point located in the middle of the public right-of-way of Rue Saint-Urbain with the extension of the southeastern limit of Lot 1 353 097;

22. thence, southeasterly, following the middle of the public right-of-way of Rue Saint-Urbain to the meeting point located in the middle of the public right-of-way of Rue Saint-Urbain with the extension of the southeastern limit of Lot 1 353 098;

23. thence, southwesterly, following the southeastern limit of Lot 1 353 098 to the meeting point of the southeastern limit of Lot 1 353 098 with the southwestern limit of Lot 1 353 099;

24. thence, southeasterly, following the southwestern limit of Lot 1 353 099 to the meeting point located in the middle of the public right-of-way of Rue Vallières with the extension of the southwestern limit of Lot 1 353 099;

25. thence, northeasterly, following the middle of the public right-of-way of Rue Vallières to the meeting point located in the middle of the public right-of-way of Rue Vallières with the extension of the northeastern limit of Lot 1 353 102;

26. thence, southeasterly, following a broken line being the northeastern limit of lots 1 353 102, 1 353 103, 1 353 252, 1 353 104, 1 353 108, 1 353 261, 1 513 179, 1 353 113, 1 355 070, 1 353 116, 1 353 118, 1 353 120, 1 353 122, 1 353 123, 1 353 126, 1 355 069, 1 353 129, 1 353 131, 1 353 133, 1 353 139, and 1 553 470 to the meeting point located in the middle of the public right-of-way of Rue Rachel with the extension of the northeastern limit of Lot 1 553 470;

27. thence, northeasterly, following the public right-of-way of Rue Rachel to the meeting point located in the middle of the public right-of-way of Rue Rachel with that of Rue Saint-Urbain;

28. thence, southeasterly, following the public right-of-way of Rue Saint-Urbain to the meeting point located in the middle of the public right-of-way of Rue Saint-Urbain with the extension of the southeastern limit of Lot 1 353 140;

29. thence, southwesterly, following the southeastern limit of Lot 1 353 140 to the meeting point of the southeastern limit of Lot 1 353 140 with the northeastern limit of Lot 1 353 141;

30. thence, southeasterly, following a broken line being the northeastern limit of lots 1 353 141 and 1 353 142 and the extension of that limit in the lanes designated by lots 1 513 195 and 1 513 182 to the meeting with the northwestern limit of Lot 1 353 152 to the meeting with the northwestern limit of Lot 1 353 152, then following the northeastern limit of lots 1 353 152, 1 353 155, 1 353 156, 1 353 157, 1 353 158, 1 353 159, and 1 353 161, to the meeting point of the northeastern limit of Lot 1 353 161 with the northwestern limit of Lot 1 353 162;

38. thence, southeasterly, following the middle of the public right-of-way of Rue Sewell to the meeting point located in the middle of the public right-of-way of Rue Sewell with the extension of the southeastern limit of Lot 2 257 501;

39. thence, southwesterly, following the southeastern limit of Lot 2 257 501 to the meeting point of the southeastern limit of Lot 2 257 501 with the northeastern limit of Lot 2 004 627;

40. thence, southeasterly, following a broken line being the northeastern limit of Lot 2 004 627, the centre line of a lane designated by Lot 2 004 614 and again the northeastern limit of lots 2 004 638, 2 004 312, 2 004 311, 2 004 310, 2 004 309, 2 004 308, 2 004 306, 2 004 305, 2 004 307, and 2 004 304 to the meeting point located in the middle of the public right-of-way of Avenue des Pins Ouest with the extension of the northeastern limit of Lot 2 004 304;

41. thence, northeasterly, following the middle of the public right-of-way of Avenue des Pins Ouest to the meeting point located in the middle of the public right-of-way of Avenue des Pins Ouest with the extension of the southwestern limit of Lot 2 003 790;

42. thence, southeasterly, following the southwestern limit of Lot 2 003 790 to the meeting point located in the middle of the public right-of-way of Rue Guilbault with the extension of the southwestern limit of Lot 2 003 790;

43. thence, southwesterly, following the middle of the public right-of-way of Rue Guilbault to the meeting point located in the middle of the public right-of-way of Rue Guilbault with that of Rue Saint-Urbain;

44. thence, southeasterly, following the middle of the public right-of-way of Rue Saint-Urbain to the meeting point located in the middle of the public right-of-way of Rue Saint-Urbain with the extension of the southeastern limit of Lot 2 160 454;

45. thence, southwesterly, following the southeastern limit of Lot 2 160 454 to the meeting point located in the middle of the public right-of-way of Rue Basset with the extension of the southeastern limit of Lot 2 160 454;

46. thence, northwesterly, following the middle of the public right-of-way of Rue Basset to the meeting point located in the middle of the public right-of-way of Rue Basset with that of the lane designated by Lot 2 162 394;

47. thence, southwesterly, following the middle of the public right-of-way of the lane designated by Lot 2 162 394 to the meeting point located in the middle of the public right-of-way of the lane designated by Lot 2 162 394 with that of Rue Sainte-Famille;

48. thence, northwesterly, following the middle of the public right-of-way of Rue Sainte-Famille to the meeting point located in the middle of the public right-of-way of Rue Sainte-Famille with that of the lane designated by Lot 2 162 367;

49. thence, southwesterly, following a broken line being the middle of the lane designated by Lot 2 162 367 and then the southeastern limit of lots 2 160 331 and 2 338 416 to the meeting point located in the middle of the public right-of-way of Rue Jeanne-Mance and of the extension of the southeastern limit of Lot 2 338 416;

50. thence, southeasterly, following the middle of the public right-of-way of Rue Jeanne-Mance to the meeting point located in the middle of the public right-of-way of Rue Jeanne-Mance with that of Rue Léo-Pariseau;

51. thence, southwesterly, following the middle of the public right-of-way of Rue Léo-Pariseau to the meeting point located in the middle of the public right-of-way of Rue Léo-Pariseau with that of Avenue du Parc;

52. thence, southeasterly, following the middle of the public right-of-way of Avenue du Parc to the meeting point located in the middle of the public right-of-way of Avenue du Parc with the extension of the southeastern limit of Lot 1 339 674;

53. thence, southwesterly, following a broken line being the southeastern limit of lots 1 339 674, 1 514 703, 1 514 711, and 1 339 441, crossing Rue Hutchison to the meeting point of the southeastern limit of Lot 1 339 441 with the southwestern limit of Lot 1 339 441;

54. thence, northwesterly, following the southwestern limit of Lot 1 339 441 to the meeting point of the southwestern limit of Lot 1 339 441 with the northwestern limit of Lot 1 339 439;

55. thence, southwesterly, following a broken line being the northwestern limit of Lot 1 339 439, crossing Rue Durocher, and then the southeastern limit of lots 1 339 371 and 1 339 367, crossing Rue Aylmer, and then the middle of the public right-of-way of the lane designated by Lot 1 341 267 to the meeting point of the public right-of-way of the lane designated by Lot 1 341 267 and that of the lane designated by Lot 1 341 266;

56. thence, southeasterly, following a broken line being the middle of the public right-of-way of the lane designated by Lot 1 341 266, crossing Rue Prince-Arthur, and then the northeastern limit of Lot 1 339 302, the middle of the lane designated by Lot 1 341 271 and the southwestern limit of Lot 1 339 681 to the meeting point located in the middle of the public right-of-way of Rue Milton and the extension of the southwestern limit of Lot 1 339 681;

57. thence, northeasterly, following the middle of the public right-of-way of Rue Milton to the meeting point located in the middle of the public right-of-way of Rue Milton with the extension of the southwestern limit of Lot 1 339 712;

77. thence, northeasterly, along the southeastern limit of Lot 282-430 of the said cadastre to the meeting point of the southeastern limit of Lot 282-430 with the northeastern limit of Lot 282-430;

78. thence, northwesterly along the northeastern limit of lots 282-430, 282-431 and 282-419 to the meeting point of the northeastern limit of Lot 282-419 with the southeastern limit of Lot 2 174 945 of the cadastre of Québec;

79. thence, southwesterly, following the southeastern limit of Lot 2 174 945 of the cadastre of Québec to the meeting point of the southeastern limit of Lot 2 174 945 with the southwestern limit of Lot 2 174 945;

80. thence, northwesterly, following a broken line being the southwestern limits of lots 2 174 945, 2 174 944 and 2 174 942 to the meeting point of the southwestern limit of Lot 2 174 942 with the southeastern limit of part of Lot 160 of the cadastre of Village de Côte-des-Neiges;

81. thence, southwesterly and southerly, following the municipal boundary between Westmount Borough and Côte-des-Neiges/Notre-Dame-de-Grâce Borough to the meeting point of the municipal boundary of Westmount Borough with the southern limit of part of Lot 156-56-1;

82. thence, westerly, following the southern limit of Lot 156-55-1 and part of Lot 156-56-1 to the meeting point located in the middle of the public right-of-way of Croissant Cedar with the extension of the southern limit of Lot 156-55-1;

83. thence, northerly, following the middle of the public right-of-way of Croissant Cedar to the meeting point located in the middle of the public right-of-way of Croissant Cedar with the extension of the southern limit of Lot 156-92 of the cadastre of Village de Côte-des-Neiges;

84. thence, westerly, following the southern limit of Lot 156-92 to the meeting point of the southern limit of Lot 156-92 with the western limit of Lot 156-92;

85. thence, northerly, following a broken line being the western limit of lots 156-92 to 156-95 to the meeting point of the western limit of Lot 156-95 with the southern limit of Lot 156-75;

86. thence, northwesterly, following the southwestern limit of Lot 156-75 to the meeting point located in the middle of the public right-of-way of Avenue Miller with the extension of the southwestern limit of Lot 156-75;

87. thence, northeasterly, following the middle of the public right-of-way of Avenue Miller to the meeting point located in the middle of the public right-of-way of Avenue Miller with the extension of the limit between the northeastern and southwestern parts of Lot 156-26;

88. thence, northwesterly, following the limit between the northeastern and southwestern parts of Lot 156-26 to the meeting point of the limit between the northeastern and southwestern parts of Lot 156-26 with the southeastern limit of Lot 155-74;

89. thence, southwesterly, following the southeastern limit of Lot 155-74 to the meeting point of the southeastern limit of Lot 155-74 with the southwestern limit of Lot 155-74;
