Cultural Property Act (R.S.Q., c. B-4)

Declaration of Mount Royal as a historic and natural district

WHEREAS Mount Royal is a major visual landmark that is a focal point of identity and a site of symbolic significance for Québec;

WHEREAS Mount Royal has historically been an area affording contact with nature and spaces for relaxation and recreation;

WHEREAS Mount Royal Park is one of the finest achievements of landscape architect Frederick Law Olmsted;

WHEREAS Mount Royal, as a place of settlement and burial grounds for Amerindians and early Québecers of European descent, is of archaeological significance;

WHEREAS Mount Royal is of particular interest for its sacred institutions and spaces, notably its cemeteries, that are constant reminders of Québec's history;

WHEREAS Mount Royal is a place of monuments and historic sites forming an important part of Québec's heritage;

WHEREAS Mount Royal has a concentration of buildings that belong to well-respected higher learning and health institutions and that have historical significance as much for their use as for their architecture;

WHEREAS Mount Royal is intimately linked to the historical development of the city of Montréal and to the history of Québec;

WHEREAS the Commission des biens culturels du Québec (the "Commission") held public consultations from 21 to 24 May 2002 on measures to preserve Mount Royal, the boundaries of the sector to be protected and the management structure to implement; WHEREAS those consultations highlighted the cultural, historical, architectural and landscape heritage significance of Mount Royal and the natural heritage significance our society recognizes;

WHEREAS the Commission recommended that Mount Royal be given legal protection by the Government of Québec because of that heritage significance, declaring that "Mount Royal is a territory comprising green spaces and built spaces with recognized natural and cultural qualities, deserving protection because it is a unique non-renewable resource and constitutes a site of symbolic significance for Québec";

WHEREAS, under section 45 of the Cultural Property Act (R.S.Q., c. B-4), the Government may, on the recommendation of the Minister of Culture and Communications, who shall obtain the advice of the Commission, declare a territory to be a historic district because of the concentration of monuments or historic sites found there;

WHEREAS, under that section, the Government may also declare a territory to be a natural district because of the aesthetic, legendary or scenic interest of its natural setting;

WHEREAS the recommendation of the Minister of Culture and Communications concerning Mount Royal as a historic and natural district was published in the *Gazette officielle du Québec* of 18 February 2003, in accordance with section 46 of the Cultural Property Act;

WHEREAS the Minister of Culture and Communications, in accordance with the Cultural Property Act, obtained the advice of the Commission des biens culturels, which sent to the Minister a first notice dated 2 July 2002 pertaining to the safeguard measures necessary to preserve Mount Royal, and a second notice dated 3 April 2003 setting forth more precisely the reasons for the Order in Council, the perimeter retained and the management structure to implement;

IT IS ORDERED, therefore, on the recommendation of the Minister of Culture and Communications:

THAT the territory of Mount Royal, as delimited in the Schedule attached to this Order in Council, be declared a historic and natural district; THAT the historic and natural district be designated under the name of Mount Royal Historic and Natural District.

SCHEDULE

BOUNDARIES OF MOUNT ROYAL HISTORIC AND NATURAL DISTRICT

A territory situated in the city of Montréal the perimeter of which is described as follows:

1. commencing at the meeting point of the centre line of the public right-of-way of avenue Vincent-D'Indy with that of boulevard Mont-Royal;

2. thence, easterly, southeasterly, again easterly, again southeasterly, northeasterly, again easterly and again northeasterly, along the centre line of the public rightof-way of boulevard Mont-Royal to the meeting point of the centre line of the public right-of-way of boulevard Mont-Royal with that of avenue du Mont-Royal;

6. thence, northeasterly, along the southeastern limit of lot 1 868 911 to the meeting point of the southeastern limit of lot 1 868 911 with the southwestern limit of lot 1 868 916;

7. thence, southeasterly, along the southwestern limit of lot 1 868 916 to the meeting point of the southwestern limit of lot 1 868 916 with the southeastern limit of lot 1 868 916;

8. thence, northeasterly, along the southeastern limit of lot 1 868 916 to the meeting point of the centre line of the public right-of-way of avenue du Parc and the extension of the southeastern limit of lot 1 868 916; 9. thence, northwesterly, along the centre line of the right-of-way of avenue du Parc to the meeting point of the centre line of the public right-of-way of avenue du Parc with that of the lane situated north of avenue du Mont-Royal (lot 2 135 853);

10. thence, northeasterly, along the centre line of the public right-of-way of the lanes situated northwest of avenue du Mont-Royal (lots 2 135 853, 2 135 847 and 2 135 843) to the meeting point of the centre line of the public right-of-way of the lane designated by lot 2 135 843 with the extension of the southwestern limit of lot 1 867 633;

11. thence, southeasterly, along the southwestern limit of lot 1 867 633 to the meeting point of the centre line of the public right-of-way of avenue du Mont-Royal with the extension of the southwestern limit of lot 1 867 633;

12. thence, northeasterly, along the centre line of the public right-of-way of avenue du Mont-Royal to the meeting point of the centre line of the public right-of-way of avenue du Mont-Royal with the extension of the southwestern limit of lot 3 292 349 (PC-16242);

13. thence, southeasterly, along the southwestern limit of lot 3 292 349 (PC-16242) to the meeting point of the southwestern limit of lot 3 292 349 (PC-16242) with the southeastern limit of lot 3 292 349 (PC-16242);

14. thence, northeasterly, along the southeastern limit of lot 3 292 349 (PC-16242) to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the southeastern limit of lot 3 292 349 (PC-16242);

15. thence, southeasterly, along the centre line of the right-of-way of rue Saint-Urbain to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the northwestern limit of lot 1 353 089;

16. thence, southwesterly, along the northwestern limit of lot 1 353 089 to the meeting point of the northwestern limit of lot 1 353 089 with the southwestern limit of lot 1 353 089;

17. thence, southeasterly, along a broken line being the southwestern limit of lots 1 353 089, 1 353 090, 1 353 093, 1 353 095 and 1 353 097 to the meeting point of the southwestern limit of lot 1 353 097 with the southeastern limit of lot 1 353 097;

18. thence, northeasterly, along the southeastern limit of lot 1 353 097 to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the southeastern limit of lot 1 353 097; 19. thence, southeasterly, along the centre line of the public right-of-way of rue Saint-Urbain to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the southeastern limit of lot 1 353 098;

20. thence, southwesterly, along the southeastern limit of lot 1 353 098 to the meeting point of the southeastern limit of lot 1 353 098 with the southwestern limit of lot 1 353 099;

21. thence, southeasterly, along the southwestern limit of lot 1 353 099 to the meeting point of the centre line of the public right-of-way of rue Vallières with the extension of the southwestern limit of lot 1 353 099;

22. thence, northeasterly, along the centre line of the public right-of-way of rue Vallières to the meeting point of the centre line of the public right-of-way of rue Vallières with the extension of the northeastern limit of lot 1 353 102;

24. thence, northeasterly, along the public right-ofway of rue Rachel to the meeting point of the centre line of the public right-of-way of rue Rachel with that of rue Saint-Urbain;

25. thence, southeasterly, along the public right-ofway of rue Saint-Urbain to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the southeastern limit of lot 1 353 140;

26. thence, southwesterly, along the southeastern limit of lot 1 353 140 to the meeting point of the southeastern limit of lot 1 353 140 with the northeastern limit of lot 1 353 141;

27. thence, southeasterly, along a broken line being the northeastern limit of lots 1 353 141 and 1 353 142 and the extension of that limit in the lanes designated by lots 1 513 195 and 1 513 182 to the meeting with the northwestern limit of lot 1 353 152, then along the northeastern limit of lots 1 353 152, 1 353 155, 1 353 156, 1 353 157, 1 353 158, 1 353 159 and 1 353 161 to the meeting point of the northeastern limit of lot 1 353 161 with the northwestern limit of lot 1 353 162; 28. thence, northeasterly, along the northwestern limit of lot 1 353 162 to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the northwestern limit of lot 1 353 162;

41. thence, southeasterly, along the centre line of the public right-of-way of rue Saint-Urbain to the meeting point of the centre line of the public right-of-way of rue Saint-Urbain with the extension of the southeastern limit of lot 2 160 454;

42. thence, southwesterly, along the southeastern limit of lot 2 160 454 to the meeting point of the centre line of the public right-of-way of rue Basset with the extension of the southeastern limit of lot 2 160 454;

43. thence, northwesterly, along the centre line of the public right-of-way of rue Basset to the meeting point of the centre line of the public right-of-way of rue Basset with that of the lane designated by lot 2 162 394;

44. thence, southwesterly, along the centre line of the public right-of-way of the lane designated by lot 2 162 394 to the meeting point of the centre line of the public right-of-way of the lane designated by lot 2 162 394 with that of rue Sainte-Famille;

45. thence, northwesterly, along the centre line of the public right-of-way of rue Sainte-Famille to the meeting point of the centre line of the public right-of-way of rue Sainte-Famille with that of the lane designated by lot 2 162 367;

46. thence, southwesterly, along a broken line being the centre line of the lane designated by lot 2 162 367 and the southeastern limit of lots 2 160 331 and 2 338 416 to the meeting point of the centre line of the public rightof-way of rue Jeanne-Mance and of the extension of the southeastern limit of lot 2 338 416; 47. thence, southeasterly, along the centre line of the public right-of-way of rue Jeanne-Mance to the meeting point of the centre line of the public right-of-way of rue Jeanne-Mance with that of rue Léo-Pariseau;

48. thence, southwesterly, along the centre line of the public right-of-way of rue Léo-Pariseau to the meeting point of the centre line of the public right-of-way of rue Léo-Pariseau with that of avenue du Parc;

49. thence, southeasterly, along the centre line of the public right-of-way of avenue du Parc to the meeting point of the centre line of the public right-of-way of avenue du Parc with the extension of the southeastern limit of lot 1 339 674;

50. thence, southwesterly, along a broken line being the southeastern limit of lots 1 339 674, 1 514 703, 1 514 711 and 1 339 441 across rue Hutchison to the meeting point of the southeastern limit of lot 1 339 441 with the southwestern limit of lot 1 339 441;

51. thence, northwesterly, along the southwestern limit of lot 1 339 441 to the meeting point of the southwestern limit of lot 1 339 441 with the northwestern limit of lot 1 339 439;

52. thence, southwesterly, along a broken line being the northwestern limit of lot 1 339 439, across rue Durocher, the southeastern limit of lots 1 339 371 and 1 339 367, across rue Aylmer, and the centre line of the public right-of-way of the lane designated by lot 1 341 267 to the meeting point of the public right-of-way of the lane designated by lot 1 341 267 and that of the lane designated by lot 1 341 266;

Professional Code (R.S.Q., c. C-26)

Advocates — Professional training

By-law respecting the professional training of advocates

WHEREAS, under paragraph i of section 94 of the Professional Code (R.S.Q., c. C-26), the Bureau of a professional order may, by regulation, determine the terms and conditions for issuing permits, in particular the obligation to serve the periods of professional training and to pass the professional examinations it determines; the regulation may also fix standards of equivalence applicable to the terms and conditions determined therein;

WHEREAS, under paragraph b of subsection 2 of section 15 of the Act respecting the Barreau du Québec (R.S.Q., c. B-1), the General Council of the Barreau du Québec, by by-law, may ensure professional training, define its modalities, give the appropriate instruction and, for such purposes, establish and administer a professional training school;

WHEREAS, under section 44 of the Act respecting the Barreau du Québec, the General Council may, to apply the by-laws provided for in paragraph i of section 94 of the Professional Code, delegate its powers to committees, whose composition and functions it shall determine by resolution;

WHEREAS the General Council of the Barreau du Québec made the By-law respecting the professional training of advocates;

WHEREAS, under section 95 of the Professional Code, every regulation made by the Bureau of a professional order under the Code or an Act constituting a professional order shall be transmitted to the Office des professions du Québec for examination and submitted, with the recommendation of the Office, to the Government which may approve it with or without amendment;

WHEREAS, in accordance with the Regulations Act (R.S.Q., c. R-18.1), a draft By-law respecting the professional training of advocates was published in Part 2 of the *Gazette officielle du Québec* of 8 December 2004, with a notice that it could be approved by the Government on the expiry of 45 days following that publication;

WHEREAS, following that publication, comments were made to the Chair of the Offfice;

WHEREAS, in accordance with section 95 of the Professional Code, the Office des professions du Québec examined the By-law and made its recommendation;

WHEREAS it is expedient to approve the By-law with amendments;

IT IS ORDERED, therefore, on the recommendation of the Minister responsible for the administration of legislation respecting the professions:

THAT the By-law respecting the professional training of advocates, attached to this Order in Council, be approved, with amendments.

By-law respecting the professional training of advocates

An Act respecting the Barreau du Québec (R.S.Q., c. B-1, s. 15, ss. 2, par. *b* and s. 44)

Professional Code (R.S.Q., c. C-26, s. 94, par. *i*)

DIVISION I THE BAR SCHOOL

1. The Barreau du Québec hereby establishes the Bar School, which shall be responsible for all professional training activities.

The Professional Training Committee of the Barreau shall be responsible to the Executive Committee of the Barreau for the administration of the Bar School.

2. The Bar School shall have its head office in Montréal.

DIVISION II

PROFESSIONAL TRAINING PROGRAM

3. The professional training program is comprised of:

(1) the development of the skills required for the practice of law; and

(2) an articling period.

4. The Professional Training Committee may, subject to the available resources and the teaching methods used, determine the professional training centre and session in which an applicant who has been admitted is registered.

DIVISION III

CONDITIONS FOR ADMISSION

5. To be admitted to the Bar School, an applicant shall, within the time prescribed by the Professional Training Committee :

(1) file an application for admission in the form prescribed by the Committee and attach thereto all the required documents; (2) hold a diploma recognized by the Government, under the first paragraph of section 184 of the Professional Code (R.S.Q., c. C-26), as allowing one to obtain the permit issued by the Barreau, or hold a diploma judged equivalent by the General Council of the Barreau in accordance with subparagraph g of the first paragraph of section 86 of the Professional Code;

(3) have been declared eligible by the Examining Committee of the Barreau; and

(4) pay the admission fee.

6. The applicant shall pay the fees determined by the Professional Training Committee on the dates fixed by it.

7. Where the applicant fails to meet any of the conditions provided for in sections 5 and 6, the Committee may take any of the following measures:

(1) allow the applicant to remedy the default within the time prescribed by the Committee;

(2) refuse to admit the applicant;

(3) refuse to issue a student card or revoke it;

(4) withhold course materials and the results of training activities and evaluations;

(5) refuse to issue an articled student card or revoke it; and

(6) cancel the admission if the applicant fails to pay the admission fee.

8. A candidate may file an application for admission only for the following school year.

He may withdraw from the Bar School at any time upon written notice.

DIVISION IV REGISTRATION PROCEDURE

9. A candidate who has been admitted shall register for professional training or for the preparatory courses in the school year following his admission.

10. A candidate who has been admitted shall, before registering for professional training or for the preparatory courses, undergo a diagnostic evaluation at the moment prescribed by the Professional Training Committee.

11. Any candidate who has been admitted may register for preparatory courses before registering for professional training. He may be requested to do so by the Committee after a review of his file following his diagnostic evaluation.

12. Upon completion of the preparatory courses, the candidate shall be registered for professional training as of the following session.

However, the Committee may, in accordance with the terms and conditions set by it and subject to the available resources and the teaching methods used, authorize a candidate to modify his choice and register for professional training or for the preparatory courses during a session.

DIVISION V EVALUATION

13. The Professional Training Committee may, for the purposes of eligibility for an evaluation, after having so informed the candidate, require the candidate to participate in specific training activities, including the submission of papers.

14. The professional training comprises oral or written evaluations designed to assess the skills required for the practice of law. It also comprises a final evaluation.

15. A candidate must obtain an overall mark of 60% at the end of all the professional training evaluations.

In case of failure, he shall sit the supplemental final evaluation and obtain an overall mark of 60%, taking into account the results of all the evaluations, otherwise he shall no longer be admitted to the Bar School.

A candidate who does not obtain an overall mark of 60% following the supplemental final evaluation may re-apply. If he is re-admitted, he shall register for preparatory courses before registering for professional training.

16. A candidate who demonstrates to the Committee that he was unable to sit the final evaluation or the supplemental final evaluation because of illness, accident, pregnancy, the death of a member of his immediate family or an act of God shall be authorized to sit the next following final evaluation or supplemental final evaluation, as the case may be.

A candidate who does not sit that evaluation shall no longer be admitted to the Bar School.

17. Any candidate who assists another candidate, attempts to assist another candidate, commits fraud or breaches the rules of proper conduct during an evaluation or during a training activity may be expelled or may have his evaluation cancelled.

18. For an evaluation, every candidate shall be assessed by one or more persons.

19. A person who is a relative of a candidate or who may be in a situation of conflict of interests by reason of his participation in the preparation, holding or marking of a candidate's evaluation may not participate therein.

For purposes of this section, each of the following persons shall be considered to be a relative of a candidate:

(1) the legal or *de facto* spouse of the candidate; and

(2) the legal or *de facto* spouse of a family member of the candidate.

20. Every marker shall solemnly affirm when hired that he is not related to any candidate in the manner described in section 19 and that he will respect the confidentiality of the deliberations and evaluations.

DIVISION VI

ARTICLING PERIOD

21. A candidate who has successfully completed his professional training shall complete an articling period within 3 years following the date on which he becomes eligible therefor, otherwise he shall no longer be admitted to the Bar School.

Notwithstanding the foregoing, a candidate who demonstrates to the Committee that he was unable to complete his articling period within the prescribed time because of illness, accident or pregnancy, because he was pursuing post-graduate legal studies or because of an act of God shall have additional time equivalent to the period during which he was unable to complete his articling period, but not exceeding 2 years.

22. The articling period shall contribute adequately to preparing the candidate for the practice of law. To that effect, it shall allow the articled student to put into practice the skills acquired in the program. It may include compulsory participation in training activities determined by the Professional Training Committee.

23. The articling period shall last for 6 consecutive months and shall be completed on a full-time basis, as of the date fixed by the Committee.

An articled student who has to be absent for more than 10 working days during this period shall file an application to suspend his articling period pursuant to section 30.

24. The articling period may be completed outside Québec for a period not exceeding 3 months.

An articling period with a department or agency of the federal government or with a judicial or quasi-judicial tribunal having jurisdiction over litigation originating in Québec is deemed to have been completed entirely in Québec.

25. The articled student card attests to the candidate's status as an articled student. It shall be issued by the Committee at the request of the articling supervisor and shall be valid for 7 months.

An articled student may engage in the professional activities reserved for advocates under the close supervision and responsibility of his articling supervisor. He must comply with the laws and regulations applicable to the practice of the profession of advocate.

26. The articling supervisor shall be responsible for overseeing the articled student in the work place.

An advocate or member of the judiciary who submits a written application to the Committee and who has met the following conditions during the five years preceding the articling period and meets such conditions during the articling period may be an articling supervisor:

(1) he has been or is:

(a) entered on the Roll of the Ordre des avocats;

(b) a member of the judiciary;

(c) in the situation referred to in section 24, a member of the bar association of the place in which a portion of the articling period will be completed;

(2) he has not been the subject of disciplinary action by a disciplinary committee of a bar association, by a disciplinary tribunal or by a judicial council;

(3) he has not been required by a bar association to take a refresher training period or a refresher course under section 55 of the Professional Code or a similar provision; and

(4) he has not been the subject of a decision rendered under section 51, 52.1 or 55.1 of the Professional Code.

27. In particular, the articling supervisor shall:

(1) provide the articled student with a work place conducive to learning and developing skills;

(2) facilitate the integration of the articled student in the work place;

(3) inform the articled student about the functioning of the work place and the available resources;

(4) determine the articled student's tasks, specifying how the work is to be performed and the deadlines that are to be met;

(5) help the articled student organize his work and introduce to him the concept of office management;

(6) allow the articled student to gradually engage in professional activities reserved for advocates;

(7) promptly assess the tasks performed by the articled student;

(8) provide the Professional Training Committee with all the information required by it;

(9) contribute to evaluating the articled student's achievement of the objectives of the articling period; and

(10) file with the Professional Training Committee, at the moments indicated by it, a report on the evaluation of the articled student.

28. If an articling supervisor does not comply with the requirements of this Division, the Committee may revoke that person's authorization to act as an articling supervisor for such period of time and under such conditions as the Committee may determine.

29. The Committee may verify whether the articling period constitutes valid preparation for the practice of law. To that effect, it may require that the articling supervisor or the articled student supply information for the purpose of enabling the Committee to determine the validity of the articling period, or it may request such information from any person having contributed to the articling period.

If it is of the opinion that an articling period does not constitute valid preparation for the practice of law or does not comply with the requirements of this Division, the Committee make take the appropriate measures, including: (1) refusing to issue or cancelling an articled student card; or

(2) cancelling, suspending or extending the articling period in order to allow the articled student to validly complete it.

Before taking measures under the second paragraph, the Committee shall give the persons in question the opportunity to present their observations.

If the Committee decides that an articling period constitutes valid preparation for the practice of law, it shall issue an attestation to that effect.

30. The Committee may authorize a change of articling supervisor, a suspension of the articling period or the cancellation of a portion of the articling period upon receipt of a written request submitted by an articled student.

31. Where the articling supervisor refuses or is unable to file his report, the articled student may take the matter to the Committee, which shall take the appropriate action.

DIVISION VII

TRANSITIONAL AND FINAL PROVISIONS

32. As of the 2005-2006 professional training year, a candidate who is contemplated in section 21 or in the first paragraph of section 27 of the By-law respecting the professional training of advocates made by Order in Council 161-95 dated February 1, 1995 and who wants to register for the professional training program provided for in this By-law shall file an application for admission in accordance with section 5.

33. As of the 2005-2006 professional training year, a candidate who is contemplated in section 23, 25 or 26 or in the second paragraph of section 27 of the By-law respecting the professional training of advocates made by Order in Council 161-95 dated February 1, 1995 shall successfully sit for one more examination in the sector in question, to be held no later than August 10, 2005, otherwise he shall no longer be admitted to the Bar School.

The candidate referred to in the first paragraph may, before or after his examination, file a new application for admission in accordance with section 5.

34. As of the 2005-2006 professional training year, a candidate who has not completed the professional training program for which he was previously registered under the By-law respecting the professional training of

advocates made by Order in Council 161-95 dated February 1, 1995 shall file a new application for admission in accordance with section 5.

35. A candidate referred to in section 32, 33 or 34 shall register for preparatory courses before registering for professional training.

36. This By-law replaces the By-law respecting the professional training of advocates made by Order in Council 161-95 dated February 1, 1995.

However, sections 11, 18 to 22 and 27 of the by-law being replaced shall continue to apply until July 10, 2005 with respect to any candidate who began his professional training before April 7, 2005.

37. This By-law comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.
