#### O.C. 863-2006, 20 September 2006

An Act respecting the exercise of certain municipal powers in certain urban agglomerations (R.S.Q., c. E-20.001)

Amendment to Order in Council 1210-2005 dated 7 December 2005 respecting various taxation measures relating to the reorganization

WHEREAS the Act respecting the exercise of certain municipal powers in certain urban agglomerations (R.S.Q., c. E-20.001) was assented to on 17 December 2004;

WHEREAS the Act provides that the Government may make various orders to carry out the reorganization resulting from the consultation of citizens held in accordance with the Act respecting the consultation of citizens with respect to the territorial reorganization of certain municipalities (2003, c. 14);

WHEREAS section 122 of the Act respecting the exercise of certain municipal powers in certain urban agglomerations provides that the Government may make any order, in keeping with the objects of the Act, to further clarify the scope of a provision of the Act or to correct any omission;

WHEREAS, on 7 December 2005, the Government made Order in Council 1210-2005 respecting various taxation measures relating to the reorganization that allows the reconstituted municipalities, until 2010, to take advantage of certain taxation measures whose purpose is to reduce the amount of agglomeration tax accounts;

WHEREAS, by Order in Council 549-2006 dated 14 June 2006, the Government amended that Order in Council to postpone to 15 September 2006, for the fiscal year 2006, the deadline by which the reconstituted municipalities must express their wish to take advantage of the measures set out therein;

WHEREAS it is expedient, given the financial contingencies relating to the implementation of those measures, to further amend that Order in Council to postpone that date to 31 October 2006; IT IS ORDERED, therefore, on the recommendation of the Minister of Municipal Affairs and Regions:

THAT Order in Council 1210-2005 dated 7 December 2005 respecting various taxation measures relating to the reorganization, amended by Order in Council 10-2006 dated 17 January 2006 and Order in Council 549-2006 dated 14 June 2006, be further amended by replacing "15 September 2006" in the first paragraph of section 9.1 by "31 October 2006";

THAT this Order in Council come into force on the date of its publication in the *Gazette officielle du Québec*.
