Premium rates under the parental insurance plan — Amendments

Regulation to amend the Regulation respecting premium rates under the parental insurance plan

WHEREAS, under section 6 of the Act respecting parental insurance (R.S.Q., c. A-29.011), the Conseil de gestion de l'assurance parentale shall, by regulation, set premium rates applicable to an employee, to a person referred to in section 51 of the Act respecting parental insurance, to an employer and to a self-employed worker;

WHEREAS the Regulation respecting premium rates under the parental insurance plan has not been amended since it was made by Order in Council 985-2005 dated 19 October 2005;

WHEREAS the Conseil de gestion de l'assurance parentale has not made a regulation to amend the Regulation respecting premium rates under the parental insurance plan within a period the Government considers reasonable considering that the Regulation may not be published later than 15 September 2007 for it to come into force on 1 January 2008;

WHEREAS, under the last paragraph of section 88 of the Act respecting parental insurance, the Government may, if the Conseil de gestion fails to make a regulation within a period the Government considers reasonable, make the regulation;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), a draft of the Regulation to amend the Regulation respecting premium rates under the parental insurance plan was published in the *Gazette officielle du Québec* of 5 July 2007 with a notice that it could be made by the Government, with or without amendment, on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation without amendment;

IT IS ORDERED, therefore, on the recommendation of the Minister of Employment and Social Solidarity:

THAT the Regulation to amend the Regulation respecting premium rates under the parental insurance plan, attached to this Order in Council, be made.

Regulation to amend the Regulation respecting premium rates under the parental insurance plan *

An Act respecting parental insurance
(R.S.Q., c. A-29.011, ss. 6 and 88)

1. The Regulation respecting premium rates under the parental insurance plan is amended by replacing section 1 by the following:

“**1.** The premium rate applicable to an employee and to a person referred to in section 51 of the Act is 0.450%.

The premium rate applicable to a self-employed worker is 0.800%.

The premium rate applicable to an employer is 0.630%.”.

2. This Regulation comes into force on 1 January 2008.
