(1) Acts assented to, before their publication in the annual collection of statutes;

(3) regulations made by the Government, a minister or a group of ministers and of Government agencies and semipublic agencies described by the Charter of the French language (chapter C-11), which before coming into force must be approved by the Government, a minister or a group of ministers;

(4) decisions of the Conseil du trésor and ministers' orders whose publications in the *Gazette officielle du Québec* is required by law or by the Government;

(5) regulations and rules made by a Government agency which do no require approval by the Government, a minister or a group of ministers to come into force, but whose publication in the *Gazette officielle du Québec* is required by law;

(6) rules of practice made by judicial courts and quasijudicial tribunals;

(7) drafts of the texts mentioned in paragraph 3 whose publication in the *Gazette officielle du Québec* is required by law before their adoption or approval by the Government.

Draft Regulation

An Act respecting the conservation and development of wildlife (chapter C-61.1)

Fishing activities — Revocation

Notice is hereby given, in accordance with sections 10 and 11 of the Regulations Act (chapter R-18.1), that the draft Regulation to revoke the Regulation respecting fishing activities, appearing below, may be made by the Government on the expiry of 45 days following this publication.

The purpose of the draft Regulation is to revoke the Regulation respecting fishing activities, further to ail of its provisions being struck out or transferred to the Regulation respecting classes of fishing licences and their term (chapter C-61.1, r. 11).

The revocation arises from

— the striking out of the term related to the registration of the salmon caught and kept, provided for in section 3.1, since that requirement is already provided for in the Quebec Fishery Regulations (SOR/90-214); and

—the transfer to the Regulation respecting classes of fishing licences and their term, in accordance with the amendments made to the Act respecting the conservation and development of wildlife (chapter C-61.1) in 2009, of the terms specifying the requirements with which applicants for a fishing licence and holders of a licence to fish in the parts of Area 22 the plans of which appear in Schedules CXCVI and CXCVII of the Regulation respecting hunting (chapter C-61.1, r. 12), must comply, as well as the circumstances under which the services of an outfitter must be used to practice sport fishing.

The revocation of the Regulation has no negative impact on the resource and on the department's traditional clientele, since it does not in any way alter the regulations currently in force.
