If a Wednesday is a legal holiday, the Official Publisher is authorized to publish them on the preceding day or on the Thursday following such holiday.

#### List of school boards

— Candidates for the office of chair of the board who are entitled to the supplement of authorized election expenses for the general school election of 4 November 2018

List of school boards whose authorized candidates for the office of chair of the board are entitled to the supplement of authorized election expenses for the general school election of 4 November 2018

Under subparagraph 1 of the first paragraph of section 206.47 of the Act respecting school elections (CQLR, chapter E-2.3), an authorized candidate for the office of chair of the board may not exceed, during an election, an amount of election expenses of \$3,780 increased by \$0.30 per person entered on the list of electors of the school board, to which is added, where applicable, a supplement of

- (a) \$0.10 per person entered on the list, if the density of electors per square kilometre is greater than 1, but less than or equal to 10;
- (b) \$0.20 per person entered on the list, if the density of electors per square kilometre is greater than 0.45, but less than or equal to 1;
- (c) \$0.35 per person entered on the list, if the density of electors per square kilometre is less than or equal to 0.45.

The third paragraph of that section also provides that, not later than 31 December of the year preceding the year in which the general election is to be held, the Minister of Education, Recreation and Sports publishes the list of school boards whose authorized candidates for the office of the chair are entitled to the supplement of authorized election expenses. For the purpose of establishing that list, the Chief Electoral Officer transmits the data concerning the number of electors per school board to the Minister for the calculation of the density of electors.

Considering that the polling day for the next general school election was set for 4 November 2018;

The Minister of Education, Recreation and Sports establishes the following list of school boards whose authorized candidates for the office of chair are entitled, based on the data transmitted by the Chief Electoral Officer, to the supplement of authorized election expenses for the general school election of 4 November 2018:
