If a Wednesday is a legal holiday, the Official Publisher is authorized to publish them on the preceding day or on the Thursday following such holiday.

Natural Heritage Conservation Act (chapter C-61.01)

Montagne-Rouge Nature Reserve — Partial withdrawal of recognition

Notice is hereby given, pursuant to section 65 of the Natural Heritage Conservation Act (Chapter C-61.01–the "Act"), that the Minister of Sustainable Development, Environment and the Fight Against Climate Change has withdrawn two parts of lot 11B and one part of lot 12, range 1 in the Arundel township cadastre, Argenteuil Registry division, from the Montagne-Rouge Nature Reserve that had been recognized as such since May 12, 2004. Pursuant to section 63 of the Act, the decision was taken in consideration of non-compliance with the provisions of the Montagne-Rouge Nature Reserve agreement (the "Agreement") covering these parts of the nature reserve.

Decision 700-17-009449-124 of the Superior Court of the District of Terrebonne established a pedestrian and vehicular right of way through the nature reserve for the abutting enclave. Construction of said right of way and vehicular traffic being prohibited in the Agreement, withdrawal of the above-mentioned parts of the nature reserve is required to provide right of way access to the abutting enclave in compliance with the court decision.

The Montagne-Rouge Nature Reserve now consists of lots 10A and 11A of range 1, one part of lots 8 and 10B of range 1, and two parts of lots 11B and 12 of range 1, the whole in the Arundel township cadastre, Argenteuil Registry division. The Montagne-Rouge Nature Reserve now covers an area of 146 and 21 hundredths hectares (146.21 ha).

Withdrawal of recognition as a nature reserve of two parts of lot 11B and one part of lot 12, range 1 in the Arundel township cadastre, Argenteuil Registry division, comprising an area of 2,919.2 square metres or 0.29 hectares, took effect on August 15, 2018.
