Order number 2019-08 of the Minister of Transport dated 14 May 2019

Highway Safety Code (chapter C-24.2)

Amendments to the Autonomous Bus and Minibus Pilot Project

THE MINISTER OF TRANSPORT,

CONSIDERING the second paragraph of section 633.1 of the Highway Safety Code (chapter C-24.2), which provides that, after consultation with the Société de l'assurance automobile du Québec, the Minister may, by order, authorize the implementation of pilot projects to study, test or innovate in respect of any matter relevant to the Code, and, for the purposes of road safety, the Minister may in particular develop new rules on traffic or vehicle use and set the rules and conditions for the implementation of a pilot project, and the Minister may also, as part of a pilot project, authorize any person or body to use a vehicle in compliance with the standards and rules prescribed by the Minister, and the provisions of a pilot project prevail over any inconsistent provision of the Code and its regulations;

CONSIDERING the third paragraph of section 633.1 of the Code, which provides that, as regards pilot projects relating to autonomous vehicles, the Minister may also provide for an exemption from the insurance contribution associated with the authorization to operate a vehicle and set the minimum required amount of liability insurance guaranteeing compensation for property damage caused by an automobile, and require the manufacturer or distributor to reimburse the Société for compensation that it will be required to pay in the event of an automobile accident, and those special rules prevail over the rules prescribed by the Automobile Insurance Act (chapter A-25) and its regulations;

CONSIDERING the fourth paragraph of section 633.1 of the Code, which provides in particular that pilot projects are conducted for a period of up to five years when they relate to autonomous vehicles and the Minister may modify or terminate a pilot project at any time;

CONSIDERING the fifth paragraph of section 633.1 of the Code, which provides that the publication requirement set out in section 8 of the Regulations Act (chapter R-18.1) does not apply to an order made under section 633.1 of the Code and an order under the second or third paragraph is published in the *Gazette officielle du Québec*; CONSIDERING that the Minister made the Autonomous Bus and Minibus Pilot Project (chapter C-24.2, r. 37.01);

CONSIDERING that the Société has been consulted on the amendments proposed by this Order for the Pilot Poject;

CONSIDERING that it is expedient to make the amendments listed below to the Pilot Project;

ORDERS AS FOLLOWS:

1. The Autonomous Bus and Minisbus Pilot Project (chapter C-24.2, r. 37.01) is amended in section 4 by striking out "and proof that the manufacturer is aware of the requirement to reimburse the Société for any compensation the Société will be required to pay in the event of an automobile accident" in subparagraph e of paragraph 1.

2. Section 7 is amended by striking out subparagraph 1 of the second paragraph.

3. The Pilot Project is amended by replacing Division III of Chapter II by the following:

"DIVISION III INSURANCE

20. Despite section 87 of the Automobile Insurance Act (chapter A-25), the minimum required amount of liability insurance guaranteeing compensation for property damage caused by an autonomous bus or minibus is \$1,000,000.".

4. The following is inserted after section 27:

"DIVISION II

EXPERIMENTAL PROJECT WITH TRANSDEV QUÉBEC INC.

27.1. The Minister authorizes Transdev Québec inc., as the operator of two EZ10 Gen2 autonomous minibuses, manufactured by EasyMile, a simplified stock corporation, to test the operation of the vehicles in Ville de Montréal

(1) in parking P8 of the Olympic Park and the access roads between the parking lot and avenue Pierre-De Coubertin; (2) in the traffic lane reserved for autonomous minibuses and buses on avenue Pierre-De Coubertin, which is situated between the cycle lane and the sidewalk, from its intersection with rue Sicard to avenue Letourneux;

(3) on avenue Letourneux, from its intersection with avenue Pierre-De Coubertin to the lane situated about 40 metres northwest of rue Ontario Est;

(4) in the lane situated about 40 metres northwest of rue Ontario Est, from its intersection with avenue Letourneux to Place Gennevilliers-Laliberté.

27.2. The signs shown below indicate that a traffic lane is reserved for autonomous minibuses and buses and any other vehicle not covered by the signs is prohibited from using the lane, where the prescription applies.





27.3. During the first two weeks of operation of the vehicles, no passenger may be transported. ".

5. Section 28 is amended by replacing "sections 20 to 22" in the second paragraph by "section 20".

6. This Order comes into force on the fifteenth day following the date of its publication in the *Gazette* officielle du Québec.
