Order of the Minister of Forests, Wildlife and Parks dated 18 March 2020

An Act respecting the conservation and development of wildlife (chapter C-61.1)

CONCERNING the Regulation to amend the Regulation respecting hunting

THE MINISTER OF FORESTS, WILDLIFE AND PARKS,

CONSIDERING the second paragraph of section 56 of the Act respecting the conservation and development of wildlife (chapter C-61.1), which provides that the Minister may, by regulation, allow the hunting and trapping of any animal or any animal of a class of animals determined by the Minister;

CONSIDERING subparagraphs 1 to 4 of the third paragraph of section 56 of the Act, which provide that the regulations may also determine, on the basis of sex or age, what animal or animal of a class of animals may be hunted, the period of the year, day or night during which the animal may be hunted or trapped and the area, territory or place in which the animal may be hunted or trapped;

CONSIDERING subparagraphs 1 and 2 of the fourth paragraph of section 56 of the Act, which provide that the Minister may, by regulation, determine the means and their specifications, and the animals, including domestic animals and dogs, with which hunting, trapping or capturing an animal the Minister indicates is permitted, as well as the maximum number of animals that may be killed or captured by a person or group of persons during a period and in an area, territory or place the Minister indicates;

CONSIDERING subparagraphs 1 to 3 of the first paragraph of section 163 of the Act, which provide in particular that the Minister may make regulations determining classes of licences, certificates, authorizations and leases, as well as their content and duration and the conditions for their issue, replacement, renewal or transfer, limiting the number of licences or leases of each class for a zone, territory or place the Minister specifies, and establishing the requirements that a holder of a licence, certificate, authorization or lease must satisfy; CONSIDERING the first paragraph of section 164 of the Act, which provides in particular that a regulation made under section 56 or under subparagraphs 1 to 3 of the first paragraph of section 163 is not subject to the publication requirements set out in section 8 of the Regulations Act (chapter R-18.1);

CONSIDERING section 51 of the Act to amend the Act respecting the conservation and development of wildlife (2009, chapter 49), which provides that the Regulation respecting the prohibition of hunting and trapping in certain territories (chapter C-61.1, r. 25) remains in force until revoked or replaced by a regulation made by the Minister under section 56 of the Act respecting the conservation and development of wildlife;

CONSIDERING the making of the Regulation respecting hunting (chapter C-61.1, r. 12);

CONSIDERING that it is expedient to amend certain provisions of the Regulation;

ORDERS AS FOLLOWS:

The Regulation to amend the Regulation respecting hunting, attached hereto, is hereby made.

Regulation to amend the Regulation respecting hunting

An Act respecting the conservation and development of wildlife (chapter C-61.1, s. 56, 2nd par., 3rd par., subpars. 1 to 4, 4th par., subpars. 1 and 2 and s. 163, 1st par., subpars. 1 to 3).

1. Section 3.1 of the Regulation respecting hunting (chapter C 61.1, r. 12) is amended

(1) by replacing paragraphs 4 and 5 by the following:

"(4) take the course or courses relating to the certificate applied for, namely,

(a) for a firearm handling certificate, the Canadian Firearms Safety Course (CFSC) and the introduction to hunting with firearms;

(b) for a bow handling certificate, the introduction to hunting with a bow;

(c) for a crossbow handling certificate, the introduction to hunting with a crossbow; and

(d) for a fur-bearing animal trapping certificate, the course on trapping and management of fur-bearing animals; and

(5) hold an attestation or certificate confirming successful completion of the exam or exams relating to the courses required to obtain the certificate applied for.";

(2) by adding the following paragraph:

"A Canadian citizen who is a resident at the time of making an application may obtain a hunter's firearm handling certificate without satisfying the conditions of subparagraphs 4 and 5 of the first paragraph on the condition that a certificate or equivalent proof of competence issued by a Canadian province or territory is provided.".

2. Section 4 is revoked.

3. Section 7 is amended by replacing "in Schedules I and I.1" by "in Schedule I.".

4. Section 7.1 is amended by striking out subparagraph 2.1 of the second paragraph.

5. Section 10 is amended by striking out subparagraph 2 of the first paragraph.

6. Section 11 is amended by replacing the fourth paragraph by the following:

"Despite the first paragraph, the "White-tailed deer, female or male with antlers less than 7 cm, all areas except Area 20" hunting licence expires on the date of expiry, within the meaning of the first paragraph, of the "Whitetailed deer, elsewhere than in Area 20" hunting licence.".

7. Section 12 is amended by inserting "and a whitetailed deer hunting licence" in the second paragraph after "moose hunting licence". **8.** Section 13 is amended in the first paragraph,

(1) by striking out "and "White-tailed deer, female or male with antlers less than 7 cm, all areas except Area 20 (1st killing)"";

(2) by replacing "in sections 1 and 1.1" by "in section 1".

9. Section 13.1 is amended in the second paragraph,

(1) by inserting ", "White-tailed deer, elsewhere than in Area 20" or "Additional white-tailed deer, elsewhere than in Area 20"" after "areas";

(2) by adding the following sentence at the end: "However, the holder of a "White-tailed deer, elsewhere than in Area 20" and "Additional white-tailed deer, elsewhere than in Area 20" hunting licence who has used either licence in one of those territories may continue to hunt white-tailed deer in the area in which the territory is situated only if more than one deer may be harvested there under section 24.".

10. Section 13.5 is amended by striking out the first and third paragraphs.

11. Section 13.6 is amended

(1) in the first paragraph,

(*a*) by inserting the following after subparagraph *a* of subparagraph 4:

"(*a*.1) "Additional white-tailed deer, elsewhere than in Area 20";";

(b) by striking out subparagraphs c and d of subparagraph 4;

(c) by replacing "Wild turkey" in subparagraph i of subparagraph 6 by "Spring wild turkey";

(d) by inserting the following after subparagraph i of subparagraph 6:

"(j) "Fall wild turkey".";

(2) by inserting the following paragraphs after the first paragraph:

"To obtain an "Additional white-tailed deer, elsewhere than in Area 20" hunting licence, a resident must first hold a "White-tailed deer, elsewhere than in Area 20" hunting licence.

An "Additional white-tailed deer, elsewhere than in Area 20" hunting licence obtained by a resident must be issued for a hunting area different than the area specified on the "White-tailed deer, elsewhere than in Area 20" hunting licence held by the resident, except for the western part of Area 5 or the southern and eastern parts of Area 8.".

12. Section 13.7 is amended

(1) in the first paragraph,

(a) by striking out subparagraph a.1 of subparagraph 3;

(b) by inserting the following after subparagraph a.1 of subparagraph 3:

"(*a.2*) "Additional white-tailed deer, elsewhere than in Area 20";";

(2) by inserting the following paragraphs after the first paragraph:

"To obtain an "Additional white-tailed deer, elsewhere than in Area 20" hunting licence, a non-resident must first hold a "White-tailed deer, elsewhere than in Area 20" hunting licence".

An "Additional white-tailed deer, elsewhere than in Area 20" hunting licence obtained by a non-resident must be issued for a hunting area different than the area specified on the "White-tailed deer, elsewhere than in Area 20" hunting licence held by the non-resident, except for the western part of Area 5 or the southern and eastern parts of Area 8.".

13. Section 14 is amended

(1) by replacing "XX to XXVIII, XXX to XXXII, XXXV and CLXXXIII" in the first paragraph by "XX, XXI, XXIII to XXVIII, XXX to XXXII, XXXV, CLXXXIII, CLXXXVII, CCXIV and CCXV and Montmorency Forest Sector A shown on the plan in Schedule CCXVII";

(2) in the second paragraph:

(a) by striking out "or for white-tailed deer with Type 2, 9 or 11 implements";

(b) by replacing "2, 9," by "10,";

(c) by replacing "those species" by "that species";

(3) in the last paragraph:

(a) by replacing "in section 16" by "in sections 16 and 16.1";

(b) by adding the following sentence at the end: "In addition, hunting is permitted only at a distance of more than 100 m from any place where bait has been deposited.".

14. Section 17 is amended

(1) in the first paragraph,

(a) by inserting "2," in subparagraph 1 after "areas";

(b) by striking out "eastern part shown on the plan in Schedule XI and the" in subparagraph 1;

(c) by replacing "2016 and 2018" in subparagraph 1 by "2020" and "in the same years" wherever appearing by "in the same year";

(d) by inserting "2," in subparagraph 2 after "areas";

(e) by striking out "eastern part shown on the plan in Schedule XI and the" in subparagraph 2;

(f) by replacing "2017 and 2019" in subparagraph 2 by "2021";

(g) by inserting "Areas 1, 6 and" in subparagraph 3 before "the western";

(*h*) by replacing "from 2016 to 2018" in subparagraph 3 by "in 2020 and 2021";

(i) by striking out subparagraph 4;

(*j*) by replacing "from 2016 to 2019" in subparagraphs 5 and 6 by "in 2020 and 2021";

(k) by striking out subparagraphs 7, 10 and 11;

(2) in the second paragraph,

(a) by inserting "Bas-Saint-Laurent," in subparagraph 1 after "Anse-Saint-Jean";

(b) by inserting "Chapais," in subparagraph 1 after "Chapeau-de-Paille,";

(c) by inserting "Owen," in subparagraph 1 after "Onatchiway,";

(d) by replacing "2012, 2014, 2016 and 2018, except in the Bas-Saint-Laurent, Chapais and Owen controlled zones, where the hunting of moose with antlers not less than 10 cm is permitted in 2018" in subparagraph 1 by "2020";

(e) by replacing "2013, 2015, 2017 and 2019, except in the Bas-Saint-Laurent, Chapais and Owen controlled zones, where the hunting of moose is permitted in 2019" in subparagraph 2 by "2021";

(f) by replacing "2014, 2016 and 2018" in subparagraph 3 by "2020" and "during the same years" by "in the same year";

(g) by replacing "2015, 2017 and 2019" in subparagraph 4 by "2021";

(*h*) by replacing "2014, 2015, 2016 and 2018" in subparagraph 5 by "2020" and "during the same years" by "in the same year";

(*i*) by replacing "2017 and 2019" in subparagraph 6 by "2021";

(*j*) by replacing "from 2012 to 2019" in subparagraphs 7 and 8 by "in 2020 and 2021";

(3) by replacing "from 2012 to 2019" in the third paragraph by "in 2020 and 2021".

15. Section 18 is amended

(1) by replacing "and c or c.1" in the first paragraph by ", a.1 and c";

(2) by replacing "*ii* or *iii*" in the second paragraph by "2 or 3";

(3) by striking out "or *c*.1" in the third paragraph".

16. Section 19 is amended by replacing "ii" and "iii" in the first paragraph by "2" and "3" respectively.

17. Section 24 is amended by replacing subparagraph 1 of the first paragraph by the following:

"(1) 2 white-tailed deer, one in an area other than Area 20 for the holder of a licence referred to in paragraph a of section 2 of Schedule I and the other in a second area, other than Area 20, for the holder of a licence referred to in paragraph a.1 of section 2 of Schedule I, other than the western parts of Area 5 and the southern and eastern parts of Area 8 where 2 white-tailed deer may be harvested in one area only; and".

18. Section 26 is amended

(1) by replacing "in 1 year," by "in a single year, a maximum of";

(2) by striking out ", one of which must come from Area 10 during the fall hunting season";

(3) by adding the following paragraph:

"The bag limit is apportioned on the basis of areas visited and the season, as follows:

(1) 1 black bear during the spring hunting season in hunting Areas 2, 3, 7, 13, 14, 16, 17, 18, 21, the eastern part of Area 27 and Area 28; and

(2) 1 black bear during the spring hunting season and 1 black bear during the fall hunting season in hunting Areas 1, 4, 5, 6, 8, 9, 10, 11, 12, 15, 19, 23, 24, 26, the western part of Area 27 and Area 29.".

19. Section 27.1 is replaced by the following:

"27.1. Any person may kill, in a single year, a maximum of 3 wild turkeys, as follows:

(1) 2 bearded wild turkeys, the second turkey having to be killed in Area 4, 5, 6, 7, 8, 9 or 10 during the spring hunting season; and

(2) 1 wild turkey, bearded or not, during the fall hunting season.".

20. Section 30 is amended

(1) by replacing "second paragraph" in subparagraph 2 of the first paragraph by "second, third, fourth and fifth paragraphs" and by inserting "other than standing crops, crops stacked or grain scattered in accordance with normal farm practices" after "substances";

(2) in the second paragraph,

(a) by inserting "or odorous substances" after "Food";

(b) by replacing "23, 24 and 29" by "the western part of Area 27 and Area 29";

(c) by replacing "and 26 to 28. In the case of wild turkey, any baiting is prohibited" by ", 26, the eastern part of Area 27 and Area 28", and by replacing "areas" wherever appearing by "Areas";

(3) by adding the following paragraphs:

"Food or odorous substances may not be deposited to bait white-tailed deer during the period from 1 December to 31 August. A saline substance used as bait is permitted at all times.

In the case of wild turkey, all baiting is prohibited.

The use of urine or any other natural substance taken from cervids other than moose is prohibited at all times.".

21. Section 31 is amended by replacing "2.60" in subparagraphs a and b of paragraph 14 by "2.50".

22. The Regulation is amended by inserting the following after section 32:

"32.1. A person may use a pointer or flusher hunting dog within the meaning of paragraph 2 of section 24 of the Regulation respecting hunting activities (chapter C-61.1, r. 1) to hunt wild turkey during the fall hunting season."







FISHING, HUNTING AND TRAPPING AREAS


SOUTHERN AND NORTHERN PARTS OF AREA 1
