## Orders-in-Council

Gouvernement du Québec

### **O.C. 807-2020, 15 July 2020**

Renewal of the public health emergency pursuant to section 119 of the Public Health Act

WHEREAS the World Health Organization declared COVID-19 to be a pandemic on 11 March 2020;

WHEREAS, under section 118 of the Public Health Act (chapter S-2.2), the Government may declare a public health emergency in all or part of the territory of Québec where a serious threat to the health of the population, whether real or imminent, requires the immediate application of certain measures provided for in section 123 of the Act to protect the health of the population;

WHEREAS the pandemic constitutes a serious and real threat to the health of the population that requires the immediate application of certain measures provided for in section 123 of the Act;

WHEREAS, under the first paragraph of section 119 of the Act, the public health emergency declared by the Government is effective for a maximum period of ten days at the expiry of which it may be renewed, as many times as necessary, for a maximum period of ten days or, with the consent of the National Assembly, for a maximum period of 30 days;

WHEREAS, under section 121 of the Act, the public health emergency is effective as soon as it is declared or renewed;

WHEREAS, while the public health emergency is in effect, despite any provision to the contrary, the Government or the Minister of Health and Social Services, if the Minister has been so empowered, may, without delay and without further formality, take any of the measures provided for in subparagraphs 1 to 8 of the first paragraph of section 123 of the Act to protect the health of the population;

WHEREAS, by Order in Council 177-2020 dated 13 March 2020, the Government declared a public health emergency and took certain measures to protect the health of the population;

WHEREAS the public health emergency was renewed until 29 March 2020 by Order in Council 222-2020 dated 20 March 2020, until 7 April 2020 by Order in Council 388-2020 dated 29 March 2020, until 16 April 2020 by Order in Council 418-2020 dated 7 April 2020, until

WHEREAS it is expedient to renew the public health emergency for a period of eight days;

IT IS ORDERED, therefore, on the recommendation of the Minister of Health and Social Services:

THAT the public health emergency be renewed until 22 July 2020;

WHEREAS it is expedient to order certain measures to protect the health of the population;

IT IS ORDERED, therefore, on the recommendation of the Minister of Health and Social Services:

THAT, for the purposes of this Order in Council,

(1) “face covering” means a mask or tightly fitting cloth that covers the nose and the mouth;

(2) “public place” means the part of the following places accessible to the public, insofar as it is enclosed or partially covered and is not an accommodation unit:

(a) a retail business, a shopping centre, or a building or room where a service enterprise is operated, including a personal care or beauty care enterprise;

(b) a restaurant or a bar;

(c) a place of worship;

(d) a place where activities or services of a cultural or entertainment nature are offered;

(e) a place where sports are played or recreational activities are carried on;

(f) a rental hall or other place used to hold events, including conventions and conferences, or to hold receptions;

(g) a place where municipal or government services are available;

(h) a common area, including an elevator, of a tourist accommodation establishment;

(i) a building or room used by an educational institution, excluding an institution providing preschool education services or elementary or secondary school general education instructional services for youth;

(j) a train or bus station, a ferry terminal, a subway station or an airport; and

(k) a private health consulting room or office;

THAT it be prohibited for an operator of a public place to allow a person who is not wearing a face covering to enter the public place, or to tolerate the presence in the public place of a person not wearing a face covering, unless the person

(1) is less than 12 years of age;

(2) states that the wearing of a face covering is not possible because of the person’s medical condition;

(3) is in the public place receiving care, being provided a service or engaging in a physical or other activity requiring the face covering be removed, in which case the person may remove the face covering for the duration of the care, service or activity;

(4) removes the face covering momentarily for identification purposes;

(5) works or practises his or her profession in the public place;

(6) is a member of the public or a student in a place referred to in the sixth paragraph in the operative part of Order in Council 689-2020 dated 25 June 2020, so long as the conditions set out in that paragraph are respected;

(7) is in a courtroom and is not covered by the preceding subparagraph, or is in a jury room;

(8) is consuming food or a beverage in a restaurant, in a food court at a shopping centre or food store, in a bar or in any other room used for the purposes of restaurant services or the consumption of beverages; or

(9) is seated in a place, excluding a place of worship, and complies with one of the following conditions:

(a) a distance of two metres is maintained between any other person who is neither an occupant of the same private residence or its equivalent nor a person providing a service or support; or

(b) the person is separated by a physical barrier able to limit contagion of any person who is neither an occupant of the same private residence or its equivalent nor a person providing a service or support;

THAT, despite subparagraph 5 of the preceding paragraph,

(1) it be prohibited for an operator to allow entry into an immovable, excluding a residential immovable, whether or not it is a public place, of any person, even one who works or practises his or her profession there, if the person is not wearing a face covering, or to tolerate the presence of the person in an entrance hall, a reception area or an elevator of the immovable if the person is not wearing a face covering;

(2) a person who works or practises his or her profession in a public place remain subject to the rules that apply in matters of occupational health and safety;

THAT any person who is guilty of an offence under section 139 of the Public Health Act (chapter S-2.2) by reason of the person contravening the rules set out in this Order in Council be liable to a fine of \$400 to \$6000;

THAT the Minister of Health and Social Services be empowered to order any modification or clarification of the measures provided for in this Order in Council;

THAT this Order in Council take effect on 18 July 2020.

#### Ministerial Order 2020-051 of the Minister of Health and Social Services dated 10 July 2020

Public Health Act  
(chapter S-2.2)

Ordering of measures to protect the health of the population amid the COVID-19 pandemic situation

THE MINISTER OF HEALTH AND SOCIAL SERVICES,

CONSIDERING section 118 of the Public Health Act (chapter S-2.2), which provides that the Government may declare a public health emergency in all or part of the territory of Québec where a serious threat to the health of the population, whether real or imminent, requires the immediate application of certain measures provided for in section 123 of the Act to protect the health of the population;

CONSIDERING Order in Council 177-2020 dated 13 March 2020 declaring a public health emergency throughout Québec for a period of 10 days;

CONSIDERING that that Order in Council orders in particular the suspension of activities of childcare centres, day care centres and home childcare services;

CONSIDERING Order in Council 689-2020 dated 25 June 2020 ordering in particular certain measures related to seating arrangements in bars and the assemblies that take place there;

CONSIDERING that the public health emergency was renewed until 29 March 2020 by Order in Council 222-2020 dated 20 March 2020, until 7 April 2020 by Order in Council 388-2020 dated 29 March 2020, until 16 April 2020 by Order in Council 418-2020 dated 7 April 2020, until 24 April 2020 by Order in Council 460-2020 dated 15 April 2020, until 29 April 2020 by Order in Council 478-2020 dated 22 April 2020, until 6 May 2020 by Order in Council 483-2020 dated 29 April 2020, until 13 May 2020 by Order in Council 501-2020 dated 6 May 2020, until 20 May 2020 by Order in Council 509-2020 dated 13 May 2020, until 27 May 2020 by Order in Council 531-2020 dated 20 May 2020, until 3 June 2020 by Order in Council 544-2020 dated 27 May 2020, until 10 June 2020 by Order in Council 572-2020 dated 3 June 2020, until 17 June 2020 by Order in Council 593-2020 dated 10 June 2020, until 23 June 2020 by Order in Council 630-2020 dated 17 June 2020, until 30 June 2020 by Order in

CONSIDERING that, by Orders in Council 505-2020 dated 1 May 2020 and 566-2020 dated 27 May 2020, the suspension applicable to the activities of childcare centres, day care centres and home childcare services under Order in Council 177-2020 dated 13 March 2020 was lifted throughout Québec, provided that the activities are carried on in compliance with the conditions set out in the Schedule to Order in Council 505-2020 dated 6 May 2020, amended by Order in Council 566-2020 dated 27 May 2020 and by Ministerial Orders 2020-034 dated 9 May 2020, 2020-039 dated 22 May 2020, 2020-042 dated 4 June 2020, 2020-044 dated 12 June 2020, 2020-047 dated 19 June 2020 and 2020-048 dated 26 June 2020;

CONSIDERING that Order in Council 505-2020 dated 6 May 2020 empowers the Minister of Health and Social Services to order any modification or clarification of the measures provided for;

CONSIDERING that Order in Council 717-2020 dated 8 July 2020 empowers the Minister of Health and Social Services to take any measure provided for in subparagraphs 1 to 8 of the first paragraph of section 123 of the Public Health Act;

CONSIDERING that the current situation of the COVID-19 pandemic allows for the easing of certain measures set in place to protect the health of the population, while maintaining some of the measures necessary to continue that protection;

#### ORDERS AS FOLLOWS:

THAT a bar permit may only be used from 8 a.m. to midnight, in the rooms or terraces indicated on the permit, unless the holder of that permit only sells alcoholic beverages for consumption on the premises at a meal;

THAT the holder of such a permit may admit simultaneously, in each room and on each terrace of the establishment where the permit is used, a maximum of 50% of the number of persons that may be admitted under that permit and may not tolerate a number of people greater than that maximum;

THAT the authorization of dancing provided for on such a permit be suspended;

THAT a distance of 2 metres be maintained with the public during the presentation of a show in an establishment where such a permit is used;

THAT the measures provided for in the preceding paragraphs apply, with the necessary modifications, to holders of a small-scale production permit, a small-scale beer producer's permit or a brewer's permit, when they allow the consumption of alcoholic beverages on the premises in accordance with their permit to produce alcoholic beverages;

THAT the Schedule to Order in Council 505-2020 dated 6 May 2020, amended by Order in Council 566-2020 dated 27 May 2020 and by Ministerial Orders 2020-034 dated 9 May 2020, 2020-039 dated 22 May 2020, 2020-042 dated 4 June 2020, 2020-044 dated 12 June 2020, 2020-047 dated 19 June 2020 and 2020-048 dated 26 June 2020, be further amended

- (1) by striking out sections 1, 2 and 3;
- (2) by striking out the first paragraph of section 5;
- (3) by replacing "Elsewhere in Québec, a" by "A" in the second paragraph of section 5;
- (4) by striking out section 6;

THAT the seventh paragraph of the operative part have effect on 13 July 2020.
