Education Act (chapter I-13.3)

Amended Basic school regulation for preschool, elementary and secondary education for the 2020-2021 school year

Amended Basic school regulation for preschool, elementary and secondary education for the 2020-2021 school year

WHEREAS, under the first paragraph of section 447 of the Education Act (chapter I-13.3), the Government may make regulations to be known as the "basic school regulation";

WHEREAS the Government made the Basic school regulation for preschool, elementary and secondary education (chapter I-13.3, r. 8) and it is expedient to amend it for the 2020-2021 school year only;

WHEREAS, under subparagraph 1 of the second paragraph of section 447 of the Education Act, the basic school regulation made by the Government relates to the nature and objectives of educational services, including preschool education, instructional services, student services and special educational services as well as the general organizational framework thereof;

WHEREAS, under subparagraph 4 of the third paragraph of section 447 of the Act, the basic school regulation may establish rules on the evaluation of learning achievement and the certification of studies;

WHEREAS, pursuant to section 458 of the Act, a draft regulation was submitted to the Conseil supérieur de l'éducation for examination;

WHEREAS, by Order in Council 177-2020 dated 13 March 2020, the Government declared a public health emergency and took certain measures to protect the health of the population;

WHEREAS, under section 12 of the Regulations Act (chapter R-18.1), a proposed regulation may be made without having been published if the authority making it is of the opinion that the urgency of the situation requires it; WHEREAS, under section 13 of that Act, the reason justifying the absence of such publication must be published with the regulation;

WHEREAS, under section 18 of that Act, a regulation may come into force on the date of its publication in the *Gazette officielle du Québec* where the authority that has made it is of the opinion that the urgency of the situation requires it, and the reason justifying such coming into force must be published with the regulation;

WHEREAS, the Government is of the opinion that the urgency owing to the following circumstances warrants the absence of prior publication and such coming into force of the Amended Basic school regulation for preschool, elementary and secondary education for the 2020-2021 school year:

—the students being unable to cover all the learning in the training program while the educational and instructional services were suspended from 13 March to 24 August 2020 must consolidate their learning and undertake upgrading activities during the first months of this school year;

—student and teaching staff absences being more frequent because any person having been in contact with a person who has contracted COVID-19 or shown symptoms associated with the illness must go into preventive self-isolation, the classes are often incomplete, resulting in the learning activities at the beginning of the school year being affected;

—the requirement to inform a student's parents of his or her learning achievement and behaviour in a written communication other than a report card not later than 15 October set out in section 29 of the Basic school regulation for preschool, elementary and secondary education will not be able to be met by many teachers owing to the fight against the COVID-19 pandemic; and

—the requirement to send the first report card at the latest on 20 November set out in section 29 of the Basic school regulation places excessive pressure on the education network and could be compromised as a consequence of the current situation;

IT IS ORDERED, therefore, on the recommendation of the Minister of Education:

THAT the Amended Basic school regulation for preschool, elementary and secondary education for the 2020-2021 school year, attached hereto, be made.

Amended Basic school regulation for preschool, elementary and secondary education for the 2020-2021 school year

Education Act (chapter I-13.3, s. 447, 1st par., 2nd par., subpar. 1 and 3rd par., subpar. 4)

DIVISION I

GENERAL

1. Sections 29 and 29.1 of the Basic school regulation for preschool, elementary and secondary education (chapter I-13.3, r. 8) are to be read as follows for the 2020-2021 school year:

"29. In order to inform a student's parents of the student's learning achievement and behaviour, the school provides one written communication, other than a report card, to the parents no later than 20 November. If the student is of full age, the communication is provided to the student.

29.1. In order to inform a student's parents of the student's academic progress, the school provides a report card to the parents at the end of each of the two terms, in the form prescribed by Schedules IV to VII. If the student is of full age, the report cards are provided to the student.

The report cards are provided no later than 22 January for the first term and 10 July for the second term.".

2. Sections 30 to 30.3 of that Basic school regulation are to be read as follows for that school year:

"30. The preschool education report card must be consistent with the report card in Schedule IV and contain all the information shown in sections 1 and 2 of the report card; the last report card of the school year must contain all the information shown in section 4 of the report card.

The results shown in section 2 of the report card must indicate the status of the development of the competencies in the Preschool Education program and, if it is the last report card of the school year, a report on the level of development achieved by the student for each competency in the Preschool Education program. The status of the development of the competencies and the report on the level of development of the competencies are based on the framework for the evaluation of learning for the Preschool Education program established by the Minister.

30.1. The report cards for elementary education and the first or second cycle of secondary education must be consistent with the report cards in Schedules V to VII, as applicable. They must contain all the information shown in sections 1 to 3 of the report cards and, for the last report card of the school year in elementary education or the first cycle of secondary education, must contain the information shown in section 5 of the report card.

A student's results in section 2 of the report cards must include

(1) a detailed result per competency for the language of instruction, second language and mathematics subjects;

(2) a detailed result per component, theory and practical, for compulsory and elective science subjects, other than mathematics, such as science and technology and applied science and technology; and

(3) a subject mark for each subject taught and the group average.

At the end of the first term of the school year, the detailed results for the subjects in subparagraphs 1 and 2 of the preceding paragraph are detailed for all the competencies or for all the components referred to in those subparagraphs.

At the end of the second term of the school year, the results consist in a report pertaining to the entire program of study, indicating the student's result for the competencies or components of the programs of studies for the subjects in subparagraphs 1 and 2 of the second paragraph as well as, for each subject taught, the student's subject mark and the group average.

The last report card of the school year includes the student's final mark for the competencies or components of the programs of studies established by the Minister for the subjects in subparagraphs 1 and 2 of the second paragraph as well as the student's final subject mark and the final group average for each subject taught. In secondary education, the credits earned for each subject passed are also indicated. **30.2.** The results in section 2 of the elementary school report cards or secondary school report cards, cycle one or two, must all be expressed as a percentage. The results

or two, must all be expressed as a percentage. The results are based on the framework for the evaluation of learning for the programs of study established by the Minister as well as, in accordance with section 30.3, on the examinations set by the Minister or by the school service centre, if applicable.

The final mark per competency or component is calculated according to the following weighting: 50% for each of the two terms.

The student's subject mark and final subject mark are calculated using the weighting of competencies established in the framework for the evaluation.

30.3. Subject to section 34 of this Basic school regulation and section 470 of the Act, a student's result for an examination set by the Minister is worth 10% of the student's final mark.".

3. The preschool education report card appearing in Schedule IV to that Basic school regulation is to be read, for that school year, as the preschool education report card appearing in Schedule I to this Regulation.

4. The elementary school report card appearing in Schedule V to that Basic school regulation is to be read, for that school year, as the elementary school report card appearing in Schedule II to this Regulation.

5. The secondary school report card, cycle one, appearing in Schedule VI to that Basic school regulation is to be read, for that school year, as the secondary school report card appearing in Schedule III to this Regulation.

6. The secondary school report card, cycle two, appearing in Schedule VII to that Basic school regulation is to be read, for that school year, as the secondary school report card appearing in Schedule IV to this Regulation.

DIVISION II

FINAL

7. This Regulation applies despite any inconsistent provision of the Basic school regulation for preschool, elementary and secondary education.

8. This Regulation comes into force on the date of its publication in the *Gazette officielle du Québec*.

O.C. 1023-2020 7 October 2020

Renewal of the public health emergency pursuant to section 119 of the Public Health Act

WHEREAS the World Health Organization declared COVID-19 to be a pandemic on 11 March 2020;

WHEREAS, under section 118 of the Public Health Act (chapter S-2.2), the Government may declare a public health emergency in all or part of the territory of Québec where a serious threat to the health of the population, whether real or imminent, requires the immediate application of certain measures provided for in section 123 of the Act to protect the health of the population;

WHEREAS the pandemic constitutes a serious and real threat to the health of the population that requires the immediate application of certain measures provided for in section 123 of the Act;

WHEREAS, under the first paragraph of section 119 of the Act, the public health emergency declared by the Government is effective for a maximum period of ten days at the expiry of which it may be renewed, as many times as necessary, for a maximum period of ten days or, with the consent of the National Assembly, for a maximum period of 30 days;

WHEREAS, under section 121 of the Act, the public health emergency is effective as soon as it is declared or renewed;

WHEREAS, while the public health emergency is in effect, despite any provision to the contrary, the Government or the Minister of Health and Social Services, if the Minister has been so empowered, may, without delay and without further formality, take any of the measures provided for in subparagraphs 1 to 8 of the first paragraph of section 123 of the Act to protect the health of the population;

WHEREAS, by Order in Council 177-2020 dated 13 March 2020, the Government declared a public health emergency and took certain measures to protect the health of the population;

(1) by inserting the following subparagraph at the end of subparagraph 5:

"(k) physical training rooms;";

(2) by adding the following at the end:

"(17) for school service centres, school boards and private educational institutions, the following persons wear a face covering, that is, a mask or tightly fitting cloth that covers the nose and the mouth:

(a) any person on grounds used by an educational institution when that institution is offering services to students at the secondary school level of the general education instructional services for youth, unless the person

i. is less than 10 years of age and is not a student;

ii. is a preschool student or a student in cycle one or cycle two of the elementary school level of the general education instructional services for youth;

iii. works or exercises his or her profession therein, in which case the person remains subject to the rules applicable with respect to occupational health and safety;

iv. is seated and is consuming food or a beverage;

V. states that the wearing of a face covering is not possible because of his or her medical condition;

vi. receives care or is provided a service requiring the face covering be removed, in which case the person may remove the face covering for the duration of the care or service;

vii. engages in an activity service requiring the face covering be removed as part of a special study program or a school project, provided that a minimum distance of two metres is maintained between every person;

(b) students at the secondary school level of the general education instructional services for youth, at all times, subject to the exceptions provided for in subparagraphs iv to vii of the preceding subparagraph;

i. in a building or room used by an educational institution;

ii. on the grounds or in any building or room used for sport-study, arts-study and sport concentration programs and other special school projects of the same nature;

(c) vocational training students and students in adult general education, in a building or room used by an educational institution, except when seated in a room in which educational and instructional services are provided and a minimum distance of two metres is maintained between every person and subject to the exceptions provided for in subparagraphs iv to vi of subparagraph *a*;

(18) educational institutions reduce by 50% the number of hours of classroom educational services for their Secondary 4 and 5 students, distance educational services be provided to those students to pursue the achievement of the objectives of the study programs and, to that end, distance educational services be favored;

(19) subparagraph 18 not apply to handicapped students and students with social maladjustments or learning disabilities attending schools, classes or specialized groups;

(20) university institutions, colleges established under the General and Vocational Colleges Act (chapter C-29), private educational institutions providing college instruction services and any other institution providing college or university instruction services or ongoing training services must favor distance training to provided their instruction services, unless the acquisition or assessment of knowledge provided for in the student's study program requires the student's presence in class;

(21) any recreational and sport activity be suspended unless

(a) it is carried out, without supervision, alone or with another person, and, in the latter case, a minimum distance of two metres is maintained between every person at all times; (b) it is carried out by the occupants of the same private residence or its equivalent;

(c) it is part of the physical education and health, sportstudy, arts-study and sport concentration programs and other special school projects of the same nature provided as part of the general education instructional services for youth by a school board or a private educational institution, provided that a minimum distance of two metres is maintained between students of different groups;

(d) it is part of the recreational and sport training offered in college or university instruction programs;

(22) any advance poll and any poll to be held in connection with a school election within the meaning of the Act respecting school elections (chapter E-2.3), as it read on 7 February 2020, be postponed and any election proceedings be suspended in the following situations:

(a) where the election is held for the office of chair of the school board;

(b) where the election must also be held for the office of school commissioner in a school board referred to in subparagraph *a*;

(c) except in the situations referred to in subparagraph a or b, where the election is held for the office of commissioner;

(23) in the cases referred to in the preceding subparagraph, voting by mail provided for in Ministerial Order 2020-066 dated 18 September 2020 be cancelled;

(24) despite subparagraph 22, a returning officer declares any candidate elected under section 79 of the Act respecting school elections on the date on which the candidates would have been declared elected if the polling had been held;

(25) no returning officer of a school board municipality is to publish a notice of election;

(26) every public sitting of a governing board of an educational institution must be held without the public being present but must be publicized as soon as feasible using any means enabling the public to be informed of the content of the discussions between the participants and the outcome of the discussions;

(27) every public sitting of a governing board of a school service centre or a council of commissioners of a school board must be held without the public being present but must be publicized in the manner provided for in the preceding subparagraph;

(28) every procedure that is part of the decisionmaking process of an educational body and that involves the movement or gathering of persons as part of a consultation meeting be replaced, for the residents of the territories referred to in this paragraph, by a written consultation, announced beforehand through a public notice of a duration of 15 days;";

THAT, for the purpose of postponing school elections and the holding of sittings of boards of directors and commissioners respectively provided for in subparagraphs 22 and 27 of the tenth paragraph of the operative part of Order in Council 1020-2020 dated 30 September 2020, as amended, every school board whose part of the territory of that school board or its electoral division be covered by that paragraph.

CONSIDERING that it is expedient to order certain measures to protect the health of the population; ORDERS AS FOLLOWS:

THAT the residents in the territories of Municipalité Pointe-à-la-Croix and the Listuguj Community, in the Gaspésie–Îles-de-la-Madeleine health region, be confined to those territories, and may not leave them except for humanitarian purposes, to work or practise their profession, to obtain care or services required by their state of health or to travel to the Province of New Brunswick;

THAT access to the territories of Municipalité Pointeà-la-Croix and the Listuguj Community, in the Gaspésie –Îles-de-la-Madeleine health region, be restricted to the following persons:

(1) persons who have their principal residence there;

(2) persons transporting merchandise and goods;

(3) persons who work or practise their profession there;

(4) persons whose travel is necessary for humanitarian purposes;

(5) persons whose travel is necessary to obtain care or services required by their state of health or to provide such care or services to a person requiring them;

(6) persons who must enter to comply with an order contained in a decision or judgment of a court or to exercise custody or parental access rights contained in an agreement;

(7) persons who access the territory solely to travel to the Province of New Brunswick for one of the purposes described in the preceding paragraphs; and

(8) persons who do not travel elsewhere than on highway 132;

THAT, despite the foregoing, the health director of the Gaspésie–Îles-de-la-Madeleine health region may authorize, in exceptional circumstances and subject to the conditions he or she determines to protect the health of the population, access to the territories by other persons or exit from the territories.

Ordering of measures to protect the health of the population amid the COVID-19 pandemic situation

THE MINISTER OF HEALTH AND SOCIAL SERVICES,

CONSIDERING section 118 of the Public Health Act (chapter S-2.2), which provides that the Government may declare a public health emergency in all or part of the territory of Québec where a serious threat to the health of the population, whether real or imminent, requires the immediate application of certain measures provided for in section 123 of the Act to protect the health of the population;

CONSIDERING Order in Council 177-2020 dated 13 March 2020 declaring a public health emergency throughout Québec for a period of 10 days;

CONSIDERING that Order in Council 1020-2020 dated 30 September 2020, amended by Ministerial Order 2020-074 dated 2 October 2020, provides in particular, despite any provision to the contrary in an Order in Council or a Ministerial Order made under section 123 of the Public Health Act, certain additional measures applicable in certain territories;

CONSIDERING that that Order in Council also provides that the Minister of Health and Social Services is empowered to order any modification or clarification of the measures provided for in that Order in Council;

CONSIDERING that it is expedient to order certain measures to protect the health of the population;

ORDERS AS FOLLOWS:

THAT no person may require that a person install or use Health Canada's COVID Alert application or disclose the information it contains;

THAT no person may advantage or disadvantage a person who has not installed the application, does not use it or refuses to disclose the information it contains;

THAT the measures provided for in the tenth paragraph of the operative part of Order in Council 1020-2020 dated 30 September 2020 and subsequent amendments also apply to the territories of Ville de Carleton-sur-Mer and the municipalities of Maria and Nouvelle, in the Gaspésie–Îles-de-la-Madeleine health region;

THAT the third paragraph of the operative part of this Ministerial Order take effect on 6 October 2020.
