Regulation respecting the *Gazette officielle du Québec*, section 4

Part 2 shall contain:

(1) Acts assented to;

(2) proclamations and Orders in Council for the coming into force of Acts;

(3) regulations and other statutory instruments whose publication in the *Gazette officielle du Québec* is required by law or by the Government;

(4) regulations made by courts of justice and quasi-judicial tribunals;

(5) drafts of the texts referred to in paragraphs (3) and (4) whose publication in the *Gazette officielle du Québec* is required by law before they are made, adopted or issued by the competent authority or before they are approved by the Government, a minister, a group of ministers or a government body; and

(6) any other document published in the French Edition of Part 2, where the Government orders that the document also be published in English.

> Regulation respecting the establishment of an exceptional temporary measure for the executive staff of school service centres owing to the COVID-19 pandemic

THE MINISTER OF EDUCATION,

CONSIDERING section 451 of the Education Act (chapter I-13.3);

CONSIDERING the making of the Regulation respecting certain conditions of employment of senior staff of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal by the Minister's Order dated 10 May 2012 approved by the Conseil du trésor on 8 May 2012 (T.B. 211408) and the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal by the Minister's Order dated 18 November 2004 approved by the Conseil du trésor on 30 November 2004 (T.B. 201768) and their amendments;

CONSIDERING that it is expedient to establish an exceptional temporary measure of recognition for the executive staff of school service centres owing to the COVID-19 pandemic;

CONSIDERING that authorization has been obtained from the Conseil du trésor in accordance with section 451 of the Education Act;

CONSIDERING that the Regulations Act (chapter R-18.1) does not apply to such a Regulation;

ORDERS AS FOLLOWS:

The Regulation respecting the establishment of an exceptional temporary measure for the executive staff of school service centres owing to the COVID-19 pandemic, attached to this Order, is hereby made.

Regulation respecting the establishment of an exceptional temporary measure for the executive staff of school service centres owing to the COVID-19 pandemic

Education Act (chapter I-13.3, s. 451)

1. A senior staff member or senior executive referred to in the Regulation respecting certain conditions of employment of senior staff of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal or the Regulation respecting certain conditions of employment of senior executives of school service centres and of the Comité de gestion de la taxe scolaire de l'île de Montréal who held a position as a senior staff member or senior executive during the period from 13 March 2020 to 30 June 2021 is entitled to a leave credit up to a maximum of 10 days.

The number of days awarded to the senior staff member or senior executive is determined in proportion to the time worked during the period from 13 March 2020 to 30 June 2021.

Accumulated leave is taken at a time agreed upon between the school service centre and the senior staff member or senior executive.

Accumulated leave that has not been taken by 30 June 2022 is paid to the senior staff member or senior executive up to a maximum equivalent to 5 days.

A senior staff member or senior executive who has left their position before 1 July 2021 due to retirement or assignment to any other position at the school service centre is paid their leave up to a maximum equivalent to 5 days at the time of the retirement or assignment.

A senior staff member or senior executive who leaves office between 1 July 2021 and 30 June 2022 is paid the leave that has not been taken at the time of their departure up to a maximum equivalent to 5 days.

2. This Regulation comes into force on the day of its publication in the *Gazette officielle du Québec*.
