### Contents

Regulation respecting the *Gazette officielle du Québec*, section 4

Part 2 shall contain:

- (1) Acts assented to;
- (2) proclamations and Orders in Council for the coming into force of Acts;
- (3) regulations and other statutory instruments whose publication in the *Gazette officielle du Québec* is required by law or by the Government;
- (4) regulations made by courts of justice and quasi-judicial tribunals;
- (5) drafts of the texts referred to in paragraphs (3) and (4) whose publication in the *Gazette officielle du Québec* is required by law before they are made, adopted or issued by the competent authority or before they are approved by the Government, a minister, a group of ministers or a government body; and
- (6) any other document published in the French Edition of Part 2, where the Government orders that the document also be published in English.

### M.O., 2024

#### Order 2024-02 of the Minister of Transport and Sustainable Mobility dated 17 January 2024

Act respecting remunerated passenger transportation by automobile (chapter T-11.2)

Regulation respecting the authorization that a qualified driver must obtain to offer remunerated passenger transportation by automobile from certain places

THE MINISTER OF TRANSPORT AND SUSTAINABLE MOBILITY,

CONSIDERING the first paragraph of section 61.1 of the Act respecting remunerated passenger transportation by automobile (chapter T-11.2), which provides that qualified drivers who offer remunerated passenger transportation by automobile whose starting point is a place determined by regulation of the Minister of Transport must be authorized to do so by the person in charge of the place;

CONSIDERING the publication in Part 2 of the *Gazette officielle du Québec* of 18 December 2023, in accordance with section 10 of the Regulations Act (chapter R-18.1) and section 61 of the Act respecting the implementation of certain provisions of the Budget Speech of 22 March 2022 and amending other legislative provisions (2023, chapter 10), of a draft Regulation respecting the authorization that a qualified driver must obtain to offer remunerated passenger transportation by automobile from certain places, with a notice that it could be made by the Minister on the expiry of 20 days following that publication;

CONSIDERING section 61 of the Act respecting the implementation of certain provisions of the Budget Speech of 22 March 2022 and amending other legislative provisions, which provides that, despite section 17 of the Regulations Act, any first regulation made under section 61.1 of the Act respecting remunerated passenger transportation by automobile comes into force on the fifth day after the date of its publication or on any later date specified in the regulation;

CONSIDERING that it is expedient to make the Regulation respecting the authorization that a qualified driver must obtain to offer remunerated passenger transportation by automobile from certain places;

ORDERS AS FOLLOWS:

The Regulation respecting the authorization that a qualified driver must obtain to offer remunerated passenger transportation by automobile from certain places, attached to this Order, is hereby made.

#### Regulation concerning the authorization that a qualified driver must obtain to offer remunerated passenger transportation by automobile from certain places

Act respecting remunerated passenger transportation by automobile (chapter T-11.2, s. 61.1)

**1.** For the purposes of section 61.1 of the Act respecting remunerated passenger transportation by automobile (chapter T-11.2), the Montréal-Trudeau International Airport is a determined place of which Aéroports de Montréal is in charge.

**2.** An authorization issued by the person in charge of a determined place must contain the following information:

(1) its unique sequential number attributed by the person in charge of the place;

(2) the designation of the place covered by the authorization;

(3) the name of the person in charge of the place;

(4) the name of the driver or the designation of the group of drivers to which the driver belongs, except in the case of an authorization with a validity period of under 1 day;

(5) its date of issue and, in the case of an authorization with a validity period of under 1 day, its time of issue;

(6) its validity period; and

(7) a statement of the applicable conditions, if any.

An authorization that applies to a group of drivers of the same qualified automobile must also contain the registration plate number of the vehicle.

**3.** This Regulation comes into force on the fifth day following the date of its publication in the *Gazette officielle du Québec*.
