Ozone-depleting substances

— Amendments

Regulation to amend the Regulation respecting ozonedepleting substances

WHEREAS under paragraphs a to c and l of section 31 of the Environment Quality Act (R.S.Q., c. Q-2), the Government is empowered, namely, to regulate or prohibit the use of any contaminant and the presence of any contaminant in products utilized in Québec;

WHEREAS under subparagraphs 16 and 18 of the first paragraph of section 70.19 of the Environment Quality Act, the Government is empowered, namely, to control, restrict or prohibit the use of hazardous material or its presence in a product that is used in Québec;

WHEREAS in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), the draft of the Regulation to amend the Regulation respecting ozone-depleting substances was published in Part 2 of the *Gazette officielle du Québec* of 4 October 1995, with a notice that it could be made by the Government upon the expiry of 60 days following that publication;

WHEREAS it is expedient to make the Regulation with amendments;

IT IS ORDERED, therefore, upon the recommendation of the Minister of the Environment and Wildlife:

THAT the Regulation to amend the Regulation respecting ozone-depleting substances, attached to this Order in Council, be made.

Regulation to amend the Regulation respecting ozone-depleting substances

Environment Quality Act (R.S.Q., c. Q-2, s. 31, pars. a to c and l, and s. 70.19, 1st par., subpars. 16 and 18)

- **1.** The Regulation respecting ozone-depleting substances, made by Order in Council 812-93 dated 9 June 1993 and amended by the Regulation made by Order in Council 515-95 dated 12 April 1995, is further amended by inserting the following section after section 10:
- **"10.1.** No person may use a gas sterilization apparatus containing a CFC or an HCFC.".
- **2.** Section 17 is revoked.
- **3.** Section 23 is amended by substituting the number "10.1" for the number "10" in the part preceding subparagraph 1 of the first paragraph.
- **4.** Section 24 is amended by substituting the number "18" for the number "17" in the part preceding subparagraph 1 of the first paragraph.
- **5.** Section 28 is revoked.
- **6.** The Regulation is amended by inserting the following section after section 30:
- **"30.1.** Section 10.1 applies from 1 March 1996 in respect of a gas sterilization apparatus containing a CFC, and from 30 June 1998 in respect of a gas sterilization apparatus containing an HCFC.".
- **7.** This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.
