**Eligibility and registration
— Amendment**

Regulation to amend the Regulation respecting eligibility and registration of persons in respect of the Régie de l'assurance-maladie du Québec

WHEREAS under subparagraph *a* of the first paragraph of section 69 of the Health Insurance Act (R.S.Q., c. A-29), the Government may, after consultation with the Régie de l'assurance-maladie du Québec or upon its recommendation, make regulations to prescribe anything that may be prescribed under that Act;

WHEREAS under subparagraph *l* of the first paragraph of section 69 of the Health Insurance Act, the Government may, after consultation with the Board or upon its recommendation, determine the conditions to be met by a person who registers with the Board, the information and documents he must provide, the time of year of registration, and in what cases, conditions and circumstances and by what methods a person must register with the Board and the cases in which an application for registration may be made by one person on behalf of another;

WHEREAS under Order in Council 1470-92 dated 30 September 1992, the Government made the Regulation respecting eligibility and registration of persons in respect of the Régie de l'assurance-maladie du Québec;

WHEREAS it is expedient to amend the Regulation;

WHEREAS in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R.-18.1), the draft regulation entitled Regulation to amend the Regulation respecting eligibility and registration of persons in respect of the Régie de l'assurance-maladie du Québec was published in Part 2 of the *Gazette officielle du Québec* of 13 September 1995 on pages 2795 and 2796 with a notice that it could be made by the Government upon the expiry of 45 days following that publication;

WHEREAS no comments were received following that publication and no amendment was made to the text of the draft regulation;

WHEREAS the Régie de l'assurance-maladie du Québec was consulted;

WHEREAS it is expedient to make the Regulation to amend the Regulation respecting eligibility and registration of persons in respect of the Régie de l'assurance-maladie du Québec;

IT IS ORDERED, therefore, upon the recommendation of the Minister of Health and Social Services:

THAT the Regulation to amend the Regulation respecting eligibility and registration of persons in respect of the Régie de l'assurance-maladie du Québec, attached to this Order in Council, be made.

**Regulation to amend the Regulation
respecting eligibility and registration of
persons in respect of the Régie de
l'assurance-maladie du Québec**

Health Insurance Act
(R.S.Q., c. A-29, s. 69, 1st par., subpars. *a* and *l*)

1. Section 13 of the Regulation respecting eligibility and registration of persons in respect of the Régie de l'assurance-maladie du Québec, made by Order in Council 1470-92 dated 20 September 1992 and amended by the Regulations made by Orders in Council 67-94 dated 10 January 1994 and 533-95 dated 12 April 1995, is further amended by adding the following paragraph after the first paragraph:

“Notwithstanding the foregoing, in the case of an original document or of a certified true copy, the Board may return it to the person concerned after making a reproduction thereof.”

2. This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.
