Taking of unpaid leave and implementation of alternative measures in public bodies — Amendment

Amendment to the Order in Council respecting the taking of unpaid leave and the implementation of alternative measures in public bodies

WHEREAS under sections 20, 22, 28, 34 and 35 of the Act respecting the conditions of employment in the public sector and the municipal sector (1993, c. 37), the Government may, in respect of any group of employees, establish the number of days of unpaid leave to be allotted by a public body to its employees, prescribe rules for the determination by public bodies of the dates and of the conditions applicable to the unpaid leave and prescribe the implementation of alternative measures;

WHEREAS by Order in Council 1369-93 dated 29 September 1993, amended by Orders in Council 1616-93 dated 24 November 1993, 1803-93 dated 15 December 1993, 1607-95 dated 13 December 1995, 240-96 dated 28 February 1996 and 772-96 dated 26 June 1996, the Government adopted provisions respecting the taking of unpaid leave and the implementation of alternative measures in public bodies;

WHEREAS it is expedient to further amend that Order in Council;

IT IS ORDERED, therefore, upon the recommendation of the Minister for Administration and the Public Service and Chairman of the Conseil du trésor:

THAT the Amendment to Order in Council 1369-93 dated 29 September 1993, attached to this Order in Council, be made.

The Schedule to the Order in Council respecting the taking of unpaid leave and the implementation of alternative measures in public bodies (O.C. 1369-93 dated 29 September 1993, amended by Orders in Council 1616-93 dated 24 November 1993, 1803-93 dated 15 December 1993, 1607-95 dated 13 December 1995, 240-96 dated 28 February 1996 and 772-96 dated 26 June 1996) is amended by substituting the date "15 January 1997" for the date "15 November 1996" in the last line of section 21.

An Act respecting farm income stabilization insurance (R.S.Q., c. A-31)

Various schemes — Amendments

Regulation to amend various farm income stabilization insurance schemes

WHEREAS under sections 2, 5, 6 and 6.1 of the Act respecting farm income stabilization insurance (R.S.Q., c. A-31), the Government made the Income Stabilization Insurance Scheme for Lamb Producers by Order in Council 1837-92 dated 16 December 1992, the Income Stabilization Insurance Scheme for Feeder Cattle and Slaughter Cattle Producers by Order in Council 1845-86 dated 10 December 1986, the Income Stabilization Insurance Scheme for Feeder Calf Producers by Order in Council 898-89 dated 14 June 1989, the Income Stabilization Insurance Scheme for Heavy Calf Producers by Order in Council 1793-86 dated 3 December 1986, the Income Stabilization Insurance Scheme for Apple Producers by Order in Council 1115-94 dated 20 July 1994 and the Income Stabilization Insurance Scheme for Potato Producers by Order in Council 1055-92 dated 15 July 1992;

WHEREAS under the stabilization insurance schemes, an assessment rate shall be set each year for each category of insurable productions;
