Regulation to amend the Fishing, Hunting and Trapping Areas Regulation

Whereas under paragraph 15 of section 162 of the Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1), the Government may, in addition to the other regulatory powers conferred on it by that Act, make regulations
(15) dividing Québec into hunting areas, fishing areas or trapping areas and delimit the areas;

Whereas under the Act, the Fishing, Hunting and Trapping Areas Regulation was made by Order in Council 27-90 dated 10 January 1990;

Whereas it is expedient to amend the Fishing, Hunting and Trapping Areas Regulation in order to change the territorial limits of certain areas;

Whereas in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), a draft Regulation to amend the Fishing, Hunting and Trapping Areas Regulation was published in Part 2 of the Gazette officielle du Québec of 7 May 1997 with a notice that it could be made by the Government upon the expiry of 45 days following that publication;

Whereas it is expedient to make the Regulation to amend the Fishing, Hunting and Trapping Areas Regulation;

IT IS ORDERED, therefore, upon the recommendation of the Minister of the Environment and Wildlife:

That the Regulation to amend the Fishing, Hunting and Trapping Areas Regulation, attached hereto, be made.

## Regulation to amend the Fishing, Hunting and Trapping Areas Regulation*

An Act respecting the conservation and development of wildlife
(R.S.Q., c. C-61.1, s. 162, par. 15)

1. The Fishing, Hunting and Trapping Areas Regulation is amended by substituting Schedules I, II, VII, X, XI, XII, XIII, XIV, XV, XVIII and XXI, attached hereto, for Schedules I, II, VII, X, XI, XII, XIII, XIV, XV, XVIII and XXI to the Regulation.
2. This Regulation comes into force on the fifteenth day following the date of its publication in the Gazette officielle du Québec.
