Des Passes Controlled Zone

WHEREAS under section 81.2 of the Wild-life Conservation Act (R.S.Q., c. C-61), the Government made the Regulation respecting the Des Passes Controlled Zone (R.R.Q., 1981, c. C-61, r.108);

WHEREAS under section 186 of the Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1), every provision of a regulation, order in council or order made by the Government under the Wild-life Conservation Act continues to be in force to the extent that it is consistent with that Act;

WHEREAS under section 184 of that Act, the provisions of the Wild-life Conservation Act are replaced by the corresponding provisions of the Act respecting the conservation and development of wildlife;

WHEREAS under section 104 of the Act respecting the conservation and development of wildlife, the Government may, by order, establish controlled zones on land in the public domain for the development, harvesting and conservation of wildlife or a species of wildlife;

WHEREAS under section 191.1 of the Act respecting the conservation and development of wildlife, regulations made by the Government under section 104 of the Act before 1 January 1987 shall continue to be in force until they are replaced, amended or repealed by an order of the Government;

WHEREAS it is expedient to replace the Regulation respecting the Des Passes Controlled Zone;

IT IS ORDERED, therefore, upon the recommendation of the Minister of the Environment and Wildlife:

THAT the Des Passes Controlled Zone be established according to the technical description and plan attached hereto as a schedule;

THAT this Order in Council replace the Regulation respecting the Des Passes Controlled Zone (R.R.Q., 1981, c. C-61, r.108);

THAT this Order in Council come into force on the date of its publication in the *Gazette officielle du Québec*.

TECHNICAL DESCRIPTION

Des Passes Controlled Zone

A territory situated in the municipalité régionale de comté de Maria-Chapdeleine, in the townships of Maltais, Milot, Petit, Primeau, Tanguay, Constantin, Faraud, Pinsonnault, Saint-Onge in unorganized territory, comprising an area of 1 491 km² and whose perimeter may be described as follows:

Foreword

In this technical description, it is understood that when following a watercourse or skirting a lake, it is always done, unless mentioned otherwise, along the outside limit of the bank or shore, that is the normal high water mark.

Starting from point 1 located on the southwest shore of Lac Bernabé and its coordinates are:
5 420 400 m N and 306 550 m E;

From point 1, westerly, along a straight line to point 2 located on the right bank of Rivière Alex, point whose coordinates are:
5 420 400 m N and 298 400 m E;

From point 2, northeasterly, along that bank and the right bank of Rivière des Aigles, so as to include them, to point 3 whose coordinates are:
5 431 300 m N and 303 350 m E;

From point 3, northwesterly, along the banks and shores of a string of brooks and lakes including Lac Restigouche, so as to include them, to point 4, located on the southern limit of Canton de Petit and its coordinates are:
5 432 950 m N and 300 950 m E;

From point 4, westerly, along that limit to point 5 located on the right bank of Petite Rivière Péribonka, point whose coordinates are:
5 432 950 m N and 291 975 m E;

From point 5, northwesterly then northeasterly, along the bank of that river and the shores of Long, du Camp and Brûlé de la Charrue lakes, so as to include them, to point 6 located on the right bank of Ruisseau de la Charrue, point whose coordinates are:
5 463 350 m N and 302 300 m E;

From point 6, southeasterly, along the bank of that brook, so as to include it, to point 7 located on the northern limit of Canton de Saint-Onge, point whose coordinates are:
5 458 600 m N and 307 150 m E;

From point 7, easterly, along that limit to point 8 located on the western limit of Canton de Faraud, point whose coordinates are:
5 548 150 m N and 318 600 m E;

From point 8, northerly, along the western limit of that township to point 9, skirting Lac Gobeil, so as to include it, point whose coordinates are:
5 469 000 m N and 318 925 m E;

From point 9, easterly, along a straight line to point 10 located on the left bank of Rivière Alex, point whose coordinates are:
5 469 000 m N and 323 100 m E;

From point 10, northeasterly, along the bank of that river, the shore of Petit Lac Alex, the bank of its tributary, so as to include them, to point 11, located on the western limit of the right-of-way of the Alcan power transmission line No. 25, point whose coordinates are:
5 473 400 m N and 324 300 m E;

From point 11, northeasterly, along that right-of-way limit, so as to include it, to point 12 located on the watershed between the two drainage basins, point whose coordinates are:
5 480 500 m N and 326 350 m E;

From point 12, northwesterly, along that watershed between the two drainage basins to point 13, whose coordinates are:
5 489 900 m N and 322 000 m E;

From point 13, northerly, a straight line to point 14 located on the right bank of a tributary of Lac D'Ailleboust and its coordinates are:
5 490 900 m N and 322 000 m E;

From point 14, northwesterly, along the banks and shores of a string of brooks and lakes, so as to include them, to point 15 located at the west end of Petit Lac Brochet, point whose coordinates are:
5 492 450 m N and 319 375 m E;

From point 15, northwesterly, along a straight line to point 16 located on the east shore of Lac de la Batture, point whose coordinates are:
5 492 800 m N and 319 200 m E;

From point 16, southwesterly then northwesterly, along the banks and shores of a string of lakes and brooks including Lac Laliberté, so as to include them, to point 17 whose coordinates are:
5 496 000 m N and 315 350 m E;

From point 17, northeasterly, along a straight line to point 18 located on the shore of an unnamed lake skirting by the shore the lake met there, so as to exclude it, point whose coordinates are:
5 497 500 m N and 316 750 m E;

From point 18, northeasterly then southeasterly, along the shore of that lake, so as to include it, to point 19 located on the bank of a tributary, point whose coordinates are:
5 496 950 m N and 318 600 m E;

From point 19, northeasterly then southeasterly, along the banks and shores of a string of brooks and lakes including Lac D'Ailleboust, so as to include them, to point 20 whose coordinates are:
5 496 500 m N and 322 550 m E;

From point 20, southeasterly, along a straight line to point 21 located on the east shore of Lac Étienne, skirting by their shore so as to include Lac de la Pagaille and Lac en Bordure, point whose coordinates are:
5 494 100 m N and 329 825 m E;

From point 21, southeasterly, along the shore of that lake, the effluent of Lac Richard and Lac Richard, so as to include them, to point 22 whose coordinates are:
5 480 000 m N and 331 425 m E;

From point 22, easterly, along a straight line to point 23 located on the watershed between the two drainage basins, point whose coordinates are:
5 480 000 m N and 332 250 m E;

From point 23, southeasterly, along that limit to point 24 located 3 km from the right bank of Rivière Péribonka, point whose coordinates are:
5 470 225 m N and 335 100 m E;

From point 24, southwesterly, along a line parallel to and 3 km from the bank of that river to point 25 located on the southern limit of Canton de Saint-Onge, skirting Lac du Chagrin and Lac Noir, so as to include them, point whose coordinates are:
5 444 900 m N and 331 150 m E;

From point 25, westerly, along that township limit to point 26 located on the eastern limit of the right-of-way of Alcan power transmission line No. 25, skirting to the south, so as to include them, du Cinq de l'Éternité, de la Belle-Truite, des Angéliques et du Marasme lakes, point whose coordinates are:
5 445 175 m N and 322 900 m E;

From point 26, southwesterly, along the eastern limit of that right-of-way, so as to include it, to point 27, located on the southern limit of Canton de Constantin, point whose coordinates are:
5 432 550 m N and 319 500 m E;

From point 27, westerly, along that township limit to point 28 located on the east bank of Rivière Brûlée skirting Lac Kidney, so as to include it, point whose coordinates are:
5 432 700 m N and 314 400 m E;

From point 28, southeasterly, along the bank of that river, so as to include it, to point 29 located at the end of Lac Côté, skirting to the west, so as to exclude it, the first lake met and to the east, so as to include them, Prudent, du Mâle and Côté lakes, point whose coordinates are:
5 424 400 m N and 314 175 m E;

From point 29, southwesterly, along a straight line to point 30 located on the southeast shore of Lac Bernabé, point whose coordinates are:
5 420 650 m N and 308 250 m E;

From point 30, southwesterly, northwesterly then southwesterly, along the shore of that lake, so as to include it, to the starting point.

Were withdrawn from that territory, the following private lots located on the shore of Lac aux Grandes Pointes.

Canton de Constantin
Rang A
Lots 1 to 28

The above-mentioned coordinates are given in metres and were graphically traced from the U.T.M. squaring used on maps to a scale of 1:50 000 published by the Department of Energy, Mines and Resources, Canada, N.A.D. 1927, Zone 19.

The whole as shown on plan P-1068 to a scale of 1:200 000, a reduced copy of which, bearing number P-1068-1, is attached hereto.




