

**Draft Regulation**

An Act respecting income security  
(R.S.Q., c. S-3.1.1)

**Income security  
— Amendments**

Notice is hereby given, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), that the Regulation to amend the Regulation respecting Income Security, the text of which appears below, may be made by the Government at the expiry of 45 days following this publication.

The purpose of the Draft Regulation is to amend section 24 of the Regulation respecting Income Security in order to permit households that were registered for the financial support program and that cease to be eligible for income security because the head of the household has entered the labour market to continue to benefit from the claim booklet for a period of 48 months.

To date, study of this matter has revealed that it will have a positive impact on those persons.

**Regulation to amend the Regulation  
respecting Income Security<sup>(\*)</sup>**

An Act respecting income security  
(R.S.Q., c. S-3.1.1, s. 25, 2nd par., and s. 91, 1st par.,  
subpar. 18, and 2nd par.)

**1.** The Regulation respecting Income Security is amended by inserting the following after subparagraph 3 of the first paragraph of section 24:

“(4) for not more than 48 consecutive months, in the case of an independent adult or a member of a family having only one adult who ceases to be eligible for the financial support program because of his entry on the labour market, if his gross monthly income does not exceed \$1 500 and for so long as the beneficiary is an independent adult or a member of a family having only one adult; this subparagraph ceases to apply if, after the first month following his entry on the labour market and for more than 3 consecutive months, the adult’s gross monthly income exceeds \$1 500.”

**2.** This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.
