An Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1)

CONCERNING the Rivière-des-Escoumins Controlled Zone

THE MINISTER FOR WILDLIFE AND PARKS,

CONSIDERING THAT under section 104 of the Act respecting the conservation and development of wildlife

amended by section 17 of Chapter 29 of the Acts of 1998, the Minister may establish, after consultation with the Minister of Natural Resources, controlled zones on lands in the public domain for the development, harvesting and conservation of wildlife or a species of wildlife;

CONSIDERING THAT under section 33 of the Act modifying the Act respecting the conservation and development of wildlife and the Act respecting commercial fisheries and aquaculture (1998, c. 29), every order in council made by the Government under section 104 of the Act respecting the conservation and development of wildlife before June 17, 1998 continues to be in force until it is replaced or repealed by an order of the Minister;

CONSIDERING the establishment of the Rivière-des-Escoumins Controlled Zone by Order in Council 795-92 dated May 27, 1992, in accordance with section 104 of the Act respecting the conservation and development of wildlife;

CONSIDERING THAT it is expedient to alter the territory of the Rivière-des-Escoumins Controlled Zone;

CONSIDERING THAT it is expedient to replace Order in Council 795-92 dated May 27, 1992;

ORDERS THAT:

The Rivière-des-Escoumins Controlled Zone be established in accordance with the territorial limits specified in the attached plan;

This Order be substituted for Order in Council 795-92 dated May 27, 1992;

This Order come into force on the day of its publication in the *Gazette officielle du Québec*.
