Rules to amend the Bingo Rules

THE MINISTER OF PUBLIC SECURITY,

CONSIDERING the first and second paragraphs of
section 20 of the Act respecting lotteries, publicity con-
tests and amusement machines (R.S.Q., c. L-6), amended
by section 2 of Chapter 54 of the Statutes of 1997, which
provide that the Régie des alcools, des courses et des
jeux may make rules respecting the matters mentioned
therein relating to lottery schemes;

CONSIDERING the third paragraph of section 20 of the
Act, which provides that every rule shall be submitted to
the Minister of Public Security for approval;

CONSIDERING THAT the Board made the draft Rules to
amend the Bingo Rules attached to this Minister's Order
at its meeting of 27 November 1998;

CONSIDERING the publication of the draft Rules in
Part 2 of the *Gazette officielle du Québec* of 3 February
1999;

CONSIDERING THAT the Board made the Rules to
amend the Bingo Rules attached to this Minister's Order
at its meeting of 23 April 1999;

ORDERS:

THAT the Rules to amend the Bingo Rules, attached
hereto, be approved.

Rules to amend the Bingo Rules*

An Act respecting lotteries, publicity contests
and amusement machines
(R.S.Q., c. L-6, s. 20, 1st par., subpars. *c, i* and
2nd par.; 1997, c. 54, s. 2)

1. Section 7 of the Bingo Rules is amended

(1) by substituting "\$500" for "\$200" in clause *a* of
subparagraph 1 of the first paragraph;

* The Bingo Rules, approved by the Order of the Minister of
Public Security dated 29 September 1997 (1997, *G.O.* 2, 5116),
was last amended by the Rules to amend the Bingo Rules,
approved by the Order of the Minister of Public Security dated
3 December 1998 (1998, *G.O.* 2, 4762).

(2) by substituting the following for subparagraph 4 of the first paragraph:

“(4) in the case of a recreational bingo licence:

(a) where the total maximum value of the prizes is \$200 or less: no more than 1 bingo event per day;

(b) where the total maximum value of the prizes is greater than \$200 without exceeding \$500: no more than 1 bingo event per week;”.

2. A holder of a licence of the “in-hall bingo” subcategory where the maximum value of the prizes is greater than \$200 without exceeding \$500 shall remain subject to the duties and obligations attached to that licence until it expires.

3. A holder of a licence of the “in-hall bingo” subcategory where the value is greater than \$200 without exceeding \$500 may submit an application for authorization to sell instant-win tickets. That authorization may be issued until the licence expires.

4. A holder of a bingo hall operator’s licence shall remain subject to the duties and obligations attached to that licence until it expires without regard to the expiry of bingo licences referred to in section 2.

5. Applications for a licence of the “in-hall bingo” subcategory already submitted to the Régie des alcools, des courses et des jeux shall be dealt with according to the new rules where the maximum value of the prizes is greater than \$200 without exceeding \$500.

6. These Rules come into force on the fifteenth day following the date of their publication in the *Gazette officielle du Québec*.

Order of the Minister for Wildlife and Parks dated 20 May 1999

An Act respecting the conservation and development of wildlife
(R.S.Q., c. C-61.1)

Delimiting areas on land in the public domain in view of increased utilization of wildlife resources

THE MINISTER FOR WILDLIFE AND PARKS,

GIVEN THAT under section 85 of the Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1), amended by section 13 of Chapter 29 of the Acts of 1998, the Minister may delimit, after consulta-

tion with the Minister of Natural Resources, areas on land in the public domain in view of increased utilization of wildlife resources;

CONSIDERING THAT it is expedient to delimit the areas on land in the public domain, as described on the plan attached to this Order, in view of increased utilization of wildlife resources;

CONSIDERING THAT the Minister of Natural Resources has been consulted on the issue;

ORDERS THAT:

The areas on lands in the public domain described on the plan attached to this Order are delimited in view of increased utilization of wildlife resources;

This Order comes into force on the day of its publication in the *Gazette officielle du Québec*.
