Licences

— Amendment

Notice is hereby given, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), that the Regulation to amend the Regulation respecting licences, the text of which appears below, may be made by the Government upon the expiry of 45 days following this publication.

The draft Regulation is intended to make adjustments following the adoption of the Act respecting owners and operators of heavy vehicles (1998, c. 40). To that end, it proposes to amend section 54 of the Regulation respecting licences by replacing “carrier” and “motor vehicle referred to in Title VIII.1 of the Highway Safety Code” (R.S.Q., c. C-24.2) by “owner”, “operator of a heavy vehicle”, and “a person who provides the services of a driver under a leasing contract”.

The draft Regulation will have an impact on the driver who must inform the person providing his services as a driver that his licence has been amended, suspended or cancelled.

Regulation to amend the Regulation respecting licences*

Highway Safety Code
(R.S.Q., c. C-24.2, s. 621, par. 44; 1998, c. 40, ss. 119 and 144, par. 23)

1. Section 54 of the Regulation respecting licences is amended by substituting the following for the part preceding paragraph 1:

“**54.** The procedure according to which an operator, an owner of a heavy vehicle and a person who provides the services of a driver under a leasing contract is informed by a driver referred to in section 519.7 of the Code is the following:”.

2. This Regulation comes into force on 1 July 1999.

Carriers' demerit points — Revocation

Notice is hereby given, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), that the Regulation to revoke the Regulation respecting carriers' demerit points, the text of which appears below, may be made by the Government upon the expiry of 45 days following this publication.

Section 4 of the Act respecting owners and operators of heavy vehicles (1998, c. 40) provides for the establishment of a register for owners and operators of heavy vehicles, the “Registre des propriétaires et des exploitants de véhicules lourds”, at the Commission des transports du Québec. The Commission must now register these owners and operators and assign them a safety rating based on their conduct. Therefore, the Regulation respecting carriers' demerit points no longer applies and must be revoked.
