Carrier — Revocation

Notice is hereby given, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), that the Regulation to revoke the Regulation respecting the notion of "carrier", the text of which appears below, may be made by the Government upon the expiry of 45 days following this publication.

The Act respecting owners and operators of heavy vehicles (1998, c. 40) substituted the notions of "owner" and "operator" for that of "carrier". The Regulation defining the notion of "carrier" must consequently be revoked because it is no longer useful.

* The Regulation respecting carriers' demerit points, made by Order in Council 672-88 dated 4 May 1988 (1988, *G.O.* 2, 1988), has not been amended since then.
