### Tariffs of private transportation by taxi

#### — Amendments

Regarding the Regulation to amend the Tariffs of private transportation by taxi

Take notice that the Commission des transports du Québec, in accordance with section 42 of the Act respecting transportation by taxi (R.S.Q., c. T-11.1), amended by section 6 of Chapter 8 of the Statutes of 1998, has adopted, on 3 March 2000, the Regulation to amend the Tariffs of private transportation by taxi, attached hereto.

Furthermore, take notice that under section 42.2 of the Act respecting transportation by taxi, this proposed regulation was not subject to the publication requirements set out in section 8 of the Regulations Act (R.S.Q., c. R-18.1); however, in accordance with this section, it has been subject to prior consultation at a public hearing held in Montreal on September 20 and December 14, 1999 and in Quebec City on September 22, 1999, after the publication of a notice in the daily *Le Devoir* of August 21 and September 25, 1999, inviting interested persons to present their observations.

Therefore, in accordance with section 17 of the Regulations Act (R.S.Q., c. R-18.1), the Regulation to amend the Tariffs of private transportation by taxi, attached hereto, comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.

### Regulation to amend the Tariffs of private transportation by taxi\*

An Act respecting transportation by taxi  
(R.S.Q., c. T-11.1, s. 42; 1998, c. 8)

1. Section 4 of Tariffs of private transportation by taxi is amended by substituting number “22,083” for number “21,818”.

\* The Tariffs of private transportation by taxi have been adopted by the Commission des transports du Québec on June 29, 1998 and published in the *Gazette officielle du Québec* on July 29, 1998 (1998, G.O. 2, 3467).

2. The following is substituted for section 6 of these Tariffs:

“6. The price of a trip calculated by the taximeter is as follows:

	Drop rate	By kilometer covered with a customer	Per hour or fractions of an hour wait

3. The following is substituted for section 7 of these Tariffs:

“7. The price of a trip calculated by the odometer is as follows:

4. Section 8 of these Tariffs is amended by substituting in the first paragraph “24,35\$” for “21,08\$”, “1,70\$” for “1,48\$”, “26,05\$” for “22,56\$”, “1,95\$” for “1,69\$” and “28,00\$” for “24,25\$”.

5. Section 10 of these Tariffs is amended:

1° By substituting “12,00\$, including GST and PST.” for “10\$” in the first paragraph;

2° By substituting “12\$” for “10\$” in the second paragraph.

6. Section 11 of these Tariffs is revoked.

7. Section 12 of these Tariffs is amended by substituting in the first paragraph “21,30\$” for “19,31\$”, “1,49\$” for “1,35\$”, “22,79\$” for “20,66\$”, “1,71\$” for “1,54\$ and “24,50\$” for “22,20\$”.

8. Section 13 of these Tariffs is amended by substituting in the first paragraph “9,56\$” for “8,79\$”, “0,67\$” for “0,61\$”, “10,23\$” for “9,40\$”, “0,77\$” for “0,70\$” and “11,00\$” for “10,10\$”.

9. Section 15 of these Tariffs is amended by substituting in the first paragraph “3,79\$” for “3,43\$”, “0,26\$” for “0,24\$”, “4,05\$” for “3,67\$”, “0,30\$” for “0,28\$” and “4,35\$” for “3,95\$”.

10. Section 16 of these Tariffs is amended by substituting the following for the first paragraph:

“16. The price of a trip superior to 1,6 km is as follows:

	Drop rate	By kilometer covered with a customer	Per hour or fractions of an hour wait
Basic price	0,00\$	1,48\$	23,04\$
7 % GST	<u>0,00\$</u>	<u>0,10\$</u>	<u>1,61\$</u>

11. Section 17 of these Tariffs is amended by substituting in the first paragraph “3,79\$” for “3,43\$”, “0,26\$” for “0,24\$”, “4,05\$” for “3,67\$”, “0,30\$” for “0,28\$” and “4,35\$” for “3,95\$”.

12. Section 18 of these Tariffs is amended by substituting the following for the first paragraph:

“18. The price of a trip superior to 1,6 km is as follows:

	Drop rate	By kilometer covered with a customer	Per hour or fractions of an hour wait
Basic price	0,00\$	1,48\$	23,04\$
7 % GST	<u>0,00\$</u>	<u>0,10\$</u>	<u>1,61\$</u>

7.5 % PST	<u>0,00\$</u>	<u>0,12\$</u>	<u>1,85\$</u>

13. Section 19 of these Tariffs is amended by substituting “5,50\$, including GST and PST” for “5,00\$” in the first paragraph.

14. This Regulation comes into force the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.

### — Amendments

Notice is hereby given that the Commission de protection du territoire agricole du Québec made at its meeting of 3 March 2000 the By-law to amend the Preservation of Agricultural Land and Agricultural Activities Regulation, the text of which appears below.

The By-law sets out the information and documents required for the valid submission to the Commission of an application under sections 58 and 65 of the Act.

The By-law also provides for the revocation of Chapter 3 of and Schedules 1 to 5 to the existing Regulation.

A draft By-law was published in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1) in Part 2 of the *Gazette officielle du Québec* of 22 December 1999 with a notice that it could be made by the Commission upon the expiry of 45 days following that publication.

## By-law to amend the Preservation of Agricultural Land and Agricultural Activities Regulation\*

An Act respecting the preservation of agricultural land and agricultural activities  
(R.S.Q., c. P-41.1, s. 19.1, 1st par., subpars. 1 and 2)

1. The heading of Chapter I of the Preservation of Agricultural Land and Agricultural Activities Regulation is struck out.

2. The following is substituted for sections 1 to 3:

\* The Preservation of Agricultural Land and Agricultural Activities Regulation, approved by Order in Council 1163-84 dated 16 May 1984 (1984, *G.O.* 2, 1938), was last amended by by-law adopted by the Commission de protection du territoire agricole du Québec at its meeting held on 25 May 1998 (1998, *G.O.* 2, 2125). For previous amendments, refer to the *Tableau des modifications et Index sommaire*, Éditeur officiel du Québec, 2000, updated to 1 February 2000.
