### Draft Regulation

An Act respecting childcare centres and childcare services (R.S.Q., c. C-8.2)

#### Childcare centres — Amendments

Notice is hereby given, in accordance with sections 10 and 13 of the Regulations Act (R.S.Q., c. R-18.1), that the Regulation to amend the Regulation respecting childcare centres, the text of which appears below, may be made by the Government upon the expiry of 20 days following this publication.

The draft Regulation prescribes that the date of coming into force of certain provisions concerning the requirement that certain holders of childcare centre permits shall ensure that at least two staff members out of three have the qualifications prescribed in the Regulation be 1 September 2001 instead of 1 September 2000. Its purpose is also to allow certain holders of childcare centre permits who would have to meet those requirements between 1 September 2000 and 31 August 2001 to do so only as of 1 September 2001.

Under section 12 of the Regulations Act, the proposed Regulation may be made after a period shorter than the 45-day period provided for under section 11 of that Act because of the urgency due to the following circumstances:

— since the training of persons registered in the different available training programs will not be completed for certain of those persons by 1 September 2000, some permit holders will not be able to meet the requirements concerning the qualification of the childcare staff on that date. Therefore, it is expedient to postpone the date so that the permit holders will not be in breach of the law.

### Regulation to amend the Regulation respecting childcare centres\*

An Act respecting childcare centres and childcare services (R.S.Q., c. C-8.2, s. 73, par. 17)

1. Section 104 of the Regulation respecting childcare centres is amended

(1) by substituting “2001” for “2000” in the first paragraph;

(2) by adding the following paragraph at the end:

“Moreover, for the purposes of the second and third paragraphs of that section, where the anniversary date provided for in those paragraphs falls between 1 September 2000 and 31 August 2001, it shall be postponed to 1 September 2001.”.

2. This Regulation comes into force on 1 September 2000.
