Caisse de dépôt et placement du Québec — Deposits by certain public bodies of their pension funds and conditions of such deposits — Amendment

Regulation amending the Regulation of the Caisse de dépôt et placement du Québec respecting deposits by certain public bodies of their pension funds and the conditions of such deposits

WHEREAS under section 20.1 of the Act respecting the Caisse de dépôt et placement du Québec (R.S.Q., c. C-2), the Caisse de dépôt et placement du Québec may, on the conditions prescribed by regulation, receive on deposit any sum of money from a public body designated by regulation or belonging to a category of public bodies authorized by regulation, or from a pension fund of such a public body;

WHEREAS under paragraph *c* of section 23 of the Act, the Fund shall establish by regulation the public bodies or categories of public bodies and the pension funds of such bodies from which it may receive sums of money on deposit under section 20.1 of the Act;

WHEREAS under section 13 of the Act, the board of directors shall make the regulations of the Fund, and such regulations shall be submitted to the Government for approval and published in the *Gazette officielle du Québec*;

WHEREAS at its meeting of 26 May 2000, the board of directors of the Fund made the Regulation amending the Regulation of the Caisse de dépôt et placement du Québec respecting deposits by certain public bodies of their pension funds and the conditions of such deposits;

WHEREAS it is expedient to approve the Regulation;

It is ordered, therefore, upon the recommendation of the Minister of Finance:

That the Regulation amending the Regulation of the Caisse de dépôt et placement du Québec respecting deposits by certain public bodies of their pension funds and the conditions of such deposits, attached to this Order in Council, be approved.

Regulation amending the Regulation of the Caisse de dépôt et placement du Québec respecting deposits by certain public bodies or their pension funds and the conditions of such deposits*

An Act respecting the Caisse de dépôt et placement du Québec
(R.S.Q., c. C-2, s. 20.1 and s. 23, par. *c*)

1. Section 1 of the Regulation of the Caisse de dépôt et placement du Québec respecting deposits by certain public bodies or their pension funds and the conditions of such deposits is hereby replaced with the following:

“1. The Caisse de dépôt et placement du Québec may receive on deposit any sum of money from a public body within the meaning of section 20.2 of the Act respecting the Caisse de dépôt et placement du Québec, from a municipal body within the meaning of section 20.3 of that Act, from a school body within the meaning of section 20.4 of that Act, from a health and social service establishment within the meaning of section 20.5 of that Act or from a pension fund of such bodies.”

2. This Regulation comes into force on the day of its publication in the *Gazette officielle du Québec*.
