An Act respecting the conservation and development of wildlife

(R.S.Q., c. C-61.1)

Regulation to amend the Regulation respecting hunting

THE MINISTER RESPONSIBLE FOR WILDLIFE AND PARKS,

CONSIDERING that sections 54.1 and 56 of the Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1), amended by sections 56 and 57 respectively of chapter 36 of the Statutes of 1999, provide that the Société de la faune et des parcs du Québec may make regulations on the matters set forth therein;

CONSIDERING that section 168 of the Act respecting the Société de la faune et des parcs du Québec (1999,

c. 36) provides that regulations or bylaws made by the Minister under sections 54.1 and 56 of the Act respecting the conservation and development of wildlife before 1 December 1999 shall remain in force until replaced or repealed by a by-law of the Société made under those sections:

CONSIDERING that the Regulation respecting hunting, which prescribes the conditions for hunting any animal or any class of animals, was made by Minister's Order 99021 dated 27 July 1999;

CONSIDERING that section 164 of the Act respecting the conservation and development of wildlife, amended by section 118 of chapter 36 of the Statutes of 1999, provides that a regulation made by the Société under sections 54.1 and 56 of the Act is not subject to the publication requirements set out in section 8 of the Regulations Act (R.S.Q., c. R-18.1);

CONSIDERING that the fourth paragraph of section 56 of the Act respecting the conservation and development of wildlife, amended by section 57 of chapter 36 of the Statutes of 1999, provides that any regulation made by the Société under that section must be submitted to the Minister for approval;

CONSIDERING that, by resolution No. 01-32adopted by the board of directors on January 24 2001, the Société made the Regulation to amend the Regulation respecting hunting, attached hereto;

ORDERS:

THAT the Regulation to amend the Regulation respecting hunting, attached hereto, be approved.

Regulation to amend the Regulation respecting hunting*

An Act respecting the conservation and development of wildlife

(R.S.Q., c. C-61.1, ss. 54.1 and 56, 2nd par.)

1. The Regulation respecting hunting is amended by substituting the following for the second paragraph of section 10:

^{*} The Regulation respecting hunting, made by Minister's Order 99021 dated 27 July 1999 (1999, *G.O.* 2, 2451), was last amended by the Regulation approved by Minister's Order 2000-021 dated 7 June 2000 (2000, *G.O.* 2, 4237).

"These licences also bear a number, the name of the animal for which it was issued and the number of the area or part of area, the wildlife sanctuary or the controlled zone, if applicable, where the animal may be hunted. They must be signed by the holder."

2. Section 14 is amended by substituting the following for the second paragraph:

"Subject to section 17, in the controlled zones specified in Schedule IV, hunting seasons for moose with Type 1, 10 or 11 implements or for white-tailed deer with Type 2, 6 or 9 implements are determined by the provisions of Schedule IV. The provisions of Schedule III for those species, respecting hunting seasons with Type 1, 2, 6 or 9 implements, do not apply to those controlled zones."

3. Section 17 is amended

- (1) by substituting the following for the first paragraph:
- "17. In areas 2, 6, 10, 12, 13, 14, 16, 18, 22 and the western part of Area 11 shown on the plan in Schedule XV, except for the Petawaga Controlled Zone, moose hunting is permitted in 2001 and 2003.";
- (2) by substituting the following for the third paragraph:

"In areas 6, 12, 13, 14, 16 and 22 and the western part of Area 11 shown on the plan in Schedule XV, except for the Petawaga Controlled Zone, only moose with antlers or moose calves may be hunted in 2002; in Area 13, the hunting of female moose more than one year old with a Type 6 implement is also permitted in 2002."; and

(3) by substituting the following for the fourth and fifth paragraphs:

"In Area 4, except for the northern part shown on the plan in Schedule CXCV and in the Louise-Gosford Controlled Zone, in areas 9, 15 and in the eastern part of Area 11 shown on the plan in Schedule XIV, moose hunting is permitted in 2001 and 2003 and only moose with antlers or moose calves may be hunted in 2002; in the La Croche, Gros-Brochet, Kiskissink, Menokeosawin and Mitchinamecus controlled zones, only moose with antlers may be hunted in 2002 and, in addition, in the Mitchinamecus Controlled Zone, only moose with antlers and female moose more than one year old may be hunted in 2001 and 2003; in the Wessonneau Controlled Zone, only moose with antlers and female moose more than one year old may be hunted in 2001 and 2003.

In the northern part of Area 4 shown on the plan in Schedule CXCV and in the Louise-Gosford Controlled Zone and in Area 5, only moose with antlers and moose calves may be hunted.".

- **4.** The following is substituted for section 19:
- "19. A female moose more than one year old may be hunted in Area 1 or in the wildlife sanctuaries referred to in paragraph *ii* of section 3 of Schedule II or in the controlled zones referred to in paragraph *iii* of section 3 of that Schedule if the hunter holds each of the licences provided for in paragraphs *a* and *b* of section 5 of Schedule I.".
- **5.** Section 23 is amended by deleting paragraph 1.
- **6.** Section 31 is amended
- (1) by substituting the following for subparagraph c of paragraph 1:
- "(c) bows with a torque of at least 18 kilograms within a draw of 0 to 71 centimetres and arrows having a cutting diameter of at least 22 millimetres;
- (d) crossbows with a torque of at least 54 kilograms with a bowstring extension of at least 25 centimetres and equipped with a safety catch; the vire must have a length of at least 40 centimetres and the point must have a cutting diameter of at least 22 millimetres;";
- (2) by substituting the following for subparagraph d of paragraph 2:
- "(d) bows with a torque of at least 18 kilograms within a draw of 0 to 71 centimetres and arrows having a cutting diameter of at least 22 millimetres;
- (e) crossbows with a torque of at least 54 kilograms with a bowstring extension of at least 25 centimetres and equipped with a safety catch; the vire must have a length of at least 40 centimetres and the point must have a cutting diameter of at least 22 millimetres;";
- (3) by striking out the words "with a steel head" in subparagraph *a* of paragraph 9;

- "(c) crossbows with a torque of at least 54 kilograms with a bowstring extension of at least 25 centimetres and equipped with a safety catch; the vire must have a length of at least 40 centimetres and the point must have a cutting diameter of at least 22 millimetres;";

- (5) by substituting the following for subparagraph a of paragraph 10:
- "(a) bows with a torque of at least 18 kilograms within a draw of 0 to 71 centimetres and arrows having a cutting diameter of at least 22 millimetres;";
- (6) by inserting the following after subparagraph b of paragraph 10:
- "(c) crossbows with a torque of at least 54 kilograms with a bowstring extension of at least 25 centimetres and equipped with a safety catch; the vire must have a length of at least 40 centimetres and the point must have a cutting diameter of at least 22 millimetres;"; and

- (a) bows with a torque of at least 18 kilograms within a draw of 0 to 71 centimetres and arrows having a cutting diameter of at least 22 millimetres;




