**Scale of fees and duties related to the development of wildlife**  
— Amendments

Regulation to amend the Regulation respecting the scale of fees and duties related to the development of wildlife

WHEREAS, under paragraph 10 of section 162 of the Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1), the Government may make regulations on the matters set forth therein;

WHEREAS the Government made the Regulation respecting the scale of fees and duties related to the development of wildlife by Order in Council 1291-91 dated 18 September 1991;

WHEREAS it is expedient to amend the Regulation;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), a draft of the Regulation to amend the Regulation respecting the scale of fees and duties related to the development of wildlife was published in Part 2 of the *Gazette officielle du Québec* of 27 June 2001 with a notice that it could be made by the Government on the expiry of 45 days following that publication;

WHEREAS no comments have been received since that publication;

WHEREAS it is expedient to make the Regulation to amend the Regulation respecting the scale of fees and duties related to the development of wildlife, without amendment;

IT IS ORDERED, therefore, on the recommendation of the Minister of Natural Resources, Wildlife and Parks and the Minister for Forests, Wildlife and Parks:

THAT the Regulation to amend the Regulation respecting the scale of fees and duties related to the development of wildlife, attached to this Order in Council, be made.

**Regulation to amend the Regulation respecting the scale of fees and duties related to the development of wildlife\***

An Act respecting the conservation and development of wildlife  
(R.S.Q., c. C-61.1, s. 162, par. 10)

**1.** The Regulation respecting the scale of fees and duties related to the development of wildlife is amended in section 4.2

(1) by replacing “licence for extracting roe and milt” in subparagraph 4 of the first paragraph by “licence to extract roe and milt and to transport”;

(2) by replacing “for extracting roe” in the second paragraph by “to extract roe and milt and to transport”.

**2.** This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.
