An Act respecting municipal territorial organization
(R.S.Q., c. O-9)

Amendment to Order in Council 626-2004 dated 23 June 2004 concerning the Amalgamation of Ville de Drummondville, Ville de Saint-Nicéphore, Municipalité de Saint-Charles-de-Drummond and Paroisse de Saint-Joachim-de-Courval

WHEREAS, in accordance with section 108 of the Act respecting municipal territorial organization (R.S.Q., c. O-9), the Government, by Order in Council 626-2004 dated 23 June 2004, constituted Ville de Drummondville resulting from the amalgamation of Ville de Drummondville, Ville de Saint-Nicéphore, Municipalité de Saint-Charles-de-Drummond and Paroisse de Saint-Joachim-de-Courval;

WHEREAS, under section 110 of the Act, the Government may amend the order at the request of a municipality not later than 12 months from the date set for the first general election;

WHEREAS the polling date for the first general election in Ville de Drummondville has been set at 6 November 2005;

WHEREAS it is expedient to amend Order in Council 626-2004 dated 23 June 2004;

IT IS ORDERED, therefore, on the recommendation of the Minister of Municipal Affairs, Sports and Recreation:

THAT Order in Council 626-2004 dated 23 June 2004 be amended

(1) by inserting “at the end of the last fiscal year for which separate budgets are adopted” in the first paragraph of section 32 after “is abolished”;

(2) by replacing “on the date of coming into force of this Order in Council” in the first paragraph of section 32 by “on that date”;

(3) by replacing “On the date of coming into force of this Order in Council” in the second paragraph of section 32 by “From the first fiscal year for which a budget is adopted by the new town in respect of all its territory”;

(4) by inserting “at the end of the last fiscal year for which separate budgets are adopted” in section 33 after “is abolished”;

(5) by replacing “and 3146” in the first clause of section 35 by “, 3146, 3181 (49.2%), 3188 and 3207”;

(6) by replacing “Amounts” in the first paragraph of section 37 by “From the first fiscal year for which a budget is adopted by the new town in respect of all its territory, the amounts”;

(7) by adding “from the first fiscal year for which a budget is adopted by the new town in respect of all its territory” at the end of section 38 after “town”;

(8) by adding the following paragraph at the end of section 43:

“This section applies from the first fiscal year for which a budget is adopted by the new town in respect of all its territory, except the first paragraph.”;

(9) by deleting section 49.
