Regulation to amend the Regulation respecting the attendance allowance and travelling expenses of the members of the Comité paritaire de l'industrie de l'automobile de la Mauricie

WHEREAS, under paragraph l of section 22 of the Act respecting collective agreement degrees (R.S.Q., c. D-2), a parity committee may, by regulation approved with or without amendment by the Government, determine the amount of the attendance allowance to which its members are entitled in addition to their actual travelling expenses;

WHEREAS the Regulation respecting the attendance allowance and travelling expenses of the members of the Comité paritaire de l'industrie de l'automobile de la Mauricie was approved by Order in Council No. 103-2003 dated 29 January 2003;

WHEREAS the Comité paritaire de l'industrie de l'automobile de la Mauricie adopted the "Regulation to amend the Regulation respecting the attendance allowance and travelling expenses of the members of the Comité paritaire de l'industrie de l'automobile de la Mauricie" at its meeting held on 13 December 2004;

WHEREAS, under paragraph l of section 22 of the Act respecting collective agreement degrees, the Regulation must be approved, with or without amendment, by the Government:

IT IS ORDERED, therefore, upon the recommendation of the Minister of Labour:

THAT the Regulation to amend the Regulation respecting the attendance allowance and travelling expenses of the members of the Comité paritaire de l'industrie de l'automobile de la Mauricie, attached hereto, be approved.

WHEREAS no comment was made concerning the draft Decree:
