Insured hearing devices — Amendments

Making by the Régie de l'assurance maladie du Québec of a Regulation to amend the Regulation respecting hearing devices insured under the Health Insurance Act, dated 13 April 2005

THE RÉGIE DE L'ASSURANCE MALADIE DU QUÉBEC,

CONSIDERING the seventh paragraph of section 3 and section 72.1 of the Health Insurance Act (R.S.Q., c. A-29);

CONSIDERING that it is necessary to amend the price of certain services rendered within the scope of the supplying of insured hearing devices under the Health Insurance Act;

GIVES NOTICE that, by Resolution CA-419-05-07 of the board of directors dated 13 April 2005, it has made the Regulation to amend the Regulation respecting hearing devices insured under the Health Insurance Act, the text of which appears below.

Regulation to amend the Regulation respecting hearing devices insured under the Health Insurance Act*

Health Insurance Act
(R.S.Q., c. A-29, s. 3, 7th par. and s. 72.1)

1. The Regulation respecting hearing devices insured under the Health Insurance Act is amended in section 19:

(1) by replacing “\$267.83” by “\$273.72” in the first paragraph;

For previous amendments, refer to the *Tableau des modifications et Index sommaire*, Éditeur officiel du Québec, 2005, updated to 1 March 2005.

(2) by replacing “\$46.75” by “\$47.16” and “\$22.33” by “\$22.42” in the third paragraph.

2. Section 20 of the Regulation is amended by replacing “\$9.04” by “\$9.24” and “\$131.08” by “\$133.96”.

3. Section 21 of the Regulation is amended by replacing “\$9.04” by “\$9.24” in the second paragraph.

4. Section 24 of the Regulation is amended by replacing “\$9.04” by “\$9.24” in the second paragraph.

5. Section 30 of the Regulation is amended by replacing the second paragraph by the following paragraph:

“For all the services listed in the first paragraph, the lump sum paid is that indicated for each of the devices listed in the following subparagraphs:

- (1) \$62.92 for a decoder;
- (2) \$83.90 for a teletypewriter;
- (3) \$115.36 for an adapted teletypewriter;
- (4) \$41.95 for a telephone amplifier;
- (5) \$104.87 for a frequency modulation system;
- (6) \$62.92 for a personal amplifier;
- (7) \$157.31 for a magnetic loop;
- (8) \$73.41 for an infrared system;
- (9) \$62.92 for a vibro-tactile device;

(10) for an environmental control system of the visual or tactile type, the lump sum indicated for each of the devices listed in the following clauses:

- (a) \$73.41 for a door monitor;
- (b) \$62.92 for a telephone monitor;
- (c) \$62.92 for a fire alarm monitor;
- (d) \$10.49 for a baby cry or sounds monitor;
- (11) \$52.44 for an adapted alarm clock.”.

6. Section 31 of the Regulation is amended by replacing “\$10.26” by “\$10.49” in subparagraph 1 of the first paragraph.

7. Subdivision VII of Division I of Chapter V of the Regulation is amended by that appearing in Schedule I to this Regulation.

8. This Regulation comes into force on the date of its publication in the *Gazette officielle du Québec* and has effect from April 1, 2005.
