## Composition of the comité de retraite of the Government and Public Employees Retirement Plan concerning non-unionizable employees — Amendments

Regulation to amend the Regulation respecting the composition of the Comité de retraite of the Government and Public Employees Retirement Plan concerning non-unionizable employees

WHEREAS, under section 173.1 of the Act respecting the Government and Public Employees Retirement Plan (R.S.Q., c. R-10), the Government may determine, by regulation, after consulting the associations representing the employees to whom the Pension Plan of Management Personnel applies, the composition of the Comité de retraite of the plan and the manner in which the committee members are appointed. However, one of the members representing the employees must be a pensioner under that plan, elected after consultation with the associations representing both the employees and pensioners under the plan;

WHEREAS by Order in Council 194-97 dated 19 February 1997, the Government made the Regulation respecting the composition of the Comité de retraite of the Government and Public Employees Retirement Plan concerning non-unionizable employees;

WHEREAS the associations involved have been consulted and it is expedient to amend the Regulation;

IT IS ORDERED, therefore, on the recommendation of the Minister responsible for Government Administration and Chair of the Conseil du trésor: THAT the Regulation to amend the Regulation respecting the composition of the Comité de retraite of the Government and Public Employees Retirement Plan concerning non-unionizable employees, attached to this Order in Council, be made

## Regulation to amend the Regulation respecting the composition of the Comité de retraite of the Government and Public Employees Retirement Plan concerning non-unionizable employees<sup>\*</sup>

An Act respecting the Government and Public Employees Retirement Plan (R.S.Q., c. R-10, s. 173.1)

**1.** The title of the Regulation respecting the composition of the Comité de retraite of the Government and Public Employees Retirement Plan concerning nonunionizable employees is replaced by the following: "Regulation respecting the composition of the Comité de retraite of the Pension Plan of Management Personnel".

**2.** Section 1 is amended

(1) by replacing "Government and Public Employees Retirement Plan concerning non-unionizable employees" in the first sentence by "Pension Plan of Management Personnel";

(2) by striking out "representing non-unionizable employees referred to in Title IV.0.1 of the Act," in paragraphs 1, 2 and 3;

(3) by replacing paragraph 4 by the following:

"(4) a pensioner under the Pension Plan of Management Personnel, chosen after consultation with the associations representing both the employees to whom the Plan applies and the pensioners under the Plan.".

**3.** This Regulation comes into force on the date it is made by the Government.
