#### **Individual and Family Assistance Act (2005, c. 15) An Act to amend the Act respecting administrative justice and other legislative provisions (2005, c. 17) — Coming into force of certain provisions**

COMING INTO FORCE of certain provisions of the Individual and Family Assistance Act and the Act to amend the Act respecting administrative justice and other legislative provisions

WHEREAS the Individual and Family Assistance Act (2005, c. 15) and the Act to amend the Act respecting administrative justice and other legislative provisions (2005, c. 17) were assented to on 17 June 2005;

WHEREAS, under section 200 of the Individual and Family Assistance Act, certain provisions of that Act come into force on the date or dates to be set by the Government;

WHEREAS section 50 of the Act respecting administrative justice and other legislative provisions provides that the provisions of the Act come into force on the date or dates to be set by the Government;

WHEREAS, by Order in Council 819-2005 dated 31 August 2005, the Government set 1 October 2005 as the date of coming into force of section 191 of the Individual and Family Assistance Act;

WHEREAS, by Order in Council 1021-2005 dated 2 November 2005, the Government set 1 January 2006 as the date of coming into force of sections 1 to 16, 18 to 30, 32 and 48 of the Act to amend the Act respecting administrative justice and other legislative provisions, and 1 July 2006 as the date of coming into force of sections 17, 31, 33 to 42, 44, 45 and 49 of that Act;

WHEREAS it is expedient to set 1 April 2007 as the date of coming into force of sections 74 to 83 and 108 of the Individual and Family Assistance Act and of section 137 of that Act for the part concerning the Youth Alternative Program and a specific program;

WHEREAS it is expedient to set 1 January 2007 as the date of coming into force of any other provision of that Act not yet in force, except the second sentence of the first paragraph of section 64;

WHEREAS it is expedient to set 1 January 2007 as the date of coming into force of sections 46 and 47 of the Act to amend the Act respecting administrative justice and other legislative provisions;

IT IS ORDERED, therefore, on the recommendation of the Minister of Employment and Social Solidarity and the Minister of Justice:

THAT 1 April 2007 be set as the date of coming into force of sections 74 to 83 and 108 of the Individual and Family Assistance Act (2005, c. 15), and of section 137 of that Act for the part concerning the Youth Alternative Program and a specific program;

THAT 1 January 2007 be set as the date of coming into force of any other provision of that Act not yet in force, except the second sentence of the first paragraph of section 64;

THAT 1 January 2007 be set as the date of coming into force of sections 46 and 47 of the Act to amend the Act respecting administrative justice and other legislative provisions (2005, c. 17).
