Taxi transportation — Amendments

Regulation to amend the Taxi Transportation Regulation

WHEREAS, under subparagraph 2 of the first paragraph of section 88 of the Act respecting transportation services by taxi (R.S.Q., c. S-6.01), the Government may make regulations fixing the annual duties payable to obtain, maintain or renew a taxi owner's permit, a taxi driver's permit or a taxi transportation service intermediary's permit, and prescribing any other conditions pertaining thereto;

WHEREAS subparagraph 9 of the first paragraph of section 88 of the Act provides that, for the purposes of section 27 of the Act, the Government may make regulations determining for the areas and territories it indicates, the training qualifications pertaining to toponymic and geographical knowledge, and the qualifications relating to the basic knowledge, skills, abilities and conduct required to carry on the occupation of taxi driver in a particular territory;

WHEREAS, in accordance with the Act, the Government made the Taxi Transportation Regulation by Order in Council 690-2002 dated 5 June 2002;

WHEREAS, under sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), a draft of the Regulation to amend the Taxi Transportation Regulation was published in the *Gazette officielle du Québec* of 27 December 2007 with a notice that it could be made by the Government on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation with amendment;

IT IS ORDERED, therefore, on the recommendation of the Minister of Transport:

THAT the Regulation to amend the Taxi Transportation Regulation, attached to this Order in Council, be made.

Regulation to amend the Taxi Transportation Regulation *

An Act respecting transportation services by taxi
(R.S.Q., c. S-6.01, s. 88, 1st par., subpars. 2 and 9)

1. The Taxi Transportation Regulation is amended by inserting the following after the heading of Division V:

“**25.2.** Every holder of a taxi driver's permit must undergo training on the transportation of disabled persons of a duration of not less than 7 hours, and have in his or her possession a document attesting that the training course has been successfully completed.”.

2. Section 27 is amended by replacing “At least 7 hours of the course, which is to last a minimum of 30 hours, deal with” in the second paragraph by “The course of a duration of not less than 30 hours includes the training referred to in section 25.2 on”.

3. Section 27.1 is replaced by the following:

“**27.1.** Every holder of a taxi driver's permit required to undergo training pursuant to section 25.2, 26 or 27 of this Regulation or the second paragraph of section 27 of the Act must have in his or her possession a document attesting that the training courses have been successfully completed.

27.2. Every holder of a taxi driver's permit must hold and have in his or her possession, before 31 December 2011, a document attesting that the training course on the transportation of disabled persons has been successfully completed.”

4. Section 80 is revoked.

5. This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.
