Order of the Minister of Sustainable Development, Environment and Parks dated 5 November 2008

Natural Heritage Conservation Act
(R.S.Q., c. C-61.01)

Extension of the setting aside of land for four proposed ecological reserves

CONSIDERING section 88 of the Natural Heritage Conservation Act (R.S.Q., c. C-61.01) which provides that the ecological reserves existing on 19 December 2002 are maintained, are deemed to be set aside in accordance with Title III of the Act for a period of 4 years beginning on 19 December 2002 and are governed, as of that date, by the provisions of the Act;

CONSIDERING M.O., 2006 of the Minister of Sustainable Development, Environment and Parks dated 23 November 2006, made in accordance with section 28 of the Natural Heritage Conservation Act, by which the period for the setting aside of the following land has been extended for 2 years until 19 December 2008:

- the proposed Grande-Rivière ecological reserve;
- the proposed Matamec ecological reserve (northern portion);
- the proposed Ruisseau-Clinchamp ecological reserve;
- the proposed Paul-Provencher ecological reserve;

CONSIDERING that it is necessary to extend the setting aside of the land for a term of 4 years to complete the steps that may lead to the assignment of permanent protection status of the land;

CONSIDERING section 28 of the Natural Heritage Conservation Act which provides that the renewals or extensions of the setting aside of land may not, unless so authorized by the Government, be such that the term of the setting aside exceeds 6 years;

CONSIDERING Order in Council 1090-2008 dated 5 November 2008 by which the Government authorized the Minister of Sustainable Development, Environment and Parks to extend the setting aside of the land for a term of 4 years beginning on 19 December 2008;

ORDERS AS FOLLOWS:

The setting aside of the following land is hereby extended for a term of 4 years beginning on 19 December 2008:

- the proposed Grande-Rivière ecological reserve;
- the proposed Matamec ecological reserve (northern portion);
- the proposed Ruisseau-Clinchamp ecological reserve;
- the proposed Paul-Provencher ecological reserve.

Order of the Minister of Revenue concerning source deductions tables

THE MINISTER OF REVENUE,

CONSIDERING the first paragraph of section 60 of the Act respecting parental insurance (R.S.Q., c. A-29.011) which provides that an employer is required to deduct from the wages paid to an employee in a year, in respect of an employment, the amount prescribed as the employee's premium under the parental insurance plan;

CONSIDERING the third paragraph of section 60 of the Act respecting parental insurance which provides that the Minister of Revenue shall draw up tables determining the amounts to be deducted from the wages paid to an employee in a particular period;
