An Act respecting municipal taxation (R.S.Q., c. F-2.1)

Regulation to amend the Regulation respecting the maximum non-taxable value of certain rectories

CONSIDERING paragraph 9 of section 263 of the Act respecting municipal taxation (R.S.Q., c. F-2.1) which provides that the Minister of Municipal Affairs, Regions and Land Occupancy may fix the value which, multiplied by the median proportion of the roll, constitutes the maximum non-taxable value of a rectory contemplated by section 231.1 of the Act;

CONSIDERING the making of the Regulation respecting the maximum non-taxable value of certain rectories by the Minister of Municipal Affairs by Minister's Order dated 7 June 1989 (1989, *G.O.* 2, 2367), amended by Minister's Order dated 17 October 2001 (2001, *G.O.* 2, 5827);

CONSIDERING that it is expedient to again amend the Regulation;

CONSIDERING that, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), the draft of the Regulation to amend the Regulation respecting the maximum non-taxable value of certain rectories was published in Part 2 of the *Gazette officielle du Québec* of 10 July 2009 with a notice that it could be made by the Minister of Municipal Affairs, Regions and Land Occupancy on the expiry of 45 days following that publication and that any person wishing to comment on the draft Regulation could submit written comments within the 45-day period;

CONSIDERING that no comments were received before the expiry of the 45-day period;

CONSIDERING that it is expedient to make the Regulation without amendment;

THE MINISTER OF MUNICIPAL AFFAIRS, REGIONS AND LAND OCCUPANCY ORDERS AS FOLLOWS:

The Regulation to amend the Regulation respecting the maximum non-taxable value of certain rectories, attached to this Minister's Order, is hereby made.

Regulation to amend the Regulation respecting the maximum non-taxable value of certain rectories*

An Act respecting municipal taxation (R.S.Q., c. F-2.1, s. 263, par. 9)

- **1.** The Regulation respecting the maximum non-taxable value of certain rectories is amended in section 1 by replacing "\$200,000" by "\$340,500".
- **2.** This Regulation comes into force for the purpose of a municipal fiscal year as of the 2010 municipal fiscal year.
