Order number AM 2010-032 of the Minister of Natural Resources and Wildlife and the Minister for Natural Resources and Wildlife dated 4 August 2010

An Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1)

CONCERNING the Regulation to amend the Regulation respecting outfitters

THE MINISTER OF NATURAL RESOURCES AND WILD-LIFE AND THE MINISTER FOR NATURAL RESOURCES AND WILDLIFE.

CONSIDERING the passing of the Act to amend the Act respecting tourist accommodation establishments and other legislative provisions (2009, c. 22), which provides, in particular, for the repeal of sections 78.3 and 78.4 of the Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1) and the subjection of outfitting operations to the Act respecting tourist accommodation establishments (R.S.Q., c. E-14.2);

CONSIDERING section 163 of the Act respecting the conservation and development of wildlife, which provides that the Minister may make regulations on the matters set forth therein;

CONSIDERING section 164 of that Act, which provides that a regulation made under subparagraphs 1 to 3 of the first paragraph of section 163 of that Act is not subject to the publication requirements set out in section 8 of the Regulations Act (R.S.Q., c. R-18.1);

CONSIDERING the making of the Regulation respecting outfitters (R.R.Q., c. C-61.1, r. 24), which provides, in particular, conditions for issue and replacement applicable to holders of an outfitter's licence and the obligations with which the holder of such a licence must comply;

CONSIDERING that it is expedient to amend certain provisions of the Regulation;

ORDER AS FOLLOWS:

The Regulation to amend the Regulation respecting outfitters, attached hereto, is hereby made.

## Regulation to amend the Regulation respecting outfitters

An Act respecting the conservation and development of wildlife (R.S.Q., c. C-61.1, s. 163, 1st par., subpars. 1 and 3)

- **1.** The Regulation respecting outfitters (R.R.Q., c. C-61.1, r. 24) is amended by replacing section 1 by the following:
- "1. In this Regulation, "lodging unit" means a lodging unit in a tourist accommodation establishment within the meaning of section 1 of the Regulation respecting tourist accommodation establishments (O.C. 1111-2001, 2001, G.O. 2, 5568)."
- **2.** Section 3 is amended by striking out subparagraph e of the first paragraph and the second and third paragraphs.
- **3.** Section 4.1 is amended by striking out ", except the conditions provided for in subparagraphs d and e of the first paragraph" in paragraph b.
- **4.** This Regulation comes into force on the date of coming into force of section 17 of the Act to amend the Act respecting tourist accommodation establishments and other legislative provisions (2009, c. 22).
