#### Licences

##### — Amendment

Regulation to amend the Regulation respecting licences

WHEREAS, under the third paragraph of section 66.1 of the Highway Safety Code (R.S.Q., c. C-24.2), enacted by section 11 of chapter 40 of the Statutes of 2007 and amended by section 2 of chapter 55 of the Statutes of 2009, the Government may, by regulation, set the maximum and minimum amounts chargeable for a course to drive a passenger vehicle;

WHEREAS the Government made the Regulation respecting licences by Order in Council 1421-91 dated 16 October 1991;

WHEREAS, under section 5 of the Act to amend the Highway Safety Code as regards driving schools (2009, c. 55), the first regulation made under the third paragraph of section 66.1 of the Code is not subject to the publication requirement or the requirement as regards its date of coming into force set out in sections 8 and 17 of the Regulations Act (R.S.Q., c. R-18.1) and it comes into force on the date of its publication in the *Gazette officielle du Québec*;

WHEREAS it is expedient to make the Regulation to amend the Regulation respecting licences;

IT IS ORDERED, therefore, on the recommendation of the Minister of Transport:

THAT the Regulation to amend the Regulation respecting licences, attached to this Order in Council, be made.

### Regulation to amend the Regulation respecting licences\*

Highway Safety Code  
(R.S.Q., c. C-24.2, s. 66.1, 3rd par; 2007, c. 40, s. 11; 2009, c. 55, s. 2)

**1.** The Regulation respecting licences is amended by inserting the following Chapter after section 7.12:

#### “CHAPTER II.1 AMOUNT CHARGEABLE TO TAKE A DRIVING COURSE

**7.13.** The maximum amount chargeable to take, in a driving school recognized by a body certified by the Société, the appropriate driving course for a road vehicle covered by a class 5 driver’s licence is \$825.00.”.

**2.** This Regulation comes into force on the date of its publication in the *Gazette officielle du Québec*.
