An Act respecting racing  
(R.S.Q., c. C-72.1)

**Rules respecting certification****— Amendment**

Notice is hereby given that the Régie des alcools, des courses et des jeux, at its plenary session of 18 April 2012, made the Rules to amend the Rules respecting certification appearing below.

A draft of those Rules was published in Part 2 of the *Gazette officielle du Québec* of 4 January 2012, in accordance with sections 10 and 11 of the Regulations Act (R.S.Q., c. R-18.1), with a notice that they could be made by the Régie des alcools, des courses et des jeux on the expiry of 45 days following that publication.

**Rules to amend the Rules respecting certification**

An Act respecting racing  
(R.S.Q., c. C-72.1, s. 103, 1st par., subpars. 10, 11 and 22)

**1.** The Rules respecting certification (c. C-72.1, r. 1) are amended by replacing section 6 by the following:

**“6.** The holder of a licence issued outside Québec by a race commission in Canada or another organization established to control and supervise horse racing in Canada, may obtain from the board a licence of the same class except in the cases provided for in section 77 of the Act respecting racing (R.S.Q., c . C-72.1) or if the licence holder's rights have been suspended by the commission or organization.

The licence holders are not required to undergo an examination, interview or test or to have acquired the schooling, experience, competence or qualification required under these Rules.”

**2.** Section 40 is amended by replacing “Québec” by “Canada”.

**3.** These Rules come into force on the fifteenth day following the date of their publication in the *Gazette officielle du Québec*.
