Highway Safety Code (chapter C-24.2)

Approval of the cameras used to photograph the registration plate of road vehicles driven on bridge P-10942 on autoroute 30

THE MINISTER OF TRANSPORT,

CONSIDERING the first paragraph of section 595.1 of the Highway Safety Code (chapter C-24.2), which provides that the cameras used to photograph the registration plates of road vehicles driven on a public road referred to in section 417.2 of the Code must be approved by the Minister of Transport and must allow the place, date and time the photograph was taken to be determined;

CONSIDERING Order 2012-10 of the Minister of Transport dated November 30, 2012 concerning the designation of toll road infrastructures operated under a public-private partnership agreement, which designates bridge P-10942 on autoroute 30 crossing the St. Lawrence river as a toll road infrastructure:

CONSIDERING that it is expedient to approve the cameras:

ORDERS AS FOLLOWS:

- 1. The cameras used to photograph road vehicles driven on bridge P-10942 on autoroute 30, their registration plates and their environment, and whose main components are the following, are approved:
- (1) cameras for photographing the rear and, where applicable, the front registration plate of road vehicles (FXCAMd 102c by ARH inc.);
- (2) cameras for photographing a vehicle and its environment (Series NH063 by Sony Electronics inc.);

- (3) road vehicle detection and camera activation systems including:
 - (a) a lateral laser scanner (LMS511 by SICK AG);
- (b) a fiber optic counting bar (EZ-TreadleTM by Sensor Line GmbH);
- (c) a magnetic/resistive sensor (Lendher FVD-L by Contaval S.L.).
 - 2. This Order comes into force on 14 December 2012.

An Act respecting transport infrastructure partnerships (chapter P-9.001)

Code of Penal Procedure (Chapter C-25.1)

Designation of persons entrusted with the enforcement of the Act respecting transport infrastructure partnerships for the purposes of drawing up offence reports referred to in article 62 of the Code of Penal Procedure

THE MINISTER OF TRANSPORT,

CONSIDERING the first paragraph of section 20 of the Act respecting transport infrastructure partnerships (chapter P-9.001) which provides that the Minister may designate from among the partner's employees who meet the conditions determined by government regulation a person to be entrusted with the enforcement of the Act for the purposes of drawing up offence reports referred to in article 62 of the Code of Penal Procedure (chapter C-25.1); CONSIDERING that the Minister of Transport entered with Nouvelle Autoroute 30, S.E.N.C., Acciona Nouvelle Autoroute 30 Inc. and Iridium Nouvelle Autoroute 30 Inc. into an agreement dated 25 September 2008 entitled "Entente de partenariat visant la conception, la construction, le financement, l'exploitation, l'entretien et la réhabilitation du parachèvement en mode de partenariat public-privé de l'autoroute 30 dans la région de Montréal";

CONSIDERING section 35 of the Regulation respecting toll road infrastructures operated under a public-private partnership agreement (chapter P-9.001, r. 3), which determines the conditions that an employee of the partner must meet at the time he or she is designated;

CONSIDERING Order number 2012-10 of the Minister of Transport dated November 30, 2012 respecting the Designation of toll road infrastructures operated under a public-private partnership agreement;

CONSIDERING that Stéphanie Comtois is an employee of Nouvelle Autoroute 30, S.E.N.C. and that she meets the conditions set out in the Regulation respecting toll road infrastructures operated under a public-private partnership agreement;

CONSIDERING that it is expedient to designate that person;

ORDERS AS FOLLOWS:

1. For the purposes of drawing up offence reports referred to in article 62 of the Code of Penal Procedure (chapter C-25.1), Stéphanie Comtois, an employee of Nouvelle Autoroute 30, S.E.N.C., is hereby designated as the person entrusted with the enforcement of the Act respecting transport infrastructure partnerships (chapter P-9.001) on bridge P-10942 of autoroute 30 that crosses the St. Lawrence River.
