

Regulation to amend the Regulation respecting the Québec sales tax

An Act respecting the Québec sales tax (chapter T-0.1, s. 677, 1st par., subpar. 44.0.1)

1. The Regulation respecting the Québec sales tax (chapter T-0.1, r. 2) is amended in section 425.1R2 by replacing “a dealer’s licence issued under the Highway Safety Code (chapter C-24.2)” by “a road vehicle dealer’s permit issued under the Consumer Protection Act (chapter P-40.1)”.

2. This Regulation comes into force on 19 October 2015.

An Act respecting Access to documents held by public bodies and the Protection of personal information (chapter A-2.1)

Fees for the transcription, reproduction or transmission of documents or personal information — Amendment

Regulation to amend the Regulation respecting fees for the transcription, reproduction or transmission of documents or personal information

WHEREAS, under subparagraph 1 of the first paragraph and the second paragraph of section 155 of the Act respecting Access to documents held by public bodies and the Protection of personal information (chapter A-2.1), the Government may make regulations prescribing fees for the transcription, reproduction or transmission of documents or personal information, and the terms and conditions of payment of the fees and, in exercising the power to make regulations, may establish categories of persons, public bodies, information, documents and files;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (chapter R-18.1), a draft Regulation to amend various regulations due to the coming into force of the provisions of the Act to transfer the responsibility for issuing road vehicle dealer’s and recycler’s licences to the president of the Office de la protection du consommateur, including the Regulation respecting fees for the transcription, reproduction or transmission of documents or personal information, was published in Part 2 of the *Gazette officielle du Québec* of 3 June 2015 with a notice that it could be made by the Government on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation without amendments;

IT IS ORDERED, therefore, on the recommendation of the Minister of Justice:

THAT the Regulation to amend the Regulation respecting fees for the transcription, reproduction or transmission of documents or personal information, attached to this Order in Council, be made.

An Act respecting Access to documents held by public bodies and the Protection of personal information (chapter A-2.1, s. 155, 1st par., subpar. 1, and 2nd par.)

1. The Regulation respecting fees for the transcription, reproduction or transmission of documents or personal information (chapter A-2.1, r. 3) is amended in section 7 by striking out “et licences” in the French text.

Highway Safety Code (chapter C-24.2)

Road vehicle registration — Amendment

Regulation to amend the Regulation respecting road vehicle registration

WHEREAS, under paragraph 2 of section 618 of the Highway Safety Code (chapter C-24.2), the Government may by regulation determine in which cases and subject to what conditions the Société d’assurance automobile du Québec may issue one or more of the following documents: a registration certificate, registration plate, validation sticker, temporary registration certificate or detachable registration plate;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (chapter R-18.1), a draft Regulation to amend various regulations due to the coming into force of the provisions of the Act to transfer the responsibility for issuing road vehicle dealer's and recycler's licences to the president of the Office de la protection du consommateur, including the Regulation to amend the Regulation respecting road vehicle registration, was published in Part 2 of the *Gazette officielle du Québec* of 3 June 2015 with a notice that it could be made by the Government on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation to amend the Regulation respecting road vehicle registration without amendments;

IT IS ORDERED, therefore, on the recommendation of the Minister of Transport:

THAT the Regulation to amend the Regulation respecting road vehicle registration, attached to this Order in Council, be made.

Regulation to amend the Regulation respecting road vehicle registration

Highway Safety Code
(chapter C-24.2, s. 618, par. 2)

- 1.** The Regulation respecting road vehicle registration (chapter C-24.2, r. 29) is amended in section 36 by replacing “a duly licensed dealer” in the first paragraph by “a road vehicle dealer holding a permit issued under the Consumer Protection Act (chapter P-40.1)”.
- 2.** Section 37 is amended by replacing “a duly licenced dealer” in the first paragraph by “a road vehicle dealer holding a permit issued under the Consumer Protection Act (chapter P-40.1)”.
- 3.** Section 44 is amended by replacing “an automotive dealer or manufacturer” in the first paragraph by “a road vehicle manufacturer or dealer holding a permit issued under the Consumer Protection Act (chapter P-40.1)”.
- 4.** Section 45 is amended by replacing “a dealer” in the first paragraph by “a road vehicle dealer holding a permit issued under the Consumer Protection Act (chapter P-40.1)”.

5. Section 150 is amended by inserting “issued under the Consumer Protection Act (chapter P-40.1)” after “road vehicle dealer’s licence”.

6. This Regulation comes into force on 19 October 2015.

Road vehicle recyclers

Regulation respecting road vehicle recyclers

WHEREAS, under paragraphs 4.1 and 4.2 of section 620 of the Highway Safety Code (chapter C-24.2), the Government may, by regulation, establish the form and retention rules applicable to the register to be kept by a recycler under Title III of the Code and determine the major components of a vehicle that must be described in the register for the purposes of section 155 of the Code;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (chapter R-18.1), a draft Regulation to amend various regulations due to the coming into force of the provisions of the Act to transfer the responsibility for issuing road vehicle dealer's and recycler's licences to the president of the Office de la protection du consommateur, including the Regulation respecting road vehicle recyclers, was published in Part 2 of the *Gazette officielle du Québec* of 3 June 2015 with a notice that it could be made on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation respecting road vehicle recyclers with amendments;

IT IS ORDERED, therefore, on the recommendation of the Minister of Transport:

THAT the Regulation respecting road vehicle recyclers, attached to this Order in Council, be made.
