## Right of first refusal to establish and operate outfitting facilities in Category III lands

-Renewal

Regulation to renew the right of first refusal to establish and operate outfitting facilities in Category III lands

WHEREAS section 48 of the Act respecting hunting and fishing rights in the James Bay and New Québec territories (chapter D-13.1) provides that the Native people have until 10 November 2015 a right of first refusal to establish and operate outfitting facilities in Category III lands;

WHEREAS subparagraph *e* of the first paragraph of section 94 of the Act provides that the Government may make a regulation pursuant to negotiations with the Cree Nation Government, Makivik Corporation and the Naskapi Landholding Corporation renewing, on its expiration, the right of first refusal contemplated in section 48 of the Act;

WHEREAS, following the negotiations provided for in subparagraph *e* of the first paragraph of section 94 of the Act, it was agreed to renew the right of first refusal to establish and operate outfitting facilities in Category III lands for a period of 6 years as of 10 November 2015;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (chapitre R-18.1), a draft Regulation to renew the right of first refusal to establish and operate outfitting facilities in Category III lands was published in Part 2 of the *Gazette officielle du Québec* of 4 November 2015, with a notice that it could be made by the Government on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation;

IT IS ORDERED, therefore, on the recommendation of the Minister of Forests, Wildlife and Parks: THAT the Regulation to renew the right of first refusal to establish and operate outfitting facilities in Category III lands, attached to this Order in Council, be made.

### Safety standards for road vehicles —Amendment

Regulation to amend the Regulation respecting safety standards for road vehicles

WHEREAS, under subparagraphs 6, 25, 28 to 30, 32.7, 37 to 40.1 and 42 of the first paragraph of section 621 of the Highway Safety Code (chapter C-24.2), the Government may by regulation, in particular prescribe safety standards that must be met by a road vehicle to be authorized to be operated and prescribe standards related to the circle check of a heavy vehicles prescribed in section 519.2 of the Code and exempt certain drivers, owners and operators in the cases it indicates;
