# Order number AM 2016-003 of the Minister of Forests, Wildlife and Parks dated 13 June 2016

An Act respecting the conservation and development of wildlife (chapter C-61.1)

Regulation to amend the Regulation respecting hunting

THE MINISTER OF FORESTS, WILDLIFE AND PARKS,

CONSIDERING the second paragraph of section 56 of the Act respecting the conservation and development of wildlife (chapter C-61.1), which provides that the Minister may, by regulation, allow the hunting and trapping of any animal or any animal of a class of animals determined by the Minister:

CONSIDERING subparagraphs 1 to 4 of the third paragraph of section 56 of the Act, which provides that the regulations may also determine, on the basis of sex or age, what animal or animal of a class of animals may be hunted, the period of the year, day or night during which the animal may be hunted or trapped, the area, territory or place in which the animal may be hunted or trapped, and the types of arms or traps which may be used;

CONSIDERING subparagraphs 1 and 2 of the fourth paragraph of section 56 of the Act, which provides that the Minister may also, by regulation, determine the means and their specifications, and the animals, including domestic animals and dogs, with which hunting, trapping or capturing an animal the Minister indicates is permitted, and determine the maximum number of animals that may be killed or captured by a person or group of persons during a period and in an area, territory or place the Minister indicates:

CONSIDERING subparagraphs 1 to 3 of the first paragraph of section 163 of the Act, which provides that the Minister may make regulations determining classes of licences, certificates, authorizations and leases, as well as their content and duration and the conditions for their issue, replacement, renewal or transfer, limiting the number of licences or leases of each class for a zone, territory or place the Minister specifies, and establishing the requirements that a holder of a licence, certificate, authorization or lease must satisfy;

CONSIDERING the first paragraph of section 164 of the Act, which provides that a regulation made under section 56 or under subparagraphs 1 to 3 of the first paragraph of section 163 is not subject to the publication requirements set out in section 8 of the Regulations Act (chapter R-18.1);

CONSIDERING the making of the Regulation respecting hunting (chapter C-61.1, r. 12);

CONSIDERING that it is expedient to amend certain provisions of the Regulation;

ORDERS AS FOLLOWS:

The Regulation to amend the Regulation respecting hunting, attached hereto, is hereby made.

# Regulation to amend the Regulation respecting hunting

An Act respecting the conservation and development of wildlife (chapter C-61.1, s. 56, s. 163, 1st par., subpars. 1 to 3)

- **1.** The Regulation respecting hunting (chapter C-61.1, r. 12) is amended by replacing the heading of Division I by "Preliminary".
- **2.** Section 2 is amended:
  - (1) by striking out paragraph 0.1;
  - (2) by inserting the following after paragraph 1:
- "(1.01) "moose" means a male or female moose or a moose calf;
- (1.02) "moose with antlers" means moose with antlers not less than 10 cm;".

- **3.** Section 7.2 is replaced by the following:
- "7.2. In addition to the conditions set out in the first paragraph of section 7.1, to obtain a wild turkey hunting licence, a resident must hold an attestation of completion of a course on wild turkey hunting, unless that resident is a resident referred to in section 7.3.".
- **4.** Section 13.3 is amended by adding the following at the end:

"The holder of a licence must show it to any wildlife protection officer or wildlife protection assistant who requests it.

The holder of a licence who declares having forgotten the attestation must, within 7 days of the declaration, produce it to a wildlife protection officer.".

- **5.** Section 13.6 is amended by replacing "one" in subparagraph 1 of the first paragraph by "two".
- **6.** Section 13.7 is amended by replacing "one" in subparagraph 1 of the first paragraph by "two".
- **7.** Section 14 is amended by replacing "CXXXVII and CXLV" in the fourth paragraph by "CXLV and CCXIII".
- **8.** Section 15 is amended by replacing the second, third and fourth paragraphs by the following:

"During a hunting expedition in any of the wildlife sanctuaries listed in Schedule VI, the bag limit for moose is the following:

- (1) 1 moose per single group;
- (2) 2 moose per double group.

A single group may consist of 2, 3 or 4 hunters. A group of 4 hunters may include a fifth hunter if the hunter is a person referred to in section 7.1 or 7.2 of the Regulation respecting hunting activities (chapter C-61.1, r. 1).

A double group may consist of 4, 5, 6, 7 or 8 hunters. A group of 7 or 8 hunters may include up to 2 additional hunters if the hunters are persons referred to in section 7.1 or 7.2 of the Regulation respecting hunting activities (chapter C-61.1, r. 1).

Every hunter in a group must take part in the same hunting expedition and hold the access right provided for in section 5 of the Regulation respecting wildlife sanctuaries (chapter C-61.1, r. 53).".

- **9.** Section 17 is amended:
  - (1) in the first paragraph:
  - (a) by replacing subparagraphs 1 to 7 by the following:
- "(1) in areas 3 and 7, the western part of Area 11 shown on the plan in Schedule XV, 13, 14, 16, 18, 22 except the Weh-Sees Indohoun sector shown on the plan in Schedule CXCVI, 26, 27 except the eastern part shown on the plan in Schedule XI and the part shown on the plan in Schedule XI and the part shown on the plan in Schedule CCXII, and 28, the hunting of moose with antlers and moose calves is permitted in 2016 and 2018; in Area 13, the hunting of female moose more than 1 year old is also permitted with a type 11 implement in the same years; in Area 16, the hunting of female moose more than 1 year old with a type 6 implement is also permitted in the same years;
- (2) in areas 3 and 7, the western part of Area 11 shown on the plan in Schedule XV, 13, 14, 16, 18, 22 except the Weh-Sees Indohoun sector shown on the plan in Schedule CXCVI, 26, 27 except the eastern part shown on the plan in Schedule XI and the part shown on the plan in Schedule CCXII, and 28, the hunting of moose is permitted in 2017 and 2019;
- (3) in the western and northern parts of Area 15 shown on the plans in Schedules CXXXIII and CCII, the hunting of moose with antlers and moose calves is permitted from 2016 to 2018;
- (4) in the western and northern parts of Area 15 shown on the plans in Schedules CXXXIII and CCII, the hunting of moose is permitted in 2019;
- (5) in areas 9, 10, the eastern part of Area 11 shown on the plan in Schedule XIV, 12, 15 except the western and northern parts shown on the plans in Schedules CXXXIII and CCII, and 17, only the hunting of moose with antlers is permitted from 2016 to 2019;
- (6) in areas 5, 8, 19 southern part, 20, the part of Area 27 shown on the plan in Schedule CCXII, and 29, the hunting of moose is permitted from 2016 to 2019;
- (7) in areas 1, 4 and 6 and the Weh-Sees Indohoun sector of Area 22 shown on the plan in Schedule CXCVI, the hunting of moose with antlers and moose calves is permitted from 2016 to 2019;";
  - (b) by striking out subparagraphs 8 and 9;
  - (c) by inserting the following after subparagraph 9:

- "(10) in Area 2 and the eastern part of Area 27 shown on the plan in Schedule XI, the hunting of moose with antlers and moose calves is permitted in 2018;
- (11) in Area 2 and the eastern part of Area 27 shown on the plan in Schedule XI, the hunting of moose is permitted in 2016, 2017 and 2019.";
  - (2) in the second paragraph:
  - (a) in subparagraph 1:
- i. by striking out "Bas-Saint-Laurent, Chapais,", "Lac-aux-Sables," and "Owen, Des Martres,";
  - ii. by inserting "Chauvin," after "Chapeau-de-Paille,";
- (b) by replacing "with antlers not less than 10 cm" in subparagraphs 3 and 7 by "with antlers";
- (c) by striking out "with antlers not less than 10 cm, female moose more than 1 year old and moose calves" in subparagraphs 4 and 6;
  - (d) in subparagraph 5:
- i. by replacing "moose with antlers not less than 10 cm and moose calves" by "moose with antlers and moose calves";
- ii. by replacing "moose with antlers not less than 10 cm, female moose more than 1 year old and moose calves" by "moose";
  - (e) by striking out subparagraph 9.
- **10.** Section 23 is amended by replacing "his or her caribou hunting licence." by "the licences obtained in the same year. In Area 23, a hunter may only kill 1 caribou with antlers more than 40 cm.".
- **11.** Section 25 is amended by striking out "Mazana," in subparagraph 2 of the first paragraph.
- **12.** Section 27.1 is amended by inserting "7," after "6,".
- **13.** Section 31 is amended by striking out the words "with a bowstring extension of at least 25 cm" everywhere they appear.

- **14.** Section 34 is amended by inserting "or a GPS emitter worn by such a dog" after "(chapter C-61.1, r. 1)".
- **15.** Schedule 1 is amended:



LAND IN THE DOMAIN OF THE STATE DESIGNATED FOR INCREASED UTILIZATION OF WILDLIFE RESOURCES



# Order number V-1.1-2016-11 of the Minister of Finance dated 9 June 2016

Securities Act (chapter V-1.1)

CONCERNING the Regulation to amend Regulation 23-101 respecting trading rules

WHEREAS subparagraphs 1, 3.1, 4.1, 9.1, 32, 32.0.1 and 34 of section 331.1 of the Securities Act (chapter V-1.1) stipulate that the *Autorité des marchés financiers* may make regulations concerning the matters referred to in those paragraphs;

WHEREAS the third and fourth paragraphs of section 331.2 of the said Act stipulate that a draft regulation shall be published in the Bulletin of the Authority, accompanied with the notice required under section 10 of the Regulations Act (chapter R-18.1) and may not be submitted for approval or be made before 30 days have elapsed since its publication;

WHEREAS the first and fifth paragraphs of the said section stipulate that every regulation made under section 331.1 must be approved, with or without amendment, by the Minister of Finance and comes into force on the date of its publication in the *Gazette officielle du Québec* or any later date specified in the regulation;

WHEREAS the Regulation 23-101 respecting trading rules was made by decision no. 2001-C-0411 dated August 28, 2001 (*Bulletin hebdomadaire*, vol. 32, no 35, dated August 31, 2001);

WHEREAS there is cause to amend this regulation;

WHEREAS the draft Regulation to amend Regulation 23-101 respecting trading rules was published in the *Bulletin de l'Autorité des marchés financiers*, vol. 11, no. 19 of May 15, 2014;

WHEREAS the Authority made, on May 18, 2016, by the decision no. 2016-PDG-0070, Regulation to amend Regulation 23-101 respecting trading rules;

WHEREAS there is cause to approve this regulation without amendment:

CONSEQUENTLY, the Minister of Finance approves without amendment Regulation to amend Regulation 23-101 respecting trading rules appended hereto.
