Tax Administration Act (chapter A-6.002)

Order of the Minister of Finance dated 17 November 2016

CONCERNING the Regulation respecting the signing of certain deeds, documents or writings for the purposes of the agreement with respect to the administration by Canada of Title I of the Act respecting the Québec sales tax (chapter T-0.1) in respect of selected listed financial institutions

THE MINISTER OF FINANCE,

CONSIDERING subparagraph b of the second paragraph of section 9.0.1.1 of the Tax Administration Act (chapter A-6.002), which provides that, for the purposes of an agreement entrusting to the Government of Canada the administration and application of any fiscal law or any regulation made under such a law with regard to the selected listed financial institutions, a deed, document or writing binds the Minister or the Agence du revenu du Québec, or may be attributed to them, only if it is signed by the Minister of National Revenue, the Commissioner of Revenue, appointed under section 25 of the Canada Revenue Agency Act (Statutes of Canada, 1999, chapter 17), or any employee of the Canada Revenue Agency, but in the latter case, only to the extent determined by a regulation of the Minister;

CONSIDERING the third paragraph of section 9.0.1.1 of the Tax Administration Act, which provides that the second, third and fourth paragraphs of section 40 of the Act respecting the Agence du revenu du Québec (chapter A-7.003) apply to the regulation of the Minister made under subparagraph b of the second paragraph of that section 9.0.1.1, with the necessary modifications;

CONSIDERING the second paragraph of section 40 of the Act respecting the Agence du revenu du Québec, which provides that the regulation of the Minister may allow that a facsimile of the signature of a person authorized by such a regulation of the Minister be affixed on the documents determined by the Minister and that such a facsimile has the same force as the signature itself; CONSIDERING the third paragraph of section 40 of the Act respecting the Agence du revenu du Québec, which provides that such a regulation comes into force on the date it is made or on any later date specified in the regulation and is published in the *Gazette officielle du Québec*;

CONSIDERING the fourth paragraph of section 40 of the Act respecting the Agence du revenu du Québec, which provides that the regulation may apply to a period prior to its publication;

CONSIDERING that it is expedient to make the Regulation respecting the signing of certain deeds, documents or writings for the purposes of the agreement with respect to the administration by Canada of Title I of the Act respecting the Québec sales tax (chapter T-0.1) in respect of selected listed financial institutions in order to allow the delegation of signature for the administration of Title I of the Act respecting the Québec sales tax in respect of listed financial institutions;

CONSIDERING that, under paragraph 1 of section 3 of the Regulations Act (chapter R-18.1), that Act does not apply to this Regulation;

ORDERS AS FOLLOWS:

The Regulation respecting the signing of certain deeds, documents or writings for the purposes of the agreement with respect to the administration by Canada of Title I of the Act respecting the Québec sales tax (chapter T-0.1) in respect of selected listed financial institutions, attached hereto, is hereby made.

Tax Administration Act (chapter A-6.002, s. 9.0.1.1)

CHAPTER I INTERPRETATION

I. In this Regulation, unless the context indicates otherwise, the term "document" designates any deed, document or writing.

CHAPTER II DELEGATION OF SIGNATURE

2. Employees who hold, within the Canada Revenue Agency, a position of Assistant Commissioner, or any person authorized to perform the functions of such a position, are authorized to sign, in place of the Minister of Revenue but within the limits of their duties, all the documents that the Minister of Revenue is authorized to sign.

3. Employees who hold, within the Canada Revenue Agency, a position listed in one of Schedules A to M, or any person authorized to perform the functions of such a position, are authorized to sign, in place of the Minister of Revenue but within the limits of their duties within the administrative unit under their responsibility or to which they are attached, all the documents that the Minister of Revenue is authorized to sign and that are required for the purposes of the provisions referred to in respect of each position.

4. A facsimile of the signature of the Minister of National Revenue or of the Commissioner of Revenue, appointed in accordance with section 25 of the Canada Revenue Agency Act (Statutes of Canada, 1999, chapter 17), may be affixed to the documents required for the purposes of the third paragraph of section 38 of the Tax Administration Act (chapter A-6.002).

CHAPTER III FINAL

5. This Regulation comes into force on the date of its publication in the Gazette officielle du Québec and has effect from 1 January 2013.
