Highway Safety Code (chapter C-24.2)

Driving course —Amendment

Notice is hereby given, in accordance with sections 10 and 11 of the Regulations Act (chapter R-18.1), that the Regulation to amend the Regulation respecting licences, appearing below, may be made by the Government on the expiry of 45 days following this publication.

The draft Regulation increases from \$825 to \$832 the maximum amount chargeable to take, in a driving school, the appropriate driving course for the road vehicle covered by a class 5 driver's licence.

That maximum amount corresponds to the amount currently provided for in the Regulation increased by taking into account the adjustment rate for government fees set on 1 January 2018 at 0.82% in accordance with section 83.3 of the Financial Administration Act (chapter A-6.001).

The draft Regulation also provides for an adjustment rule for the maximum amount of \$832, as of 1 January 2019.

The draft Regulation has no negative impact on enterprises that give driving courses. As for the clientele who must take a driving course, the proposed measures have a negligible effect, since the additional costs entailed by the measures simply represent the increase in the cost of living.

Regulation to amend the Regulation respecting licences

Highway Safety Code (chapter C-24.2, s. 66.1)

- **1.** The Regulation respecting licences (chapter C-24.2, r. 34) is amended in section 7.13
 - (1) by replacing \$825" by "\$832";
 - (2) by adding the following paragraphs at the end:

"That amount is adjusted by operation of law, on 1 January of each year as of 1 January 2019, by the rate provided for in section 83.3 of the Financial Administration Act (chapter A-6.001). The rate may not be lower than zero.

The Regulation respecting the rounding off of adjusted fees (chapter A-6.001, r. 0.1) applies to the adjustment, with the necessary modifications.

The Minister publishes the result of the adjustment of the amount in the *Gazette officielle du Québec*.".

2. This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette* officielle du Québec.
