Amendment to Schedule I of the Act

Amendment to Schedule I to the Act respecting contracting by public bodies

WHEREAS, under sections 21.1, 21.2, 21.26 and 21.28 of the Act respecting contracting by public bodies (chapter C-65.1), Schedule I to the Act lists offences for the purpose of keeping the register of enterprises ineligible for public contracts and the power of the Autorité des marchés publics to refuse to grant or to renew an authorization to an enterprise or to revoke an authorization;

WHEREAS, under section 21.42 of the Act, the Government may amend Schedule I;

WHEREAS section 9 of the Cannabis Act (S.C. 2018, chapter 16) establishes criminal offences regarding the distribution of cannabis and the possession of cannabis for the purpose of distributing;

WHEREAS section 10 of that Act establishes criminal offences regarding the selling of cannabis and the possession of cannabis for the purpose of selling;

WHEREAS section 11 of that Act establishes criminal offences regarding the importing and exporting of cannabis and the possession of cannabis for the purpose of exporting;

WHEREAS section 12 of that Act establishes criminal offences regarding the production of cannabis;

WHEREAS section 14 of that Act establishes criminal offences regarding the use of a young person in the commission of certain offences;

WHEREAS it is expedient to amend Schedule I to the Act respecting contracting by public bodies;

IT IS ORDERED, therefore, on the recommendation of the Minister Responsible for Government Administration and Chair of the Conseil du trésor:

THAT the amendment to Schedule I to the Act respecting contracting by public bodies, attached to this Order in Council, be made;

THAT the amendment come into force on the 30th day following the publication of this Order in Council in the *Gazette officielle du Québec*.
