Civil Code of Québec  
(Civil Code)

Temporary closure of the Personal and Movable Real Rights Registry Office

THE MINISTER OF JUSTICE,

CONSIDERING article 3025 of the Civil Code, which provides that the minister in charge of the organization and inspection of a registry office may, by order, close the registry office temporarily where required by the circumstances;

CONSIDERING section 1 of the Act respecting registry offices (chapter B-9), which provides that the Minister of Justice is in charge of the organization and inspection of the Personal and Movable Real Rights Registry Office and has superintendence of the registrar assigned to that registry office;

CONSIDERING that it is expedient to close the Personal and Movable Real Rights Registry Office temporarily due to technical problems that occurred following work carried out on its servers;

ORDERS AS FOLLOWS:

THAT the Personal and Movable Real Rights Registry Office be closed as of 9 a.m., on this day, until its computer system is back in service.
