Highway Safety Code (chapter C-24.2)

Suspension of the prohibition from operating an off-highway vehicle referred to in the Act respecting off-highway vehicles (chapter V-1.2) which is equipped with a studded tire, other than a tire equipped with "ice screws", from 1 January to 1 May 2021

THE MINISTER OF TRANSPORT,

CONSIDERING section 633.2 of the Highway Safety Code (chapter C-24.2), which provides that, the Minister of Transport may, by order and after consultation with the Société de l'assurance automobile du Québec, suspend the application of a provision of the Code or the regulations, if the Minister considers that it is in the interest of the public and is not likely to compromise highway safety;

CONSIDERING that section 633.2 of the Code provides that the publication requirement set out in section 8 of the Regulations Act (chapter R-18.1) does not apply to an order made under section 633.2;

CONSIDERING the first paragraph of section 441 of the Highway Safety Code (chapter C-24.2), which provides that no person may drive a road vehicle on which a tire is equipped with non-skid studs or with any other device that may damage the roadway;

CONSIDERING that it is expedient to suspend the prohibition from operating an off-highway vehicle referred to in the Act respecting off-highway vehicles (chapter V-1.2) which is equipped with a studded tire, other than a tire equipped with "ice screws", from 1 January to 1 May 2021;

CONSIDERING that the Minister considers that the suspension of that prohibition is in the interest of the public and is not likely to compromise highway safety;

CONSIDERING that the Société de l'assurance automobile du Québec has been consulted on the suspension of that prohibition; ORDERS AS FOLLOWS:

1. The prohibition provided for in the first paragraph of section 441 of the Highway Safety Code (chapter C-24.2) is hereby suspended for persons who operate an off-highway vehicle referred to in the Act respecting off-highway vehicles (chapter V-1.2) which is equipped with a studded tire, other than a tire equipped with "ice screws", from 1 January to 1 May 2021.

2. This Order comes into force on 1 January 2021. It is revoked on 1 May 2021.

Highway Safety Code (chapter C-24.2)

Amendment to the Ministerial Order concerning Public highways where photo radar devices and red light camera systems may be used

THE MINISTER OF TRANSPORT, THE MINISTER OF PUBLIC SECURITY,

CONSIDERING subparagraph 3 of the first paragraph of section 634.3 of the Highway Safety Code (chapter C-24.2), which provides that the Minister of Transport and the Minister of Public Security may determine that photo radar devices and red light camera systems may be used to monitor compliance with highway safety rules on public highways after consulting with the municipality responsible for the maintenance of the highway, if applicable;

CONSIDERING the third paragraph of the said section, which provides that any order made under subparagraph 3 of the first paragraph is published in the *Gazette officielle du Québec*;
