Public Health Act (chapter S-2.2)

Ordering of measures to protect the health of the population amid the COVID-19 pandemic situation

THE MINISTER OF HEALTH AND SOCIAL SERVICES,

Considering section 118 of the Public Health Act (chapter S-2.2) which provides that the Government may declare a public health emergency in all or part of the territory of Québec where a serious threat to the health of the population, whether real or imminent, requires the immediate application of certain measures provided for in section 123 of the Act to protect the health of the population;

CONSIDERING Order in Council 177-2020 dated 13 March 2020 declaring a public health emergency throughout Québec for a period of 10 days;

CONSIDERING that Order in Council 433-2021 dated 24 March 2021 provides for, among other things, certain special measures applicable in certain territories;

CONSIDERING that that Order in Council also empowers the Minister of Health and Social Services to order any modification or clarification to the measures provided for in the Order;

Considering that Order in Council 489-2021 dated 31 March 2021 also empowers the Minister of Health and Social Services to take any of the measures provided for in subparagraphs 1 to 8 of the first paragraph of section 123 of the Public Health Act;

CONSIDERING that it is expedient to order certain measures to protect the health of the population;

ORDERS AS FOLLOWS:

THAT the operative part of Order in Council 433-2021 dated 24 March 2021 be amended,

- (1) by replacing "in which they reside" in the eighth paragraph by "of their principal residence";
 - (2) by replacing Schedules III and IV by the following:

"Schedule III – Orange zone territories

Saguenay—Lac-Saint-Jean Health Region;

Mauricie et Centre-du-Québec Health Region;

Estrie Health Region;

Abitibi-Témiscamingue Health Region.

Schedule IV – Red zone territories

Bas-Saint-Laurent Health Region;

Capitale-Nationale Health Region;

Montréal Health Region;

Outaouais Health Region;

Chaudière-Appalaches Health Region;

Laval Health Region;

Lanaudière Health Region;

Laurentides Health Region;

Montérégie Health Region.";

That, in addition to the provisions of the sixth paragraph of Order in Council 433-2021 dated 24 March 2021, and despite any provision to the contrary, the following measures apply to the territories of Ville de Gatineau, the regional county municipality of Les-Collines-de-l'Outaouais and the Communauté métropolitaine de Québec:

- (1) the measures specific to the curfew set out in subparagraphs 4, 5 and 7 of that paragraph apply, but between 8:00 p.m. and 5:00 a.m.;
- (2) the restaurants, retail sales businesses and premises in which cultural, sports, outdoor or recreational activities are permitted if the activities have not been suspended by an Order in Council or a Ministerial Order made under section 123 of the Public Health Act (chapter S-2.2) may not admit the public between 7:30 p.m. and 5:00 a.m., except in the case of a pharmacy or a service station;
- (3) all activity in a retail sales business is suspended, except as regards the following businesses:
 - (a) grocery and other food stores;
 - (b) pharmacies;
 - (c) hardware stores;
 - (d) service stations;
 - (e) food and pet products supply businesses;
- (f) businesses dealing in products for agricultural operations;
- (g) businesses dealing in products, parts and other material necessary for transportation and logistics services and for repair or maintenance of a vehicle, including vehicle repair and servicing centres, but excluding the sale of vehicles;
 - (h) flower shops;
 - (i) convenience stores;
- (j) businesses dealing in products for agricultural operations;
- (k) businesses dealing in articles for medical, orthopedic and eye care;
- (1) businesses dealing in household and building cleaning products;

- (m) department stores and other sales outlets offering customers a wide variety of goods, including food, drugstore or hardware products; and
- (n) the Société des alcools du Québec and the Société québécoise du cannabis;
- (4) all activity in businesses dealing in personal and beauty care and in pet grooming is suspended;
- (5) in a pharmacy, only products essential to day-to-day life may be sold to customers;
- (6) in a hardware store, only products required for outdoor maintenance, repair or construction may be sold to customers;
- (7) in a department store or other sales outlet referred to in subparagraph m of subparagraph 3,
- (a) only products usually sold in any of the businesses referred to in any of subparagraphs a to h of subparagraph 3 may be accessible or sold to customers, which excludes, in particular, toys, clothing, books, electronic devices, decorative items, kitchen articles and home appliances; and
- (b) subparagraphs 5 and 6 apply to drugstore and hardware products offered to customers;
- (8) customers in a shopping centre may travel through the common areas of the shopping centre only to directly access a business referred to in any of subparagraphs a to n of subparagraph 3 or other premises in which the activities have not been suspended;
- (9) the suspension of the activities described in subparagraph 3 does not prevent a retail sales business from selling, online or by any other form of remote business, products usually available in its establishment, or curbside pick-up of remote purchases, the items purchased having to be given to the purchaser outside the establishment;
- (10) the suspension of the activities described in subparagraph 3 also does not prevent, in a retail sales business, the continuation of services to repair computer and electronic equipment or the repair and rental of sports and outdoor equipment or tool rentals;
- (11) the activities carried on in the following places are suspended:
- (a) museums, biodomes, planetariums, insectariums, botanical gardens, aquariums and zoos, except for activities that take place outdoors and require participants be moving, such as sports activities or activities on walking trails;

- (b) saunas and spas;
- (c) libraries, other than those managed by educational institutions, except loan desks and individual work rooms and spaces for;
- (d) movie theatres and rooms in which performing arts are presented, including venues where the arts are broadcast; and
 - (e) physical training rooms;
- (12) the public may not attend an indoor rehearsal, production or audio-visual filming or indoor recording of a performance;
- (13) in a building housing a place of worship, a maximum of 25 persons for the entire building may be in attendance;
- (14) for the days in the 2020-2021 school calendar year devoted to educational services, school service centres, school boards and private educational institutions,
- (a) provide distance educational services to preschool children and students at the elementary level in general education for youth according to the minimum service provision set out in the Schedule;
- (b) provide distance educational services to students at the secondary level in general education for youth according to the normal timetable; and
- (c) provide distance educational services to students in adult general education and vocational training;
- (15) the preceding subparagraph does not apply to handicapped students or students with social maladjustments or learning disabilities attending a specialized school or class that is part of regional or supraregional schooling services;
- (16) for handicapped students or students with social maladjustments or learning disabilities attending specialized classes or groups that are not in a school or a class referred to in the preceding subparagraph, the educational institutions may provide classroom educational services, but must favour the distance educational services referred to in subparagraph 14;
- (17) for the days in the 2020-2021 school calendar year, childcare services provided at school suspend their activities, except for childcare services provided to handicapped students or students with social maladjustments or learning disabilities in specialized schools or classes that are part of regional or supraregional schooling services;

- (18) despite the preceding subparagraph, childcare services are organized by the school service centres and school boards and are provided to children in preschool education and students at the elementary level having one parent who
- (a) holds employment or practises a profession in the health and social services network, including in a private professional practice, a community pharmacy and a prehospital emergency service;
- (b) is in charge of or is employed by an intermediate resource, a family-type resource, a social economy enterprise providing home assistance, a private seniors' residence, a childcare centre, a day care centre or a home childcare service;
- (c) provides services within the framework of the direct allowance home care mechanism service employment paycheque;
- (d) is a police officer, a firefighter, a correctional services officer or a special constable;
- (e) is employed by a 9-1-1 emergency centre or a dispatch centre for a fire safety service or a police force;
- (f) is employed by any of the following organizations and has been identified by the highest authority in the organization as a provider of services held to be essential in the context of the COVID-19 pandemic:
 - i. the Red Cross;
 - ii. Héma-Québec;
 - iii. Transplant Québec;
 - iv. the Régie de l'assurance maladie du Québec;
 - v. the Institut national de santé publique du Québec;
- vi. a drug wholesaler accredited by the Minister of Health and Social Services;
 - vii. a suicide prevention centre;
 - viii. the government air service;
- ix. a waste collection or treatment service or a water treatment service; or
- x. the Commission des normes, de l'équité, de la santé et de la sécurité du travail;

- (g) is an inspector, a veterinarian, an analyst or other agent appointed for the carrying into effect of the Food Products Act (chapter P-29);
 - (h) is a coroner;
- (i) is employed by the Ministère de la Sécurité publique du Québec, is assigned to civil protection and has been identified by the highest authority in that department as a provider of services held to be essential in the context of the COVID-19 pandemic;
- (j) is a member of the personnel assigned to responding to calls made by the population via the Government's COVID-19 telephone information line or is a member of the personnel assigned to overseeing the providing of that service at the Ministère du Travail, de l'Emploi et de la Solidarité sociale;
- (k) is employed by a school service centre, a school board or a private educational institution;
- (*l*) is employed by a specialized lodging resource for vulnerable persons and their close relatives (spousal abuse, addiction, homelessness, mental health);
- (m) is a worker performing duties within the judicial system;
 - (n) provides home care services to elderly persons;
- (o) is a person assigned to snow removal for sidewalks and road links; or
- (p) is involved in the work of developing or manufacturing a COVID-19 vaccine or any of its components;
- (19) for childcare services to be organized pursuant to the preceding subparagraph, each group is made up of a maximum of 10 children;
- (20) all recreational or sports activities are suspended, unless they are carried out in a place where the activities are not otherwise suspended, in circumstances that do not involve a league, tournament or competition, by a group of not more than eight persons, to which another person may be added to guide or oversee the activity, provided that a minimum distance of two metres is maintained at all times between the persons, other than in the case of occupants of the same private residence, or its equivalent; and
- (21) the universities, colleges established under the General and Vocational Colleges Act (chapter C-29), private educational institutions providing college instructional services and any other institution providing

college-level or university instructional services or ongoing training services must favour distance training for their educational services, unless the acquisition or evaluation of the knowledge in the student's program of studies requires the student's presence in the classroom;

THAT the second paragraph not operate to prevent basic necessity goods and services from being supplied in an emergency or as a consequence of a fire or other loss, nor the providing of care or health or social services;

THAT this Order come into force on 1 April 2021 at 8:00 p.m.
